1.	Cllr. Brian Gordon	There has been an alarming increase in knife crime attacks in London. How does Barnet's record of such crime compare proportionately with London as a whole and is our Council doing as much as it can in liaison with the police to combat this scourge	Chairman, Community Leadership and Libraries Committee	<p>In the last 12 months (to June 2019) there have been 422 knife crime offences in Barnet, which equates to a rate of 1.02 per 1000 population. This rate is the 7th lowest out of the 32 London boroughs and is 35% lower than the London average.</p> <p>We are committed to working with the police to combat knife crime and serious violence through the Safer Communities Partnership and the Barnet Safeguarding Children Partnership, and through the REACH (Resilient, Engaged, Achieving Children) Team.</p>
2.	Cllr. Barry Rawlings	Have the administration any plans to reduce the number of questions asked by councillors at committee or full Council?	Chairman, Constitution and General Purposes Committee	No
3.	Cllr. Brian Gordon	How much is Barnet benefitting from the extra £150m + being provided by Government to local authorities to repair potholes in roads?	Chairman, Environment Committee	The Council received central government funding to repair potholes in the 18/19 financial year (£690,000) and the 17/18 financial year (£91,036).

4.	Cllr. Gill Sargeant	<p>The walkway from the bridge over the Silkstream in Montrose Park is not due to be opened until the end of November. Residents finding the walkway closed are finding other unsafe ways to cross over. Could the borough please find a safe way of opening the walkway?</p>	<p>Chairman, Assets, Regeneration and Growth Committee</p>	<p>The Councils project team are in regular communication with Fairview Ltd and are awaiting confirmation on opening dates for the bridge.</p> <p>The Councils improvement programme at Montrose/Silkstream Park involves the whole park, which is a live construction site with many health and safety considerations. The team are reviewing the feasibility of opening particular zones within the park to enable access from the Fairview site through to the Uritas Youthzone.</p> <p>However, this could not be achieved until post the summer period at the earliest whilst our construction partner, Blakedown Ltd complete associated works. We would also need to ensure that in opening up specific routes, the health and safety of visitors to the site was not compromised.</p>

5.	Cllr. Brian Gordon	Could you please provide a brief feedback on the success of his year's Passover refuse collection facility?	Chairman, Environment Committee	<p>In 2019 the Passover Waste service consisted of three elements for households in designated roads</p> <p>A) Three extra bags of side waste taken on the normal collection day</p> <p>B) An additional bag collection of up to three bags of waste on Thursday, for those whose normal collection day is Tuesday and Wednesday</p> <p>C) Five locations where a static vehicle would be placed for residents to bring waste to on Friday from 10am to 4pm.</p> <p>The service collected approximately 90 tonnes of additional waste from the 333 designated roads (potentially serving 18,442 households), and 30 tonnes from the 5 static locations on the Friday. 50% of the tonnage came from the Wednesday NW11 collection area which holds 99 of the 333 designated roads, showing the need and uptake for the service may be greatest in this area.</p> <p>The total amount collected on 120 tonnes is equivalent to 11 full refuse vehicles.</p>

Paul Edwards	The government's latest fuel poverty statistics, dated 13 June 2019, show that Barnet experienced a 25 per cent increase in the number of fuel poor households between 2016 and 2017, one of the highest percentage increases in London. Will the council develop a cold homes programmes to help low income and vulnerable households tackle fuel poverty?	Leader	Fuel poverty is clearly a concern for some residents in Barnet. We will be reviewing statistics and considering actions that the Council and other agencies can take to help our residents over the coming months.

7.	Cllr. Brian Gordon	Is there a concern, or even evidence, that the new Tenancy laws are making it more difficult for private landlords to gain possession of their properties could result in less rented accommodation being available in Barnet?	Chairman, Housing Committee	<p>In April 2019, the Government announced its intention to end a landlord's ability to end the right of Landlords to evict tenants at short notice with no good reason.</p> <p>Under the proposals, landlords will have to provide a concrete, evidenced reason already specified in law for bringing tenancies to an end a marked step-change from the current rules which allows landlords to evict tenants at any time after the fixed-term contract has come to an end, and without specifying a reason.</p> <p>To ensure responsible landlords have confidence they will be able to end tenancies where they have legitimate reason to do so, the government will amend the Section 8 eviction process, so property owners are able to regain their home should they wish to sell it or move into it. Court processes will also be expedited so landlords are able to swiftly and smoothly regain their property in the rare event of tenants falling into rent arrears or damaging the property – meaning landlords have the security of knowing disputes will be resolved quickly.</p> <p>There is currently no date set for the new legislation needs to change the law, which will follow a consultation period and the passage of a Bill through Parliament. It is not possible at this stage to say whether the intended legislation will lead to a reduction in rented accommodation in Barnet.</p>

8.	Cllr. Sara Conway	Why were the heritage windows at the former Church End Library site stolen? And how can this situation be avoided in future?	Chairman, Assets, Regeneration and Growth Committee	<p>Unfortunately, over the period December 2017 to June 2019, the council has been the victim of a number of crimes related to the old Church End Library, including theft, illegal occupation and vandalism.</p> <p>The police have been to the property a number of times and arrest were made in January 2018, however, this has not deterred further break-ins and criminal activity. On one of those occasions, the stained glass window in question was stolen from behind a wooden panel, and the panel re-fixed to cover up the theft.</p> <p>Vacant buildings will always be secured in the most appropriate way in order to reduce the risk of theft and/or illegal occupation. In this case, the building was physically secured repeatedly and ultimately caretakers were situated in the building once it was discovered that the thieves were using tools to get into the building and then re-securing it from the inside to make it look like there had been no forced entry.</p>
9.	Cllr. Brian Gordon	Can you briefly outline the progress on the new intended Youth Zone within Barnet?	Chairman, Children, Education and Safeguarding Committee	<p>Unitas Youth Zone opened its doors on Sunday 22 June with over 1400 local residents in attendance. Since then over 2,600 young people have signed up as members and around 250 young people attend evening sessions. Community groups have started using the facility with Barnet FC and Tully's Boxing Club provide coaching sessions on a regular basis. We are delighted with the progress made by the service and look forward to their continued, sustained success.</p>

10.	Cllr. Alan Schneiderman	In common with the rest of the world, does Barnet face a climate change emergency?	Chairman, Environment Committee	Parliament has declared a climate emergency. When it comes to climate change, that which is true for the rest of the UK is also true for Barnet.
11.	Cllr. Brian Gordon	What are your reflections on the fact that this Borough's secondary schools have been ranked second best in England?	Chairman, Children, Education & Safeguarding Committee	I am very pleased that our hard work in children's services has been validated in so many ways over the past few months. Our secondary schools are absolutely something to be proud of. All secondary schools are rated as 'Good' or 'Outstanding' by Ofsted.
12.	Cllr. Arjun Mitra	I understand that the Council allocated around £10 million to replace doors on Barnet Homes properties to bring them up to standard, has this money been spent, and how many homes benefited?	Chairman, Housing Committee	<p>There are around 5000 glass-reinforced plastic (GRP) fire doors across the Barnet Homes stock, for which a provision of £10.5m has been made for replacing the doors as part of the £51.9m fire safety improvement programme approved by the Housing Committee.</p> <p>Barnet Homes have carefully followed the advice of the Government and that of the Expert Panel it has set up to advise on such matters and subsequently have completed updated fire risk assessments of all blocks in which GRP doors are present. Each risk assessment stipulates a target timescale within which the doors should be replaced and subsequently these timescales inform the replacement programme</p>

13.	Cllr. Brian Gordon	Please can you confirm the time frame for the installation of the long-awaited part-pavement parking scheme in Broadfields Avenue and Edgwarebury Lane, Edgware.	Chairman, Environment Committee	<p>Consultation was undertaken earlier this year, Officers are reviewing the findings and will be completing a detailed report for Chief Officer approval and sign off.</p> <p>If approval is granted to proceed with the scheme(s), Officers will liaise with Councils Contractor over the summer period to agree a timeline for the implementation of the works which is likely to be completed in the Autumn 2019.</p>
14.	Cllr. Nagus Narenthira	What has the council administration done to help the residents of Colindeep Lane, Colin Gardens and Greenway who were affected by recent Flooding?	Chairman, Environment Committee	<p>As part of the regeneration of Silk Stream Park and Montrose Park, the Council has worked collaboratively with the Environment Agency and the Greater London Authority (GLA) to secure external funding to incorporate flood alleviation measures along the Silk Stream, including a wetland that will function as a flood attenuation basin.</p> <p>These upstream measures are designed to reduce the flow of the river downstream during flood events and as such should benefit the residents downstream in The Greenway, Colin Gardens, and Colindeep Lane.</p>
15.	Cllr. Gabriel Rozenberg	Please provide a list of any streets in Barnet that the council has on record as having been named after women.	Chairman, Environment Committee	We do not have a list of roads named after women.

16.	Cllr. Barry Rawlings	In his speech at the last Council meeting, the leader talked of affordable housing as helping young people 'get a foot' on the housing ladder. Does he accept that the government's definition of affordable is out of the reach of most young people in Barnet and in order for families to be close to each other and support networks it is more social housing we need rather than fantasy 'affordable' housing?	Leader	<p>The Government defines affordable housing in the National Planning Policy framework. This includes social rented homes, affordable rented property at up to 80% of market rent, or properties where the rent is at least 20% below market rents.</p> <p>In addition, affordable housing includes a number of options for low-cost homeownership, including starter homes, discounted market sale (at least 20% below market) and shared ownership.</p> <p>The council's own approach recognises the need to have a variety of affordable housing products to meet the needs of different income groups. This includes building new homes at 65% affordable rents via Opendoor Home, and new council homes at London Affordable rents via the Housing Revenue Account. In addition, affordable rents in Barnet are capped at Local Housing Allowance levels, making them eligible for Housing Benefit should the tenant be eligible for this.</p>
17.	Cllr. Gabriel Rozenberg	Please provide a list of all statues, sculptures, public art etc in Barnet that are known to commemorate historical female figures.	Chairman Assets, Regeneration and Growth Committee	<p>The only statues the council are aware of, known to commemorate historical female figures, are a sculpture of Margret Thatcher, located in the Mayor's Parlour, and one in memory of Dame Henrietta Barnett, founder of Hampstead Garden Suburb, located in Central Square, NW11. Further details can be found at https://historicengland.org.uk/listing/the-list/list-entry/1078867</p>

18.	Cllr. Gill Sargeant	Can the borough ensure that the 303 bus route is reopened round Corner Mead in Grahame Park.	Chairman, Environment Committee	Officers continue to work towards the re-opening of the route. Work has been undertaken to set back the 'stop' line at the signals and a further route test has been carried out. The council awaits Transport for London (TfL) and the bus operator to finalise their checks, so it could be worth redirecting this question to the local Assembly Member.
19.	Cllr. Gabriel Rozenberg	Please provide a list of all public toilets, whether council administered or otherwise, by ward. Please describe how the number of public toilets compares with the recent past (eg 10 years ago).	Chairman, Environment Committee	As indicated on the Barnet Open Data Portal there are currently 26 public toilets in operation which are managed by various Council departments depending on their location (Highways, Street Scene and Property Services). It does not appear that historical data is available to indicate how this can be compared with the number that existed ten years ago, however it is officers view that this would not have significantly changed over that period.

20.	Cllr. Paul Edwards	<p>The government's latest fuel poverty statistics, dated 13 June 2019, estimate that 1 in 8 households in Barnet, a total of 17,346 households in the borough, live in fuel poverty. What steps are being taken to identify residents in fuel poverty?</p>	Leader	<p>In Barnet, households living in fuel poverty are identified by housing officers, adult social care and Age UK. The council has also given information and signposting information to GP's and Ambulance workers so that they can refer people to relevant services.</p> <p>In the Health and Well Being Board (HWBB) consultation response to the Barnet Housing Strategy, a commitment was made to expand education and training for primary healthcare workers in order to increase the identification and referral of patients living in colder homes.</p> <p>An analysis completed by the GLA found that Londoners most likely to report not being able to keep their home warm in winter include those in the lowest income quintile (31 per cent), single parents (27 per cent), those living in social rented accommodation (27 per cent) and disabled Londoners (25 per cent). These are the same population subgroups at risk of food poverty, for which an extensive analysis was completed in Barnet in 2018. As a result, a combined care pathway for food and fuel poverty is being developed for consideration at an upcoming HWBB. The aim of the pathway is to assist frontline workers with identifying people in need of support, raise awareness of appropriate referral processes and ensure people can access appropriate support.</p>

21.	Cllr. Gabriel Rozenberg	Please provide an overview of the location and extent of all cycle lanes in Barnet that are physically separated from the main highway.	Chairman, Environment Committee	Cycle routes off the carriageway in Barnet are mainly routes through parks and open spaces. Notably a route through much of the Dollis Valley, routes that share the pavement alongside stretches of the major TfL roads (A1, A41 and A406) and other links where cyclists can use bridleways and restricted by-ways or where shared use of a public footpath is permitted.

22.	Cllr. Sara Conway	What steps has the Council taken to prepare for Brexit?	Leader	<p>On 20th February 2019, a report went to Policy and Resources Committee outlining our approach to Brexit preparedness. Through research and guidance from central government, the Local Government Association, London Councils and other Local Authorities; a set of themes were identified which have been used as a framework for assessing opportunities and mitigating potential risks. This has been captured through the creation of an impact log which focuses on the following themes:</p> <p>“no deal”</p> <ul style="list-style-type: none"> • Workforce • Citizens’ rights • Community cohesion • Council funding • Supply chain • IT/systems • Legislation • Economy • Emergency planning • Elections <p>Due to the uncertainty and changing picture on a national level regarding Brexit, it is difficult to assess potential impacts on Barnet with certainty. Therefore, the council is preparing for potential impacts that could occur under either a deal or no-deal scenario. The council will continue to assess the themes identified as more information becomes available nationally, and the terms of any deal become clearer. We have also engaged with our delivery partners who are responsible for delivering services on behalf of the council. These organisations identified many similar issues to the council, and</p>

Keeping abreast of national developments forms a key part of our approach and we will continue to monitor and follow any guidance provided by central government and national bodies. The council is also represented on the London Resilience Forum, Local Authorities Panel, London Councils and London Prevent Network who take a collective approach to reporting information to the Ministry of Housing, Communities and Local Government (MHCLG).
23.	Cllr. Alex Prager	Would the leader join me in welcoming the news of an English Heritage blue plaque to be unveiled in West Hendon in commemoration of the pivotal role played in the borough during Operation Fortitude?	Leader	Absolutely. So often the work that goes into setting up intelligence operations goes under-acknowledged, and I am proud that West Hendon played a role in aiding the Allied war effort in this way.
24.	Cllr. Alan Schneiderman	How many potholes are there in Barnet?	Chairman, Environment Committee	There are currently 374 identified carriageway defects logged for action.

25.	Cllr. Alex Prager	Can the Chairman of Adults & Safeguarding committee comment on how satisfied the users of our adult social care services are?	Chairman, Adults and Safeguarding Committee	<p>Barnet has a positive record on measures of satisfaction. For example, the most recently available national survey and performance data show that:</p> <ul style="list-style-type: none"> • 63.6% of people who use adult social care in Barnet are extremely or very satisfied with their care and support, compared with 60.7% for our nearest neighbours and 59.3% in London. In addition 27. 1% of people were quite satisfied • 75.8% of people feel in control of their lives, compared with 71.2% in our nearest neighbour councils and 70.1% in London. • 83.7% of Barnet people say those services made them feel safe and secure, which is equal to our nearest neighbours and better than the London average of 82.2%. • 80.9% of adults with mental health needs live independently, considerably better than our nearest neighbours (67.1%), the London average (61%) and the England average (57%). • 78% of people with learning disabilities live independently, again better than our nearest neighbours (70.9%), London (73.3%), and England 77.2%.

26.	Cllr. Arjun Mittra	What are the latest plans for Willow House, and will the council send a briefing to ward councillors on the latest information they have regarding the families affected?	Leader	<p>Tenders for the refurbishment work at Willow House were received in May 2019. Unfortunately, upon analysis, it was considered that they did not represent value for money and subsequently a decision was taken to re-tender the project. This process is now complete and the results are currently being reviewed by Barnet Homes. Provided the tenders prove to be acceptable it is expected that work will commence work in late August and be finished by early in the new year.</p> <p>A total of 13 properties were affected by the fire at Willow House, of these 2 were occupied by Barnet Homes tenants with the remainder being leasehold properties. Barnet Homes has already successfully rehoused one of the secure tenant households in a new property, whilst the second family voluntarily remains in temporary accommodation awaiting the refurbishment of Willow House to be completed. The leaseholders affected by the incidents also received advice and assistance from Barnet Homes. Currently, no leaseholders or their subtenants are living in temporary accommodation provided by Barnet Homes, having sourced their own accommodation. Leaseholders have been kept updated on developments by the insurance company Barnet Homes continue to liaise with as part of the refurbishment process.</p>

Chairman, Environment Committee	<p>Street Scene continues to work hard to deliver street cleansing services, both proactive and reactive, to relevant land across the borough. Over the last 6 months the service has:</p> <ul style="list-style-type: none"> • Emptied litter bins over 100,000 times • Cleared over 3,000 fly-tips which had been reported • Collected and disposed of 2,475 tonnes of litter and detritus from our streets • Fully weed sprayed all of the borough 21 wards <p>At Environment Committee on 4 June a raft of options were approved, setting out how an additional £500k would be used to make further improvements to the service.</p> <p>The approved options are in the process of being implemented and positive feedback, particularly on residential road cleansing, is being received.</p>
28.	Cllr. Nagus Narenthira	What measures will be taken so that the residents of Colin Gardens, Colindeep Lane and Greenway would not be put at risk of future Flooding?	Chairman, Environment Committee	See Question 14

29.	Cllr. Felix Byers	How are the plans for our Borough's new town in Brent Cross developing?	Leader	<p>The Brent Cross programme is progressing well with a number of key milestones reached in the past 12 months. Following the deferral of the Brent Cross Shopping centre development, the council agreed a revised funding agreement with central government to ensure the new town centre development could proceed ahead of the shopping centre. Following on from this agreement the council has progress works to deliver the new Thameslink rail station, to be named Brent Cross West. The Official Journal of the European Union (OJEU) procurement process for delivery of the station is well underway with the contract due to be let in October this year. Other supporting works on replacement rail sidings and waste facility are also progressing well.</p> <p>The Council's partners in the Brent Cross South development, Argent Related, have secured planning approval for the first three residential plots in the new development, and the council have secured vacant possession of a large number of industrial units that will make way for the new town centre. Demolition of these units is due to start in August, with works on the plots and associated infrastructure due to begin in early 2019.</p>

30.	Cllr. Barry Rawlings	Barnet's current housing target is 2,349 per annum. However, the Conservative Government has raised this to 4,126 a 75% increase every year. Does he consider this vast increase, supported by our 3 MPs 'a threat to the suburbs'?	Leader	<p>The Mayor's Draft London Plan sets a target of 3,134 per annum, an increase of 33% on the current housing target.</p> <p>The Government's standardised assessment raises it further and presents a significant challenge for Barnet and its emerging Local Plan.</p> <p>Ensuring that the Borough retains the qualities that make it attractive while also accommodating the future needs for new homes, jobs and infrastructure is a role for the new Barnet Local Plan, a draft of which we will publish in the Autumn.</p>

31.	Cllr. Felix Byers	What work is being done specifically to assist the poorer areas of our Borough?	Leader	<p>The Council Regeneration Programme aims to deliver investments and improvements to the poorer areas of the borough and includes estates such as Stonegrove, Grahame Park, West Hendon and Dollis Valley. The completion of the Council's first regeneration scheme at Stonegrove/Spur Road Estate is a demonstration of this. The scheme provided:</p> <ul style="list-style-type: none"> •999 new homes of which 498 were affordable homes and 344 of these were social rented •Award-winning Church and Community building providing education and recreation activities for adults and children. Including a nursery and café. This is managed by a Community Trust established for this purpose. •Local Energy Centre •£30 million of government funding to support the provision of affordable housing •High-quality public realm and improved connectivity to the surrounding area •Improvements to the Highways •Over £800k of S106 contributions to support local improvements to the open space, highways and employment and skills. <p>The other regeneration schemes are also on their way to delivering improvements to their local areas. The Council also delivers targeted support schemes such as BOOST, which is a partnership with Barnet Homes, JobCentre Plus, Barnet & Southgate College and a number of local community organisations. It helps unemployed residents from Childs Hill, Burnt Oak and the surrounding areas to find work. BOOST also provides housing support, benefits advice and training</p>

32.	Cllr. Gill Sargeant	Could the Council please find a way of ensuring some spaces are made available on the car park at Quakers course for key volunteers at projects on the Concourse.	Chairman, Environment Committee	<p>Quakers Course is now a Council managed car park that is already extremely well subscribed and is almost entirely 100% utilised.</p> <p>We are strongly in support of organisations supporting residents of the Grahame Park estate and alternative bays at the rear of Concourse properties are available.</p> <p>A charity parking permit scheme/discount is currently under consideration to support the voluntary sector throughout the borough.</p>

33.	Cllr. Thomas Smith	How did the Council achieve a turnaround in our Ofsted report in such a short space of time?	Chairman, Children, Education & Safeguarding Committee	<p>The incoming DCS had identified problems with Children’s Social Care prior to the inspection carried out in 2017 and the team that led the transformation had come into post.</p> <p>OFSTED identified in their 2019 report “<i>Leaders and managers have made significant progress in improving the quality of children’s services since the previous inspection in 2017. Their determination to strive constantly for improvement and their openness to learning have driven change at pace. This has been supported by the positive input of the improvement board. Strong and effective leadership at a political level and throughout the council has prioritised support and care for children and young people</i>”. Critical to our improvement has been the commitment and focus of all of our staff in Family Services and our partners to work tenaciously for children and young people leading to a child-focussed service.</p>
34.	Cllr. Paul Edwards	The government's latest fuel poverty statistics, dated 13 June 2019, provide data at the Lower Layer Super Output Area (LSOA) level. Can the Leader please provide fuel poverty data in terms of absolute number of households and percentage of households for every ward in Barnet?	Leader	<p>The sub-regional fuel poverty statistics compiled by the Department for Business, Energy and Industrial Strategy (BEIS) are estimates of the number and proportions of fuel poor households by small geographies such as local authority Lower Layer Super Output Area (LSOA). Sub-regional modelling is done because the relatively small sample size of the survey does not give sufficient coverage for all local authorities. It is therefore inappropriate to aggregate that data and provide absolute numbers of households in fuel poverty by ward. Additionally, data is not available from BEIS at ward level. The smallest geography available is LSOA that has been mapped and presented alongside the boundaries of Barnet wards.</p>

35.	Cllr. Gabriel Rozenberg	How many electric charging points have been installed across the Borough in the last six months?	Chairman, Environment Committee	<p>The phase 1 roll-out has included 40 Lamp Post EV Chargers being installed. This comprises our activity over the last six months.</p> <p>In August this year a further 40 lamp column electric vehicle chargers will be installed.</p> <p>In addition, over the coming months, 15 free standing chargers are planned to be installed at Copthall Leisure Centre and seven free-standing chargers will be installed at New Barnet Leisure Centre. Finally, 15 free standing chargers will be installed in our car parks and on-street locations in the early autumn.</p>
