Qn.	Councillor	Question	Response by	Response
1.	Cllr Gordon	<p>The Department for Transport has announced it will allow people with “hidden disabilities” to apply for blue badge parking permits. This will include for example those unable to walk without considerable psychological distress or risking severe harm. Can we ensure that this more understanding approach being promoted by the DfT will be replicated within our own Council among those whose task it is to assess the eligibility of applicants within this Borough?</p>	Leader	<p>In anticipation of the introduction date for the new criteria the London Borough Barnet, as all local authorities are required to do, adopted the Department for Transport's updated guidance for the issuing criteria for a blue badge. The new criteria were in place and available for consideration for anyone applying after the date of the change. We have been considering applications made based on those new criteria since that date and consider that the London Borough of Barnet fully meets its duty to reflect the revised guidance from the Department for Transport.</p>

2.	Cllr Rozenberg	What new measures will Barnet bring forward over the 2018-22 term to reduce the carbon footprint of both the council and the borough as a whole?	Chairman Environment Committee	<p>The emerging Transport Strategy proposes multiple initiatives to promote sustainable and active travel and reduce air quality impacts.</p> <p>Officers are preparing to implement the Ultra-Low Emissions Zone (ULEZ) within LBB, a London wide initiative to reduce polluting vehicle journeys into the city. Officers are currently looking at our fleet procurement options to ensure that we have a compliant fleet operating across the Borough.</p> <p>Electric vehicle charging points have been installed in the borough to encourage the use of Zero-emission vehicles.</p> <p>As part of the RE:FIT programme, final surveys are currently underway to confirm energy saving measures which will be installed across 13 Council owned assets (including libraries, depots, the town hall). At this stage, it is anticipated that across these assets, there will be an annual emission reduction equivalent to 227 tonnes of CO2 due to the energy-saving works. Where possible, the Council will seek to include additional assets and encourage schools to participate in the RE:FIT programme.</p>

Cllr Barry Rawlings	<p>The Governor of the Bank of England has warned that companies that are not moving towards zero-carbon emissions could go bankrupt, and he has also warned about a potential fall in asset values for fossil fuel companies as a result of government regulations. Will the Pensions Committee review the Council's holdings in such companies and propose a plan for divesting from such companies in order to comply with the Council's fiduciary duty of ensuring returns on the Pension Fund are maximised?</p>	Chairman of Pension Fund Committee	<p>The investment of the pension fund are highly diversified across sectors and geographically to avoid a concentration of risks. The Pension Fund Committee, through its appointed fund managers, challenges the companies in which we invest on their management of risks, of which climate change is a major concern, with corporates expected to have long term business plans that recognise moves to a lower-carbon world while still servicing the needs of their customers. The Pension Fund Committee will be reviewing its current approach to engagement, including monitoring of climate change risks, later in the year.</p>

4.	Cllr Gordon	I have been receiving complaints about dogs being allowed to roam freely in sections of parks where there are signs mandating dogs to be kept on a lead, with no complaint or enforcement measures in place. Is there anything the Council can do to toughen up on this issue?	Chairman; Environment	<p>At the present time there are two Council bylaws in relation to Dog Control that originated in 1992 and 1993 respectively for dog fouling, dogs on leads and no dog areas across the borough.</p> <p>Where the Council receives complaints for dog fouling or poor/unsafe dog control they are investigated by Re Enforcement officers and supported by the Council's Waste Enforcement Contractor where we have a Public Spaces Protection Order (PSPO) relevant to Dog Control. At the present time the Barnet Dog Control PSPO is limited to Brook Farm Open Space and King George Playing fields in Underhill and Totteridge wards.</p> <p>As elected members will recall we instigated our Dog Control PSPO in Barnet for these two specific areas agreed with the Environment Committee. This PSPO is now due to be reviewed in accordance with the Delegated Powers Report at the 6 month point (due 13th November). It is our intention to now seek to extend the PSPO into the following areas, subject to approval by the Executive Director, Environment:</p> <ul style="list-style-type: none"> • Hadley Wood • Tudor Park • Clitterhouse Recreational Ground • Moat Mount Open Space • Arrandene Open Space • Dean Road Open Space

				<p>In 2017, Council passed a motion to limit the number of dogs that can be walked by an individual at one time and the following PSPO limited this to four.</p> <p>We welcome any reports of poor dog control to be reported to the Community Safety Team by email at BarnetCST@Barnet.gov.uk. Any dangerous dogs need to be reported to the police using 999.</p>
5.	Cllr Brayne	How much has Barnet Council spent on paid for advertising promoting the improvement of its children's services Ofsted rating from 'failed' to 'good'?	Chairman Children's Committee	The Council has not spent money on advertising promoting the improvement in Children's Services. We have cited our improvement in routine staff recruitment activities.
6.	Cllr Anne Clarke	Is the Leader satisfied with the living conditions of residents living on Marsh Drive?	Leader	Since some residents of Marsh Drive raised specific issues with Barnet Homes regarding the block, they have responded quickly by addressing the problem with vermin and pest infestation, including the implementation of an extended baiting programme across the estate, as well as setting up a dedicated hotline for people to report any issues. Urgent roofing works are also underway to fix the issue of flooding.

7.	Cllr Gordon	The Met Police Commissioner has announced that of the 20,000 additional police officers Boris Johnson promised nationwide, 6000 are to be deployed in London. Are we lobbying strongly for Barnet to obtain its fair share of these?	Chairman; Safer Communities Partnership Board	Absolutely. Barnet residents currently receive far too few officers, particularly with the size of the precept that they pay. We will continue to lobby Commissioner Dick for a fair share of officers.
8.	Cllr Rozenberg	In the aftermath of the antisemitic, far-right extremist murders in Halle, Germany, would the Leader like to put on record this borough's solidarity with the Jewish community in Germany? Would he like to take this opportunity to note the important work done in this borough by the Community Security Trust to keep synagogue attendees safe?	Leader	<p>CST is a fantastic organisation, that help keep so many of our residents feel safe. I am both proud and glad that they are headquartered in our borough, along with the largest Jewish population between New York and Tel Aviv.</p> <p>It is clear that what happened in Halle was a despicable act of hate-motivated violence, that could have been even worse if the synagogue did not have security measures in place.</p> <p>It is the good use of the security measures that makes me relieved that CST receive a generous grant from the Government to protect Jewish schools and synagogues, and that CST is also taking part in community outreach – helping other religious communities learn how to best protect themselves through best practice.</p>

9.	Cllr Danny Rich	Why do Barnet Council continue to entirely omit Finchley Nurseries, one of Barnet's oldest surviving businesses – now 90 years old, from all relevant planning documents, describing it repeatedly as "open fields to the North" despite the site being just 10 meters from the former NIMR?	Chairman Planning Committee	The non-inclusion of neighbouring business or properties is not unusual in Ordnance Survey maps. The existence of Finchley Nurseries is known by both Barnet Council and the developer Barratts London, and noise and vibration monitoring equipment have previously been installed at this site as a result of a request by the Council's Scientific Services Team.
10.	Cllr Gordon	How many cases have there been within the past ten years of Planning Consents being granted by Committee being challenged by judicial review to the point of a hearing in Court? If there were any, how many of those actions were successful against the Council?	Chairman; Planning	There has been 1 case overturned by Judicial Review in the last 10 years.

11.	Cllr Brayne	Regarding the consultation on green waste collection, to what extent will the public consultation influence the decision? If over 50% of residents disagree or strongly disagree with the proposals, will the proposals still go ahead? What about if it's 90%?	Chairman Environment Committee,	The results of the consultation as a whole will be considered by the Environment Committee, taking into account the responses received and the requirement to deliver savings as set out in the consultation document.

Cllr Sara Conway	Following recent footage of Class A drugs being taken in the hallway please can you advise on the current security situation in the Barnet Homes properties at Marsh Drive and when the intercom system will be repaired?	Leader	<p>Barnet Homes continue to work with the Police and the councils Community Safety Team to address anti-social behaviour issues on the estate and Barnet Homes have issued tenancy related legal sanction warning letters to two residents within Marsh Drive.</p> <p>Barnet Homes have also increased their presence on the estate, carried out door knocking exercises within Marsh Drive to obtain evidence and the local Police Safer Neighbourhood team have increased their patrols to the block.</p> <p>Unfortunately, the intercom system to parts of Marsh Drive is beyond economical repair, meaning that the only option would be to replace the entire system including all doors and installations into each property. In order to address the security concerns raised by residents, we have significantly increased the hours of the Wardens on the estate and currently they patrol the estate between 6pm – 4am Monday to Sunday.</p>
13.	Cllr Gordon	Has our Council appointed a Brexit lead to work with Government, as recommended by the Secretary of State for Housing , Communities and Local Government?	Leader	Yes. The Council's Deputy Chief Executive is the Brexit Lead Officer.

14.	Cllr Rozenberg	Does the Leader of the Council stand by his view that Brexit does not come up on the doorstep when he meets with Barnet residents?	Leader	I stand by my statement that nobody brings up Brexit on the doorstep. I find that residents would prefer to talk to councillors about local matters; particularly crime and local environmental issues. I have no doubt that canvassers obsessed with Brexit will claim otherwise.
15.	Cllr Arjun Mittra	Could I have an update on progress for the air quality audit for Martin school that I requested?	Chairman Environment Committee	The levels of Nitrogen Dioxide predicted for Martin primary school are just below the levels set in the air quality objectives. Consequently, Martin Primary school is not one of the top 10 schools which are being prioritised for an air quality audit. The schools which will be audited have Nitrogen Dioxide levels which exceed the air quality objective levels. However, we will put Martin Primary School on the reserve list for an air quality audit should any of the top 10 schools not want an air-quality audit to be carried out.
16.	Cllr Rutter	Have Wilmot Dixon taken responsibility for the issues at the depot?	Leader	Yes, they have taken responsibility for the issues at the depot and are undertaking the necessary repairs at their expense.

17.	Cllr Brayne	Given that 35% of children in Barnet are in poverty (inc. housing costs), what proportion of children are living in households that use food banks? What percentage of children living in poverty does the council consider acceptable?	Chairman, Children	<p>The most recent figures for child poverty from the HMRC (defined as children aged under 16 years old living in families receiving out of work benefits or tax credits, where their reported income is less than 60% median income) show that between 2006 and 2016, the number of children living in poverty has fallen from 15,985 to 10,000. This a reduction from 25% to 14% and is significantly lower than both London (18.8%) and England (17.0%) averages.</p> <p>The council wants to continue to reduce the percentage of children living in poverty and work is already underway to refresh the current Child Poverty Strategy enhancing targeted support to combat child poverty in the borough.</p> <p>The figures from the Child Poverty Action Group, released in 2019, set the percentage of children in poverty in Barnet during 2017/18, at 17% before housing costs and 35% after housing costs. It should be noted that these figures are estimates and that different methodologies for calculating child poverty yield different results.</p> <p>Data is not collected on the proportion of children living in households that use food banks. Food banks are provided by independent organisations and accordingly have different referral processes. Some do not require any referrals at all and do not collect information user demographics. Others, such as Trussell Trust, do not share local data for food</p>

				banks with local authorities. However, the lack of data on food bank usage and food aid usage was identified as a gap within the food security needs analysis completed June 2018. This report also identified key geographical areas at risk as well as population groups. 18.	Cllr Anne Hutton	How many registered organisations are there in Barnet providing Home Care?	Chairman Adults	There are 76 Domiciliary Care Providers registered with the Care Quality Commission (CQC) in Barnet who provide home care services. The Council currently has contracts with 45 of these providers.
19.	Cllr Teare	Would the Leader join me in congratulating our sixth form and college students on their A-level results?	Leader	Yes, I would like to congratulate and thank our secondary schools and colleges for another year where our A Level students surpassed national averages at all thresholds at A-Level.
20.	Cllr Rozenberg	Is knife crime rising or falling in Barnet? What practical steps does the borough plan to bring it under control?	Chairman Safer Communities Partnership Board,	There were 422 Knife Crimes in Barnet in the last year (the 12 months up to June 2019). There has been an increase in knife crime since Sadiq Khan became in 2016. Barnet residents continue to get fewer officers for their money than any other borough. If we were to receive our fair share, then

21.	Cllr Alan Schneiderman	What action will be taken in response to the recent environmental report from Friends of the Earth which says that "Barnet particularly needs to do much better on increasing the use of public transport, cycling, and walking, improving home insulation, and increasing renewable energy"?	Chairman Environment Committee	<p>The Borough's Transport Strategy encourages better use of Public transport and we are working with TfL to increase the capacity of tube and bus services including proposals for Crossrail 2 and the West London Orbital train service. New stations are to be built at Colindale and Brent Cross.</p> <p>New Housing developments are designed to encourage active travel (Walking and Cycling), High levels of insulation are installed in new developments and renewable energy provision is designed into the schemes by developers. Government grants are available for retrofitting of energy-saving initiatives for existing homes.</p>
22.	Cllr Rutter	What impact will the works to repair the depot have on my residents in Brunswick Park?	Leader	<p>We are working with the Principal Contractor to limit impact on the local community and highway network. The works will require periodic deliveries although this will be coordinated to avoid peak traffic times. There may also be some construction noise during the rectification work. We have selected construction methodologies that limit both noise and vibration (such as auger piles as opposed to percussively driven), although we cannot eliminate these factors completely. The Contractor will be instructed to operate within the policy and planning constraints imposed under the original scheme.</p>

23.	Cllr Brayne	How is the air pollution around each of the borough's schools monitored? What measures is the Council taking to reduce school children's exposure to air pollution whilst at school and during their journey to school?	Chairman Environment Committee,	Barnet have had their annual air quality review and assessment recently approved by DEFRA/GLA. The updated Air Quality action plan details on schools was described in the September Environment Committee. The GLA have carried out accurate predictions for Nitrogen Dioxide levels at Schools for 2013 and 2016. 2 schools have been audited, Wessex and Tudor, to identify measures to improve air quality. There are 10 schools now on the list that still exceed NO2 levels and audits will be done via the LIP process for most of the schools in the next 2.5 years - part of that process may include monitoring. The Stars scheme is very successful in Barnet (as set out in the details of the Air Quality Action plan points 13 and 14)
24.	Cllr Gill Sargeant	When will the primary school on the Redrow site need to be submitted for Planning in order for the school to open in 2021?	Leader	The initial pre-application discussions are due to take place shortly and we anticipate the submission of a planning application at some stage next year.

25.	Cllr Wardle	What are we doing to enhance civic pride in Barnet?	Leader	<p>The Council is always trying to enhance civic pride wherever possible. One of the most visible vehicles for doing this is with the Mayoralty, which has attended 210 engagements since the beginning of the term in May.</p> <p>During this time the Mayor, as first citizen of the borough, has been a visible presence within the community whilst also promoting Health and Wellbeing and setting up the Heritage walks for the community to be involved with, to keep fit and learn of the historical facts around Barnet whilst also enjoying Barnet's greenspaces.</p> <p>Community groups and individuals are recognised for the good work that they do, usually voluntary, and the Barnet Civic Awards, hosted by the Mayor, is an opportunity for these unsung heroes to be officially recognised.</p> <p>The Mayoralty officiates at Citizenship ceremonies and is an invited speaker at many functions.</p> <p>The <i>Together, we are Barnet</i> campaign is also helping enhance civic pride across the borough – promoting much of the great work we do.</p> <p>I, of course, want us to continue to enhance the pride that people have living in our borough – and I welcome any suggestions from anyone on how this can be best achieved.</p>

But in recent weeks, some community activists have been calling for the exit to be closed early every night. Does the Council agree that this would punish ordinary commuters while doing nothing to prevent bad behaviour?</p>	<p>Chairman Safer Communities Partnership Board</p>	<p>The area of Station Road and Finchley Central including the Finchley Central Tube area is currently subject to an open investigation by the Community Safety Team and Local Policing Team.</p> <p>This has been subject to a live Community Safety MARAC referral since June 2019. The main issues identified are begging and street drinking and this conduct is linked to a core group of 6 problem persons several of which have been subjected to interviews under caution by the Council's local Community Safety Team and Local Police Team officers resulting in the issuing of Community Protection Notices to the key problem persons within that group. These notices continue to be monitored by the local police Team and are subject to ongoing enforcement activity.</p> <p>Consideration is also being given to the introduction of a Public Spaces Protection Order in the locality however due to recent reports from the local police team that the area has seen a reduction in the issues and complaints the Council has not instigated a public consultation as yet.</p> <p>The Community Safety Team were not aware of calls for the closure of the tube station exit at night so therefore will be making further enquires with Transport for London and British Transport Police to ascertain their assessment of the matter and will then update the Chair of the Safer Communities</p>

27.	Cllr Barry Rawlings	Is the Leader ashamed of the number of children living in poverty revealed in the latest figures, and what are the administration's plans to deal with this scandal?	Leader	<p>Any child poverty is too much, and that is why we are working on a number of initiatives to support families experiencing poverty, such as:</p> <ul style="list-style-type: none"> • Free access to benefit and debt advice through BOOST and the Welfare Reform Task Force at community venues or in customer's own homes. In 2018/19 our advisers gave benefit advice to 836 people and helped 1,467 with universal credit claims. • The Skills Escalator project, which is aimed at low-income households and provides access to training and career advice to help those in work to increase their incomes. BOOST provided holistic family support which includes career progression and working with employers to increase work hours, as well as dedicated help for people to find jobs. The new job retention project going live this autumn will help working people to sustain employment when going through a period of poor mental health. In 2018/19 BOOST had more than 11,000 visits and helped 227 people into work. • The Taskforce engages with households affected by benefit caps or impacted by the change to universal credit. Services offered include welfare benefit, debt and budgeting advice. Discretionary housing payments (DHP) are used to provide a respite to enable households to sustain tenancies

In 2018/19 1081 DHP's were awarded.</p> <ul style="list-style-type: none"> • Other discretionary spend that has been made available to those facing poverty include the Crisis Fund which paid out £268,997 in 2018/19 and the Discretionary Council Tax Support Fund which paid out £112,996 to 221 households. <p>The most recent figures for child poverty from the HMRC (defined as children aged under 16 years old living in families receiving out of work benefits or tax credits, where their reported income is less than 60% median income) show that between 2006 and 2016, the number of children living in poverty has fallen from 15,985 to 10,000. This a reduction from 25% to 14% and is significantly lower than both London (18.8%) and England (17.0%) averages.</p> <p>The figures from the Child Poverty Action Group, released in 2019, set the percentage of children in poverty in Barnet during 2017/18, at 17% before housing costs and 35% after housing costs. Work is already underway to refresh the current Child Poverty Strategy enhancing targeted support to combat child poverty in the borough.</p>
28.	Cllr Byers	Has this year's programme of weed spraying been more or less successful than last year's?	Chairman; Environment	<p>Two borough wide herbicide applications have been delivered to date in the 2019/20 cycle. A further application is being programmed in for quarter 4. These applications have been undertaken by a specialist weed spraying contractor selected following officer research and dialogue with other London Boroughs. The sprays were delivered successfully. Die back of weeds across the borough has been comprehensive and regrowth vastly reduced. Feedback from residents and Members has been positive and post spray assessments from officers have demonstrated a vast improvement on last year's outcome.</p>

29.	Cllr Rozenberg	Can the Leader reassure me that the important work of the borough's Housing Committee over the past 18 months in reducing and preventing homelessness will continue undiminished in the coming years? What will be the role of the new Homelessness Forum?	Leader	Preventing homelessness and reducing rough sleeping remains a key priority for the council. Objectives and actions from the Homelessness Strategy have been embedded in Annual Delivery Plans and within the council's performance framework with progress against key activities reported quarterly. The Homelessness Forum will continue to take forward early intervention and prevention work with partners to help residents remain in good quality homes they can afford.

30.	Cllr Anne Clarke	What discussions and preparations has the Council had regarding the possibility of food and medicine being in inadequate supply in the Borough in the event of a no deal Brexit?	Leader	<p>The Government is working with pharmaceutical companies, suppliers, and the NHS to make sure patients continue to receive the medication they need if the UK leaves the EU without a deal. The Government has analysed the supply chain, made plans to reduce the risk of disruption, and given instructions to pharmaceutical companies to ensure that they have adequate stocks to cope with any potential delays at the border. To avoid the uninterrupted supply of medicines following Brexit, the Department of Health and Social Care (DHSC) are putting in place arrangements for an 'express freight service'. Council contracts are held with sexual health and substance misuse providers, and care home providers, we continue to monitor these contracts regularly ensuring that they reflect their responsibilities in sourcing adequate quantities and quality medicines.</p> <p>In terms of food, while the advice from government is that it is unlikely there will be an overall shortage of food, there may be a reduction in choice. If there was a shortage of some types of food, the council would work with central Government and other regional and national organisations to respond. The council is in the process of setting up a communications network with foodbanks across the borough so that we can monitor levels of supply and demand and respond to issues accordingly.</p>

31.	Cllr Jajeh	Christmas is a very important time for our town centre businesses. Will we be offering free parking in the council's car parks again this year to boost the number of high street shoppers during the festive season?	Chairman; Environment	I am very pleased to announce that we absolutely will be once again offering free parking in the council's car parks, and on streets, for the festive season. This will commence on Small Business Saturday – on the 7 th December, and run through to Christmas.
32.	Cllr Rozenberg:	Will the Leader reassure me that despite changes to the Housing Committee, Barnet Council will continue to put tenants first? Does he continue to believe that expanding selective licensing for the private rented sector will help the borough to crack down on rogue landlords and thus improve conditions for Generation Rent?	Leader	A key objective of the council's Housing Strategy is to improve standards within the Private Rented Sector. As part of that commitment, officers are collating evidence to support the case for selective licensing. Barnet Council has a strong record of prosecuting rogue landlords and the council, in partnership with Re, received £93,000 to develop state-of-the-art, sector-leading technology to combat rogue landlords after a successful funding bid to the Ministry of Housing, Communities & Local Government.

33.	Cllr Danny Rich	<p>Why was the demolition of the former NIMR allowed to proceed without Barnet's Scientific Sciences having any independent asbestos testing equipment in place? Is the Barratt's site manager correct when he reportedly declared the CEMP designed to protect Barnet residents from harm from this most toxic of sites as a "guideline document only"?</p>	Chairman Planning Committee	<p>Prior to demolition, there was a full independent hazardous materials survey done of all the buildings and soil on site.</p> <p>All the asbestos was removed from the buildings. Buildings, where asbestos was present, were air tested and no levels exceeded the appropriate standards after removal, this was done mainly in 2017 and all before demolition.</p> <p>This work was done by asbestos contractors independent of developers and demolition company. However, the remaining stretch of fencing and the rubbish that had been deposited behind it, was not repaired. It was anticipated that, should the Passenger Transport Service utilise the carpark, further works would be required that would supersede any repairs to the fence, the cost of which was not insignificant and would have been negated. Once there is certainty regarding the future use of the Watling Car Park and former market, the fence repairs can be addressed.</p>
113.	Cllr Sara Conway	What measures can be taken to keep the lampposts along Watling Avenue clear of illegal advertising stickers?	Chairman Environment Committee	<p>The council is aware of the stickers that have been placed not only in Burnt Oak but in the other wards of Barnet as well. We are actively monitoring this activity in areas where there is CCTV coverage. Recently we have been successful in capturing the individuals placing the stickers on the lamp posts in Watling Gardens. We will be proceeding to launch a witness appeal to identify the individuals responsible where the images will be displayed in Watling Avenue urging the local community to identify the individuals so that we can take enforcement action as this is criminal fly-posting.</p> <p>We will be considering the appropriate way to remove and prevent the stickers being placed in the area alongside the name and shame campaign. (this will be launched by end November 2019)</p>

Chairman Licensing Committee	The Council has committed to investigate the case for Selective Licensing in the Housing Strategy. The commencement of this work has been delayed due to contractual negotiations between Barnet and Re. It is hoped that these will be resolved imminently. In the meantime, work has been on going on licensing HMOs under the mandatory and additional HMO licensing schemes.

Leader	Governance Officers and the Political Assistants are working jointly to refresh the Members Surgery Risk Assessments completed originally in 2018. Following recently concerns raised by a Member regarding an incident at their surgery, a refresh of the Risk Assessments has commenced and will be led by the Political Assistants. All Members are requested to engage in this process. Additionally, personal safety guidance has been circulated to all Members.
