Council deplores the Government's proposals to:

- impose a massive housing target of 5744 new homes a year in Barnet through their proposed new algorithm
- extend permitted development to allow the building of up to two more storeys on homes and blocks of flats without planning permission
- extend permitted development to allow former shops, offices and warehouses to be converted into housing without planning permission
- reduce Section 106 affordable housing by raising the contribution threshold to 50 units
- grant automatic planning permission for most developments in 'growth' areas
- grant automatic planning permission for most developments in 'renewal' areas subject to basic checks
- remove democratic control and accountability from the planning process by sidelining planning committees
- remove the right of residents to have a say on final planning applications

Council believes these proposals are reckless and will destroy the suburban character of our borough with massive overdevelopment, more tower blocks of one and two bedroom flats, fewer family homes, development on greenbelt and green spaces, the proliferation of poor quality, rabbit-hutch homes in former commercial premises, and even fewer decent, genuinely affordable homes.

Council notes that the Leader of the Council and his administration colleagues recently voted against opposing the Government's 'Planning for the Future' document which makes the case for many of these proposals.

Council calls on the Leader of the Council to publicly set out his views on these matters and explain to Barnet's residents why he will not oppose the plans for massive overdevelopment in 'Planning for the Future'.

Council also notes that it's been three years since the tragedy at Grenfell, but we still have unsafe cladding on private and housing association tower blocks in Colindale, Hendon and across Barnet - a failure of the current planning and regulatory system which must be addressed.

Council believes:

- it is not acceptable for people to be living in unsafe homes**
- the safety and well-being of all our residents should be the first priority of all in positions of power**
- tenants and leaseholders should not have to foot the bill for cladding works through their rent or service charges**
- leaseholders must be able to re-mortgage and obtain insurance.**

Council calls on the Leaders of all three political Groups on the Council to write to the Prime Minister and Secretary of State for MHCLG to #EndOurCladdingScandal now by agreeing the following 10 Steps:

- The government must lead an urgent national effort to remove all dangerous cladding from buildings by June 2022.**
- The Building Safety Fund must cover all buildings, regardless of height, and a range of internal and external fire safety defects, not just cladding.**
- The government should provide the money up front and then seek to recover it from any responsible parties or via a temporary levy on development.**
- Social housing providers must have full and equal access to the fund.**
- The government must compel building owners or managers to be honest with residents about fire safety defects.**
- The government should cover the cost of interim safety measures.**
- The government should act as an insurer of last resort and underwrite insurance where premiums have soared.**
- A fairer, faster process is needed to replace the EWS form and funding is necessary to ensure all buildings requiring a form are surveyed within 12 months.**
- Mental health support must be offered to affected residents.**
- Protecting residents from historic and future costs must be a key commitment of new building safety legislation.**

Explanatory note: on 1 August 2020, new Permitted Development rules came into force that grant permission (without a full planning application) for self-contained flats to be constructed on top of certain existing, purpose-built blocks of flats. This is separate to the wider changes set out in the Planning White Paper that are listed in Cllr Houston's motion. Unlike those proposals, this one has already taken place.
