

Summary

This report provides an update on the delivery and financial performance across the Brent Cross programme and update on emerging issues relating to the Brent Cross West station works contract and the Anticipated Final Cost review.



Officers Recommendations

The Committee is asked to note delivery progress across the Brent Cross (BX) programme as set out in the presentation to the HM Government Assurance Board on 17 November 2021 and the emerging issues relating to the Brent Cross West station works contract and the Anticipated Final Cost review.

1. PURPOSE OF REPORT

Introduction

- 1.1 This report provides an update on the delivery progress of the Brent Cross Programme since the last meeting on 07 October 2021.
- 1.2 A detailed progress update on the Brent Cross programme was provided to the Housing and Growth Committee on 16 November 2021. <u>Brent Cross Cricklewood Update.pdf (moderngov.co.uk)</u>. This Committee noted that the Brent Cross West (BXW) and associated critical infrastructure Anticipated Final Cost review has concluded and will be reported to the Brent Cross Member Working Group and the Finance Performance and Contracts Committee.
- 1.3 The report to the Housing and Growth Committee advised that whilst construction works on the station project continues to progress well, issues and risks are now emerging that are starting to have a material impact on the programme, particularly relating to material cost inflation and supply chain issues as a result of Covid and the current economic climate. This is placing pressure on the Anticipated Final Cost (AFC).
- 1.4 The Brent Cross West Station and associated critical infrastructure AFC review has now concluded. The review indicates that should identified risks materialise there could be a small cost overrun to the project. This has been reported to the Government Assurance Board who have agreed to form a working group to focus on mitigating these risks. The first meeting is scheduled for 23 November 2021. Officers have also put together a risk mitigation and funding plan to deal with the cost pressures, which will be presented during the exempt session of the Committee.

Brent Cross Town

- Pavilion building final finishes. Opening planned for end of November.
- Reserved Matters Planning Approval is now in place for
 - the Student Accommodation units on Plot 25 (planning ref 21/4063/RMA)
 - the Transport Interchange on the eastern side of the Brent Cross West Station (planning ref 21/2289/RMA).
- Clitterhouse Playing Fields consultation period has completed. Outcomes will feed into final design https://www.brentcrosstown.co.uk/clitterhouse-playing-fields-consultation
- Works on Claremont Park are ongoing. The park remains on schedule to open in Spring 2022. Maintenance agreements being negotiated.
- Plot development anticipated in March (Phase Unconditional Date to be updated in line with H&G approval)





Plots 53/54

- Works continue on site. Earthworks and levelling progressing ahead of piling works. Ongoing liaison with neighbouring residents to resolve issues over construction traffic.
- Ground 10A and shared equity surgeries to be held through November for council tenants and resident homeowners who are interested in taking up an offer of a new home.

Southern Junctions

- The junction of the A5 Cricklewood Broadway, Cricklewood Lane and Chichele Road is now fully operational and bus stops have been restored.
- Officers are currently working through the future use of the remaining site and how it best contributes to Cricklewood Town Centre.





Waste Facility

 Award of contract confirmed to McLaughlin & Harvey as contractor for a two-stage NEC3 ECC Design & Build the replacement Waste Transfer Station.







Brent Cross West Station

- Good progress being made on construction works for the new station.
 - The first 'Y' columns that support the high level canopies were installed
 - Platform copers and drainage installation progressing well
 - The fast platform lift shaft concrete works are now complete ahead of programme
 - The western entrance substructure works progressing to programme
 - Final surfacing on the TOC access road complete
- De-commissioning of the Network Rail / Amey site accommodation ahead of handover to BXT.
- Detailed handover programme has been shared with stakeholders.
- Developing proposals for the Western Entrance public realm.
- Health & Safety incidents workshop held 12 Nov. LBB / Mace escalating with NR/VF
