Agenda Item 9 – Social Distancing Measures	<p>John Smedley</p> <p>I would like to know if statistics have been collected, in particular</p> <p>Numbers of cyclists and motorists using the road where there are the restrictions since the start of the plan.</p> <p>Similar numbers for an equal time period before the plan, to see whether road usage has changed.</p> <p>Accident figures for current and previous periods both for cyclist and motor if available.</p>	<p>Paragraph 4.6 of the report references the ongoing collection of cycle volume data. Data has been and continues to be collected. We do not have data prior to the impact of covid. The data we do have currently shows volumes in line with seasonal variations. However, the evolving approach to covid mitigation over the last 2 years, including lockdowns and flexible working, currently makes it difficult to interpret changing travel habits and current and future demand. For that reason we are looking to continue data collection as we begin to come out of covid and begin to see a new stability in travel habits.</p>
