Qn.	Councillor	Question	Response by	Response
1.	Cllr Whysall	What impact does the Leader believe the Government's crashing of the economy will have on Barnet and its residents and businesses?	Leader	An adverse impact - and we're already seeing it. Higher interest rates, higher mortgages, higher inflation, higher prices, more people in debt, likelihood of more businesses failing, terrible cuts to public services and the adverse impact of that on vulnerable service users.
2.	Cllr Thomas	Does the Leader recognise the difference between a refund and a reduction?	Leader	Yes, and the advantages to the way we are delivering our pledge to refund the 1% Conservative council tax hike is as follows: Residents in immediate financial difficulty as a result of the Conservative-caused cost-of-living crisis will benefit from a targeted refund made available through our £2m Resident Support Fund (equivalent to 1% on council tax), and all residents will benefit from a universal 1% refund delivered through next year's council tax bills which means a total of £4m or 2% in council tax terms will have been given back to Barnet's residents - effectively double the pledge made. We are ensuring that the Council is not spending any additional money for consultation and other costs to deliver the pledge, and residents benefit from lower council tax levels going forward.
3.	Cllr Rose	Does the Leader agree that the implementation of the new health and social care bill should be delayed until it is properly funded by the Government?	Leader / Cllr Edwards	Absolutely - it's likely to cost us at least £3m at a time when we are getting very little support from central government to cover the demand for adults social care services.
4.	Cllr Longstaff	<p>"In the Labour Party Manifesto, it is clearly stated, "We will maintain quarterly deep cleans of residential streets".</p> <p>But in the P&R papers from 29th September, you commit to two deep cleans per year. Why are you not sticking to your manifesto commitment on street cleaning?</p>	Cllr Schneiderman	The reference to a minimum of two street cleansing cleanses a year in appendix B of the Business Planning report submitted to Policy & Resources Committee on 29 September details the existing street cleansing specification that was set prior to May 2022 and the confirmation of the council's current commitment in respect of this service. Street Cleansing service proposals that seek to deliver four visits per annum to residential roads are currently being developed in conjunction with the Chair of the Environment & Climate Change Committee for introduction by the end of the calendar year.

5.	Cllr Young	Does the Leader agree that the new policies in the emerging local plan will give stronger protection to the green belt in line with national policy and help deliver the administration's commitment to protecting our green spaces in the future.	Leader	As part of the Local Plan examination, the Council has taken the opportunity to submit initial modifications for the Inspector's consideration. Changes have been made to remove 'low quality, low value' element of ECC04 – Parks and Open Spaces. The Local Plan's housing target is not reliant on the development of such spaces or any Green Belt release which is afforded the strongest protection in accordance with London Plan and national policy.
6.	Cllr Thomas	Will the Leader commit to doing the right thing and freeze council tax next year, given the rising cost of living?	Leader	Unfortunately, the Conservative Government has crashed the economy, and we are now expecting swingeing cuts from central government to plug the gaping £40bn hole they have caused, which makes my desire to freeze council tax that much harder. But we will be delivering our 1% refund through council tax bills next year, and we will not be hiking up council tax by the legal maximum as the Barnet Conservatives did - even without the refund.
7.	Cllr Velleman	One of the most frequent issues we receive from residents, community groups and schools is the safety of our roads in Whetstone and Barnet in general. Do you think it is time to support 'twenty's plenty' campaigns on residential roads and other measures to make our roads safer for all road and pavement users?	Cllr Schneiderman	<p>"We agree that reducing speed limits is one measure that may help reduce road casualties as well as deliver a range of other transport and health benefits.</p> <p>The Administration has stated its support for 20 mph zones where residents want them. Such zones typically involve physical measures alongside a speed limit to calm traffic and cover an area consisting of several roads; evidence shows that this approach is more effective than simply introducing a 20-mph speed limit. There are already a number of such zones in Barnet.</p> <p>We intend to review the Council's Long-Term Transport Strategy and as part of this will look at setting out a policy to identify places suitable for 20mph zones and the process for taking proposals forward. Of course, introducing zones will require full and timely consultation with residents, the police and other emergency services, and other stakeholders including local businesses, pedestrians, cyclists and drivers."</p>

8.	Cllr Grover	How does the Leader anticipate maintaining service levels and accountability from the Council's privatised service providers for the next three and a half years now that they have been handed their notice?	Leader	The current contract management process will continue to operate for the extended services. The extended services will still be subject to performance targets and service credits for any underperformance.
9.	Cllr Clarke	What is the Leader most proud of after 200 days in administration?	Leader	The fact that we have made progress to deliver so many of our election pledges already in such a short space of time, including: Our pledge to refund the 1% Conservative Council Tax hike in a targeted way to help people in crisis now through the Resident Support Fund, and universally through a 1% refund in all council tax bills next year, that we have maintained weekly bin collections, declared a climate emergency, agreed a community skips services, about to roll-out community safety hubs and ward safety walks, are investing an additional £1.8m to upgrade the borough's CCTV, proposed more robust policies on affordable housing, height, density and protection of green spaces, and worked with the community to put in place a wonderful Black History Month programme to name only a few things we can be proud of.
10.	Cllr Thomas	How will increasing parking charges by 10% help residents and businesses?	Cllr Schneiderman	The proposed increases are 5% less than the Barnet Conservatives proposed in their budget and are in line with inflation which is unfortunately high due to the Conservative Government crashing the economy.
11.	Cllr Khalick	When and where will the community safety hubs pathfinder programme be launched?	Cllr Conway	The first two community safety hubs will be launched in Edgware and West Hendon. The Edgware hub is located at The Meeting Room in Broadwalk Shopping Centre and will open on Thursday 27 October between 3pm and 6pm. The West Hendon hub is located at the Metropolitan Thames Valley Community hub facility and will open on Tuesday 1 November between 3pm and 6pm. The hubs will then open at these times weekly for the duration of the pathfinder, though the opening times will be reviewed in December. Further sites will be explored as part of the pathfinder, in particular sites in the North and the East of the borough. A number of sites are being explored and should be open shortly.

12.	Cllr Thomas	In March this year, Labour proposed to save £2m by cutting senior Council officers. They have now scrapped this proposal and are instead recruiting for two posts costing ~£160k a year. How can they justify this?	Leader	We will be making much more than £2m savings in this year's budget process - the current budget gap for next year is £10m, and we will close that gap to deliver a balanced budget whilst protecting frontline services and keeping council tax low.
13.	Cllr Mittra	What is the Council doing to enhance street cleaning in the Borough?	Cllr Schneiderman	An additional £500k is being invested in the council's street cleansing service. Service proposals that seek to deliver four street cleansing visits per annum to residential roads (currently two per annum) are currently being developed in conjunction with the Chair of the Environment & Climate Change Committee for introduction by the end of the calendar year.
14.	Cllr R Cornelius	Could the leader confirm how many extra homes will be built by the next council election and how this compares with the plans inherited from the last administration.	Cllr Houston	In addition to the schemes that have been inherited by the previous administration (for which we are reviewing the unit and tenure mix to maximise affordable housing delivery) a number of new schemes are currently being explored, for which we hope to bring business cases forward to Committee over the coming year. These schemes are all subject to resident and stakeholder engagement which will inform the number of units that will be delivered. It is important that any homes coming forward meet housing need and so will be prioritising affordable, larger, accessible, family homes where possible.
15.	Cllr Rose	I was disappointed to see that the national Planning Inspector approved the Barnet House development of mainly rabbit hutch flats. Does the Leader agree this situation was the failing of the previous Conservative administration to pressure developers to build homes fit for families here in Barnet?	Leader/ Cllr Houston	Yes, the Conservative approach to growth has been flawed all along - the planning reforms allowing wider permitted development has not helped deliver quality affordable family homes, and following 'Trussonomics' building affordable family homes has got so much harder overnight. Ironically the Truss growth plan is unlikely to result in much growth any time soon.....

16.	Cllr Thomas	Barnet's Iranian community will be concerned to see the mistreatment of women in Iran, which have led to justifiable protests, where they have friends and relatives. Does the Leader agree with me that the treatment of women in Iran - and Afghanistan for tha matter - is unacceptable?	Leader/ Cllr Conway	I condemn the mistreatment of women wherever it occurs. Ending violence against women and girls requires us to challenge and change harmful societal attitudes towards women globally, including here at home in the UK. I am in favour of making misogyny a hate crime, and I look forward to all members supporting this campaign.
17.	Cllr Lemon	When will the new community skips service begin?	Cllr Schneiderman	It is anticipated that the Community Skip Service will commence in November. We have scheduled 12 weeks' worth of skip locations initially, and will use the intelligence and learnings from this first phase of the project to inform the development of the future phases on a dynamic basis as we progress through the schedule.
18.	Cllr Thomas	A recent P&R report contained the following line which was confirmed as relating to CPZ permits: "Parking - A review of services and policies to ensure a consistent, fair approach to improving traffic, highway air quality and road safety. Meeting existing unaddressed needs and demands on the highway." Based on the current CPZ regime, how many extra CPZ permits need to be sold to achieve the administration's target of increasing parking revenue by £1.5m?	Cllr Schneiderman	The CPZ programme covers areas with identified potential need for a CPZ and areas of existing CPZs which need review to ensure that controls remain suitable for current highway need and demand. The programme assumes that implementation, operation, maintenance, and administration costs are offset over time using a range of sources including parking penalties, parking permit sales incorporating visitors, business and schools parking permits. Turn up and pay parking contributes the next largest amount followed by the suspension of parking bays. It is not possible to determine exact numbers of permits that will be sold under this programme but estimate it to be approximately 5,000."

Cllr P Cohen	Can we welcome the co-operation between councillors and the Met Police in taking to the streets of Barnet to promote safer transport on buses and tubes, particularly for women and girls, through such means as the Street Safe pilot service and the Hollie Guard smartphone app. Does the Leader agree that the	Cllr Conway	I welcome this co-operation, and note we are inviting the Roads and Transport Police to the Safer Communities Partnership Board on 4 Nov. Community safety, including the safety of women and girls, is a key priority for this Labour administration and we have already made progress on delivering key pledges including for community safety hubs, ward safety walks, developing an identified network of safe spaces, and investment of an additional £1.8m to upgrade our CCTV.

Cllr Longstaff	<p>"In Labour's 2022 Election manifesto, which you proudly referred to at the last council meeting as something you would faithfully implement, the following was written:</p> <p>"To help you, we will freeze Barnet's council tax this year, and give you back the 1% Conservative Council Tax Hike forced through in March."</p> <p>Please will you tell me in which municipal year you will be freezing council tax? "</p>	Leader	The Barnet Labour Group budget amendment included a general council tax freeze for 2022/23 which has been implemented. We also promised to refund the 1% council tax hike (social care precept) imposed this year by the Barnet Conservatives. We will be delivering the refund through council tax bills in 2023/24 to avoid costs to the council tax payer of around £200,000 that would be incurred if we implemented the refund before then.
21.	Cllr Perlberg	How are Barnet schools coping with increasing costs of energy, goods and food prices?	Cllr Coakley-Webb	Barnet schools ended the 2021-22 year with 23 schools in deficit, up from 12 the previous year. The total amount of deficit also increased £760k to £3.57m in the year to March 22. The increasing costs of energy, goods and food prices, as well as salary increases is putting further pressure on the school budgets. Regarding energy 61 LA maintained schools in Barnet, out of a possible 90 LA maintained schools, purchase their energy through the Barnet contract (academies don't have the option of purchasing energy centrally) and it is unlikely that there will be any reduction in charges under this phase of the Energy Bill Relief Scheme as the charges currently paid under the Barnet contract arrangements are already substantially lower than the support levels set by the government to reduce maximum costs paid by energy consumers. The situation will continued to be monitored going forward, particularly as arrangements under the scheme are expected to be reviewed after three months.

Events were hosted online and across the borough with Barnet Mencap and the Police. Hate Crime reporting centres and the Barnet Safe Places Scheme were both promoted, alongside encouraging people to become Hate Crime reporting champions, pledging to report hate crime if they witness it. Hate Crime Awareness week Events Flyer attached.</p>
24.	Cllr Thomas	<p>What is the risk that garden waste subscriptions will fall if the annual charge is increased from £70 to £80?</p>	Cllr Schneiderman	<p>None - we're not increasing the charge. The increase the councillor refers to was a proposal from the Conservatives which we are rejecting.</p>
25.	Cllr Velleman	<p>As an alumnus of Alonim nursery, then in Southgate, now in Whetstone, I am delighted that Alonim will be celebrating their 40th anniversary in November. Will the Leader congratulate them on their activities to date and wish them well for the future?</p>	Leader	<p>I am delighted to congratulate the Alonim Nursery on their 40th Anniversary, and to send them my very best wishes for their future success.</p>

What outcomes does the Leader</p>	Cllr Schneiderman	<p>A citizens' assembly is a group of the public who are brought together to consider a public issue in depth over multiple days and meetings. TPXImpact have been appointed to support us in delivering the Citizen's Assembly - work to develop a 'killer question' which will be deliberated by</p>

As part of the assembly members hear evidence, question witnesses and deliberate with one another, before reaching recommendations on what they think should be done. Citizens' assemblies put the trade-offs faced by decision-makers in front of members of the public and ask them to arrive at workable recommendations. The main outcome of a Citizen Assembly is that it can bring out diverse perspectives on complex and contested problems, enable decision-makers to come face-to-face with citizens or those with lived experience of an issue, help participants to understand, change and develop their opinions, and offer policymakers an insight on public opinion on a contested issue based on the public having access to thorough and unbiased information and time for deliberation.

Leader	<p>"The change national economic picture (including rising inflation, increasing interest rates and changing budget announcements) along with uncertainty related to future funding for local government is creating significant pressure in the council. The Medium Term Financial Strategy (MTFS) presented to Policy & Resources Committee on 29th September 2022 presented a range of scenarios with the mid-case showing a budget gap of £10.443m for 2023/24 and additional savings of £44.721m being required for expected expenditure to be sustainable within expected income across the MTFS period to 2026/27. Since then, announcements from subsequent Chancellors have made it clear that further reductions to public spending should be expected.</p> <p>The Chancellor has announced a full medium term fiscal plan on 31st October 2022. This will provide greater clarity around local government funding and enable us to better plan resources across 2023-2027 to ensure a balanced budget for 2023/24 and prepare for any future budget gaps to 2027.</p> <p>The national economic picture is having an impact on residents as well and supporting them through the cost of living crisis is also expected to have an adverse impact on income particularly in relation to leisure and parking income and around the council's ability to collect council tax and business rates debt."</p>

37.	Cllr Cooke	Would the Chair provide an update on the roll-out of electric vehicle charging in the Borough?	Cllr Schneiderman	The council is committed to encouraging the uptake of electric vehicles and sustainable modes of transport through the provision of electric vehicle charge points. Barnet currently has over 200 publicly accessible charge points and will be installing a further 610 charge points over the coming year. 510 of which will be placed along 34 streets in the borough, with installations starting on the first site (Gloucester Grove) on 17 October. The other 100 will be Fast Chargers placed in town centre locations across the borough and this work will take place over the next 9 months. The Council has been successful in securing large sums of grant funding to support these two current EV projects and we are currently working on submitting a further grant funding bid for a further project to be delivered in 23/24. In addition to the current projects identified above we will continue to also roll out Lamp post mounted EV charge points.
38.	Cllr Wardle	Will the North Finchley SPD be revisited?	Cllr Young	There are no plans to revisit the North Finchley SPD
39.	Cllr Velleman	What are the Council doing to support residents in this cost of living crisis exacerbated by the Conservative Government's mismanagement of the economy?	Leader	The Council have put in place a package of measures totalling £9m to help residents through the cost of living crisis, including a £2m Resident Support Fund (which is equivalent to 1% of council tax and represents a targeted refund of 1%) for those in immediate financial crisis, a universal refund of 1% of council tax through next year's council tax bills, a Housing support fund of £2.5m, a contribution of £150k to the Barnet Together Alliance Community Response Fund taking their total to £300,000, a Community Innovation Fund of £250,000, payments of Council Tax Discretionary Relief, Discretionary Housing Payments up to £1,445,000 (£626,000 awarded to date), a School Uniform Fund (£17,000 spent to date), and we are also currently working with colleagues to develop Health & Safety guidance for any community spaces that wish to be a warm space for local residents - we will be making a list of these spaces and initiatives available on a website later in the year. Cllr Whysall	Following the report sent to all councils last month by the government regarding the implementation of the Elections Act 2022 what steps are being taken to introduce the proposed permanent or interim Voter Card the Council have been instructed they must make available?	Leader	<p>It is recognised that the Elections Act 2022 will bring forth some significant changes to the way elections must be conducted and of these, the requirement for electors voting in polling stations to show photo ID before receiving their ballot papers is rightly considered to be the change that will have the most impact.</p> <p>The government have stated that their research shows that 98% of electors already have an acceptable form of identification. Electors that do NOT have suitable photo ID will be able to apply for a free Voter Authority Card (VAC) – and the government is creating a national online portal where this application can be made and following which, upon successful application, the elector will receive their VAC in the post. Local Authority Electoral Registration Teams may need to, in what is anticipated by the government to be a small number of cases, produce a VAC locally for an elector to collect from the Council's offices should the elector not have received their VAC in the run up to an election.</p> <p>The detail around the actual mechanisms that Electoral Registration teams must follow is still emerging from DLUHC and the secondary legislation that will bring the relevant processes into law has yet to be seen.
