**APPLICANT'S WRITTEN SUBMISSIONS**

**Summary**

1. The applicant seeks a premises licence to operate music events on the above Council land in the years 2023 – 2027.
2. The background to the application is fully set out in the officer's report, and is not repeated here. The Sub-Committee is asked respectfully to note the schedule of conditions (page 41) and covering note (page 46). Amendments have been made to the application at the request of responsible authorities, as the officer notes (pages 13-14).
3. On 16<sup>th</sup> June 2022, the Licensing Sub-Committee granted a licence for a weekend of events in 2022. In its decision, the Sub-Committee noted "the extensive conditions agreed with the Police and the fact that no responsible authorities had made any representations."
4. The 2022 events proceeded in accordance with the premises licence conditions, in consultation with the Safety Advisory Group and under the eye of the responsible authorities.
5. The applicant has proposed the same conditions in 2023.<sup>1</sup>
6. The applicant has assembled an experienced team for delivery of the events (see page 46). The senior team is responsible for development of the event management plan,

which is a comprehensive document dealing with all aspects of the safe and efficient operation of the event including, by way of example: crime prevention and security arrangements,<sup>2</sup> risk assessments, crowd management; noise management; traffic management; bar and alcohol management; medical plan; and production schedule. As is standard in events of this nature, it is an iterative bible of documents to be finalised in consultation with the Safety Advisory Group in advance of the event (see condition 38).

7. The applicant is again grateful to note that, as a result of the experience from 2022, the ongoing working with the Safety Advisory Group and the proposed conditions, there are no representations from any responsible authority.
8. The applicant is pleased to attach a number of supportive letters dealing with the 2022 event, including from local residents.

### **Representations**

9. The applicant replies briefly to concerns raised by objectors as follows.

### **Dates**

10. A concern is expressed of risk to school children if events are held during term time.
11. The events are planned to be held in August.
12. If for any reason, a future event takes place during term time:
  - a. it will not take place during school hours;
  - b. the applicant will notify local schools giving them notice of proposed dates and times.

### **Number of attendees**

13. An “extreme concern” is registered that numbers have not been given.
14. In fact, numbers are given on the application form (see page 20). This year the capacity will be 15,000. In 2024 it will be 17,500. In 2025-2027 it will be 19,999. The reason for this approach is to enable growth to happen in a controlled manner, and so lessons from each year can be applied to the next.

### **Parking**

15. A concern is expressed regarding parking in 2022, particularly around Longfield Avenue and Page Street.
16. The applicant agrees that, on the Saturday in 2022, there was a complaint to the events telephone line from a resident of Longfield Avenue. The organisers’ Community Manager attended and agreed that the complaint was justified. Accordingly, the organisers work with Barnet Council to resolve the issue. On the Sunday, stewards were located in the area of Longfield Avenue to prevent inconsiderate parking. The Community Manager attended Longfield Avenue together with Barnet Council’s Events Manager on the Sunday and spoke with residents, who were satisfied with the action taken.
17. In the light of that experience, the traffic management plan for 2023 will include (i) the allocation of additional parking areas; (ii) further marshals in the area identified, (iii) clearer signage and (iv) an on-site removal truck. The traffic management plan will be developed with Barnet Council’s own highways department to ensure that residents are properly protected.

### **Noise**

18. A general objection has been made regarding noise from the events.
19. The noise limits for the events were set by Barnet Council. The limits are monitored throughout the event by the organisers’ acoustic team, who will also respond to any

complaints logged through the dedicated noise line. The limits set by the Council were complied with.

20. The same process will appertain in 2023.

21. A separate general complaint is made that many residents were disturbed by revellers going home.

22. The Sub-Committee will note that under the application (page 32) the site must close by 10 p.m. The event management plan will specifically deal with egress routes, will seek so far as practical to divert those departing from residential areas and will allocate additional stewarding to patrol surrounding roads to ensure a prompt and quiet departure.

### **Recreation**

23. A complaint is made that children are deprived of green space to play in and dog walkers to walk in. In fact, the field adjacent to the site remains open to use, which comprises a minimum of 45,000 square metres of space, and 50,000 square metres during the build and break phases.

24. A complaint is also made that programmed sports games had to be called off in 2022. In fact, as the Council's Parks and Green Spaces Management Team have confirmed, all games were postponed across the borough in July, August and September due to dry conditions causing cracking of pitches.

25. A complaint is made that the swimming pool had to be closed. This is factually incorrect: it was open as normal.

26. A separate complaint is made regarding damage to ground surface. The organisers invest in preventative measures, including the laying of temporary tracks, and planning plant movements, together with contractual responsibilities to make good any surface damage.

27. Finally, it is said that the Metro Golf car park was reserved for festival goers. This is not true. The car park was marshalled throughout the event and no festival goers were permitted to park there.

### **Build and break**

28. A complaint is made that crews were working to 10 p.m. in 2022 and that the fields will be out of bounds for too long.

29. The build and break phase will take 11 days maximum, unless there is bad weather which necessitates extra time and care to prevent surface damage.

30. No plant movement or loud work occurs beyond 8 p.m. In 2022, cleaners and security will have worked beyond that hour, but that caused no noise or complaint. In fact, there was no complaint at all regarding the build and break in 2022.

31. A separate complaint is made that equipment was left on site. Some equipment was left on site by a supplier in 2022, which the organisers pressed to remove expeditiously. The failure of a traffic management company to remove traffic signage timeously led to the removal of the company for this year's events.

### **Bats**

32. There is a general concern raised regarding bats. However, no concern has been raised by any authority or agency concerning harm to wildlife, and no evidence has been presented on the topic.

### **51<sup>st</sup> Festivals**

33. An allegation is made that after 2019 Enfield Council refused to licence the festival in Trent Park. This is incorrect. The festival took place in Trent Park until 2021, following which the Council wished to leave the ground fallow to recover following poor weather. Enfield Council have confirmed that they would welcome the return of the festival. Objectors also refer to the Elrow Town Festival in 2019, but this is nothing whatsoever to do with the applicant.

## **Fintan Daly**

34. Mr Daly complains that customers of the golf centre were impeded by a backup of vehicles at the top of Champions Way, that some festival goers spilled into the car park and that the golf centre was awaiting compensation for disruption.

35. The applicant is disappointed to read this objection:

- (1) The golf centre car park was stewarded at the organisers' cost, and the arrangements were checked by the Council to ensure that staff were in place and that only golf club customers could gain access.
- (2) The pick up and drop off point was located off site in the Power League Car Park on Pursley Way to reduce the risk of congestion on Champions Way as requested by Metro Golf prior to the event weekend.
- (3) The present complaints were not brought to the organisers' attention during or after the events.

36. Nevertheless, the following steps will be taken for this year:

- (1) A new traffic management team has been appointed.
- (2) The applicant will be more than pleased to liaise with Metro Golf to minimise any disruption.
- (3) With the advantage of year one data, the applicant has been in talks with Saracens RFC to utilise additional parking sites (and to utilise other sites also used by the rugby club) and speeding up traffic flow on Champions Way.
- (4) Metro Golf will be given a direct telephone number in case of any issue with security at its car park. This will provide direct communication to event control and access to traffic managers and security supervisors.



## **Conclusion**

37. The Sub-Committee is invited to the view that it is appropriate to grant this licence subject to the detailed list of conditions presented, in the knowledge that no responsible authority has made any representation following the experience of 2022. The Sub-Committee may be assured that the applicant's experienced team will continue to liaise with the Safety Advisory Group and also with the objectors, should they wish this to happen.

Hi there,

Thank you for your email and the tickets for residents. I'm happy to provide feedback; however, I would prefer this to be anonymised if shared.

- I had a lovely afternoon at the 51st festival and thought it was a good use of the space available at that location.
- It appeared to be well organised with considerable thought given to minimising disruption to residents.

- I thought the number of attendees was appropriate and manageable.
- There was ample security, the search when entering the event seemed quite thorough, and security staff were visible throughout the event.
- Keeping the area clean was a priority with lots of bins provided and staff picking up litter.
- The first aid tent was signposted and the medical staff there were friendly and approachable.
- There was a good number of toilets; however, there didn't appear to be a clear queuing system which inevitably caused some confusion for attendees.
- I appreciated that drinking water was easily accessible at water fountains.
- A variety of food stalls were present; I wasn't sure whether these were local businesses. If not, then I would hope that local businesses are encouraged and given priority to set up stalls at the event.
- For some reason, I didn't know about the event until the day before, which is surprising and potentially indicative of gaps in channels of communication with residents, particularly from a target demographic for such an event.
- Thankfully I was able to request tickets the night before and purchase them the following morning. I strongly support the provision of free/discounted tickets to residents.
- As parking at the event was not relevant to me, I didn't really pay much attention to the availability of parking. However, I strongly support robust parking enforcement from the council to minimise any disruption to residents.
- I would attend again if offered free/discounted tickets and would not mind if the event was hosted at the same location again. I found it to be a positive moment for the local community!
