1.	Cllr Shooter	The Prime Minister, quite rightly refused to bail out Birmingham City when the Labour group ran it into the ground, will the leader be seeking a bailout when the cabinet drives Barnet to the same place despite the robust position that was handed to them 18 months ago?	Leader	It is doubtful that The Prime Minister will bailout Birmingham, just as he refused to bailout Conservative Thurrock and Conservative Northamptonshire. This has been a difficult thirteen years for local government, as central government grants have been more than halved. And Barnet's Conservative administrations have also found it difficult, having to call draw millions and millions in ressrves, even in the years before Covid. But we will close the gap responsibly, without unrealistic Liz Truss like spending or tax proposals.
2.	Cllr Thomas	Please list the membership of the new Financial Sustainability Board and the dates it has convened.	Leader	The purpose of the Financial Sustainability Board is to review financial risks identified through outturn and to review income opportunities. The Board includes: The Section 151 Officer; The Assistant Director for Finance; Executive Directors, Directorate Business Planning Leads, Directorate Heads of Service; Directorate Head of Finance; Investment Project Managers. It met on the 29th June, 26th July, 19th September and the 26th September.  i. To review financial risks identified through outturn  ii. To review income opportunities
3.	Cllr Greenspan	What is the current backlog of unrepaired potholes and please provide monthly figures since November 2022 detailing: 1. Number of Potholes reported.  2. Number of Potholes fixed.  3. Average time from report to repair. Please provide detailed responses to each numbered item in the question and note that I have requested monthly figures.	Cabinet member for Environment & Climate Change	From December 2022 to September 2023 inclusive, 4,617 potholes have been reported and 4,357 potholes have been fixed. The average time from report to filling in is 8 days - this covers all categories of potholes with the most serious ones being fixed more quickly.  AGRICATION OF THE PROPERTY OF THE PR

4.	Cllr Thomas	At the September Overview and Scrutiny Committee, Cllr Schneiderman said that the increase to parking charges reflected the increasing costs of running the service. Please advise what elements of running the service have increased by more than inflation since the last increases to charges were implemented.	Cabinet member for Environment & Climate Change	Inflation has peaked at 11 per cent under this Conservative Government. That has had an impact on the cost of contracts, labour and materials.
5.	Cllr Rose	There have been ten Section 114 notices issued since 2018, when in the 17 years previously there were none including Conservative Thurrock, Liberal Democrat Woking and, yes, Labour Birmingham. This appears to be the impact of a 50 per cent cut in central government funding since 2010. How do we not just balance the budget this year, but prepare for any more Truss-like reckless funding slashes that may come out of this desperate and dying government.	Leader	We are meticulously challenging and re-building budgets to ensure future demand for services is understood and built in. This task has not been helped by the reckless Government mini-budget of last year. What we really need is sanity in Government, which can only come from Labour.
6.	Cllr Longstaff	The Labour Administration plans to increase Controlled Parking Zone prices by 10.9% for several of the bandings from January 2024. This is on the back of similar increases in January this year. The increases are well beyond the cost of the service. The Cabinet Member said this was to	Cabinet member for Environment & Climate Change	Under this Conservative Government, inflation has run as high as 11 per cent, and therefore freezing parking charges is the equivalent of a subsidy to motoring. This is about ensuring a level playing field for council taxpayers, service users, and yes those that use their cars. We're all in this together.

7.	Cllr Mittra	There has been real concern that following Prime Minister's nudge and a wink to climate deniers by postponing the end of the sales of new petrol cars, that there will be a drying up of investment in electrical charging points. Will the Cabinet member for Transport and Climate Change commit to continue Barnet's investment infrastructure for electric even as the Conservatives start to indulge their worst instincts.	Cabinet member for Environment & Climate Change	Even if the Government is wobbly on Climate Change and our children's future, we are going to be continuing to push for more electric vehicle points, planting trees and ensuring transport choices in Barnet. We hope to see a Labour Government whose Green New Deal will supercharge an agenda the Conservatives have left to stagnate for too long.
8.	Cllr Greenspan	Will the Leader update council the progress of the council's support to Jewish Schools in dealing with the Kosher school crisis since the last council meeting?	Cabinet member for Family Friendly Barnet	Following detailed written feedback from Barnet Council to the GLA about the potential financial impact of the Mayor's Offer on Jewish schools, the GLA published an Equality Impact assessment (EQIA). Following the EQIA, the Mayor agreed a further £5m contingency to address extraordinary costs, which resulted in an uplift in the grant for kosher school meals, equating to 85p per meal, which takes the total funding for each kosher meal to £3.50. The council also provided feedback to the LGA about the potential financial impact of the offer on all schools, particularly in relation to schools being paid for only 80% take up. The GLA subsequently increased the payment rate to 90% take up and all schools will receive this, even if the take up is lower than this. The council has sent out a survey to all schools to find out what their take up has been at the start of term and to ask them if they anticipate any negative financial impacts as a result of

				implementing the Mayor's Offer and, if so, this will again be raised with the GLA. The council have been working with Pardes House, who are leading a tender to find a new schools meals provider for the Jewish Schools. The Council has offered a lease for the Kosher Kitchen with a peppercorn rent and the details of this offer have been included in the tender. However, not all of Barnet's Jewish schools have chosen to be part of the tender and so part of the survey to schools, specific questions have been included for Jewish schools to get an update on how they are currently providing free school meals. The shortfall for providing Free School Kosher Meals in Key Stage 1, a Westminster Government policy, continues to be an issue for Jewish schools in Barnet.
9.	CIIr Radford	May I thank the Cabinet member for Family Friendly Barnet for her speedy response to the national RAAC scandal? While I am pleased to hear that East Barnet schools seem to not be immediately affected, I was greatly reassured by the speed of her and officers' respons. Can an update be given on the implications for the non-school estate?	Cabinet member for Family Friendly Barnet	Following the review of our managed school portfolio, we carried out a secondary review to double-check the initial findings. Following this secondary review, Underhill School, most of which was built in 1932, has had another visual survey carried out in the separate extension building, and has been identified as requiring further intrusive surveys. The area has therefore been cordoned off and will be kept out of use, until the intrusive survey has been carried out. We also have initiated an investigation into the Council's wider portfolio which consists of 978 buildings, excluding schools. This investigation has so far consisted of a desktop exercise in partnership with building services and property services to identify which properties have an increased likelihood of containing RAAC, based on the information held on build dates and works carried out. This investigation has identified 5 properties which were built within the period RAAC was most widely used. These properties are to be surveyed over the next two weeks, in order to confirm the presence or absence of RAAC. These surveys are to be carried out by a partner contractor and will consist of the following: • An initial visit to understand areas which are required to be surveyed. • Assessment on any areas which are inaccessible where intrusive survey is required. • Plan to carry out intrusive survey safely including mitigations for risks such as asbestos or height. • Intrusive survey conducted. • Findings provided. The 5 properties identified for further investigation: • Canada Villa Young Peoples Activity Centre, Edgware Library, Family Resource Centre, Osidge Library - visual inspections

				carried out on 22nd Sep. Intrusive surveys scheduled. • Hendon Lane 24 – desktop survey carried out, and further site visit scheduled for confirmation of two small areas which are flat roofs.
10.	Cllr R Cornelius	Does the leader acknowledge that the heavy responsibility of granting Landlords consent for the Spires development will be a decision for him alone under the current constitution?	Leader	Very much so. Any change of use of the site to residential, and / or structural repairs (including demolition and redevelopment of the site) would both require landlord's consent. Legally however, these are not to be unreasonably withheld. So, in addition to carefully considering any such request for consent, legal advice will also be sought, in order for a properly informed decision to be made.
11.	Cllr David	Last week was National Hate Crime Awareness Week, which focuses on combatting hate crime and making it easier for victim of hate crime to report incidents. Will the Cabinet Member for Community Safety and Resident Participation engage with third party reporting organisations, such as Tell Mama, CST and Gallup to ensure we are doing all we can in Barnet to encorage the reporting of hate crime?	Cabinet member for Community Safety Participation	As part of Hate Crime Awareness Week, Barnet's Community Safety Team are attending several Hate Crime events across the brough during the week with popup hubs, to engage with and educate residents. We commission Barnet Mencap to deliver Barnet's Hate Crime Project and work closely with them and the police, including the Transport Police, all year round, with activities, promotion and educational events detailed in the annual Hate Crime report which is presented to the SCPB.
12.	Cllr Grocock	Please identify how many ANPR cameras are in the Borough and how many are currently online with those offline?	Cabinet member for Environment & Climate Change	There are currently 20 ANPR cameras in Barnet which are controlled and monitored by the Met Police.
13.	Cllr Ambe	Could the Leader advise Full Council on what progress has been made in ensuring Barnet Council is accredited	Leader	As we continue to see more employed residents needing extra support, we cannot reduce poverty without having a clear approach to becoming a living wage

		to the Living Wage Foundation in line with my proposed motion last year?		borough. As an employer Barnet council pays all our staff a living wage and has undertaken a review of our contracts confirming most of our contracts pay a living wage. For some of our contracts, implementing this has been more difficult and will take more time. This challenge is most prevalent within our adult social care contracts, which is an issue all local authorities and the wider care industry are grappling with. Officers are currently working with 3rd parties to ensure they all pay a living wage on contracts. We are therefore taking a long-term view on addressing this issue and will continue to work with the Living Wage Foundation and other local authorities on this issue. Barnet is committed to being a living wage borough, but we cannot achieve this alone. Therefore, as well as focusing on our own workforce contracts, we have started developing a plan to engage local businesses and anchor institutions.
14.	Cllr Longstaff	Since Labour's introduction of an £8 per hour charge to play tennis in our public parks, a big increase on the previously much lower price of free, I've not seen any parents and children playing tennis on a Saturday in Friary Park. There are no free times to play on a Saturday when families are most likely to want to play. Does the Cabinet Member consider this to be a successful outcome for families in the 'Borough of Fun'?	Cabinet member for Culture, Leisure, Arts & Sports	It is worth pointing out that before the introduction of charges there were already two council tennis courts that were already charging, as they had done under the previous administration. Many of the others were of poor quality that were not up to a requisite standard. You can give out free tennis racquets, but if they have broken strings, there is not much use in giving them out. So we faced a dillema on how to bring up council courts to a standard where they can be used at a time when there is real financial difficulty, having seen central government grants more than halved since 2010. We secured investment from the LTA to bring the courts up to a decent standard, and £1.2 million have been invested, on the condition they are kept to a good standard. The money has to come from somewhere. The Conservative Group does not like fees and charges in general. We need to keep council tax low. And we never want to go lightly into reserves. Cabinet member for Community Safety Participation	We are working with the Metropolitan Police's programme, called 'Clear, Hold, Build' (CHB), which has seen council officers and residents of Colindale's Grahame Park Estate working with the Police to identify issues, make arrests and clear it of those threatening the safety of residents. In just two months, the Police have made 160 arrests.  Current statistics show that Knife Crime in Barnet has reduced, which will be detailed at Safer Communities Partner Board. 17.	Cllr loannides	The Clear Hold Build Strategy is having a real impact on Colindale North - 160 arrests in eight weeks - including for suspicion of serious crimes from murder and grievous bodily harm to firearms possession and drug dealing - and residents feel far safer on the estate. I would like to ask the Cabinet Member for Community Safety and Resident Participation, after the initial wave of arrests, what are the next steps for the Clear Hold Build strategy and both in Grahame Park, and if we could see the approach used elsewhere.	Cabinet member for Community Safety Participation	The success of the Clear Hold Build Project in Barnet is being replicated across London. As the project is a police led operation, the next stages will be decided by the police in collaboration with council officers, who will have an integral part in the ongoing project, and relevant press releases will be issued when appropriate.
18.	Cllr Grover	Officers have been ignoring my emails over several months, so I raise a question here. The temporary parklets brought in during the lockdown period involved having agreements in place with all relevant businesses requiring them to take responsibility for the maintenance and upkeep of the space, including frequent sweeping, removing all litter, watering, maintaining, and replacing the plants provided. There are many examples of these agreements not being honoured by businesses —	Cabinet member for Environment & Climate Change	All businesses involved in the parklet programme were contacted as part of evaluation in October 2021 – 16 businesses responded (out of 23). The evaluation focussed on the impact of the parklet on the business (as the primary objective of the programme was to support small, high-street businesses during the COVID period). Questions included:  - Have the parklets benefitted your business - 15 strongly agreed / agreed, one felt neutral.  - Was the application process simple – 12 strongly agreed / agreed, 4 felt neutral or disagreed.  - Would you like to continue using the parklet in the future – All strongly agreed.  Other businesses feedback included:

including a few on Temple Fortune. I understand a review of all parklets took place last Spring to ensure that businesses are using them correctly and that the licenses and other requirements are in order. Please can the results of that review in relation to each parklet be published by way of answer to this question.

- "It was the difference between us reopening and closing after lockdown."
- "So many residents are still extremely concerned about sitting inside, now they don't have to worry."
- "Customers now have confidence in our business after COVID."
- "Really easy to maintain and attracts customers in."
- "We have had amazing feedback from customers."
- "The council has provided amazing support during COVID to help us reopen."

Neighbouring businesses were also interviewed. The results of these interviews showed:

- Most of the neighbours spoken to do not have outdoor space, and considered that there are still customers that are uncomfortable entering premises.
- Neighbouring businesses thought that parklets have had a negative impact on their customer numbers compared to competitors with parklets, although they were unable to substantiate this.
- Businesses were supportive of parklets and their impact on the aesthetic of the high street.
- Some noted that customers have complained about not being able to park but they acknowledge parklets have limited impact on this.

A subsequent analysis of parking data showed that the parklets had not impacted the availability of parking, however. The evaluation concluded with the following recommendations for improving the parklets:

- Increase the opportunities for greening.
- Improve the height and depth of parklets to reduce traffic noise and improve safety.
- Consider options to provide shelter from rain and sun.
- Support access to electrical points to for heaters and lighting in colder seasons
- Bring level with pavement to enable access for all customers.

The council is commissioning a second evaluation of the parklet programme, which we anticipate concluding on the week commencing 11th December. This

				evaluation will review the challenges around maintenance, amongst other issues, to understand whether some businesses are not complying with this part of their agreement, and the changes that need to be made to the programme going forwards. Whilst the programme is giving important support to local businesses, high streets and town centres at a challenging time, we should look at improvements that could be made.
19.	Cllr Whysall	We know that the previous Conservative administration put together a Local Plan that lacked controls, risking situations like the Edgware development which has caused real upset in the community. Can the administration give an update on the Labour administration's application to the Department for Levelling Up, Housing and Communities to modify the Local Plan, and what we may do if they refuse amendments.	Cabinet member for Housing & Regeneration	We are committed to progressing with the Local Plan we inherited or risk not having a development framework for Barnet to influence proposals such as the Ballymore/TfL regeneration scheme in Edgware. We are working with officers to submit further modifications to the Plan via the Government's appointed Inspector, but it is important to remember, that under the current planning system, the Local Plan is subject to a Department for Levelling Up, Housing and Communities Inspector led examination. Any modifications we propose will now need to be agreed by the Inspector. The Local Plan and the Edgware Growth SPD set only a broad strategy for regeneration, so it will be through the planning aplication that the Council will assess the scheme's appropriateness.
20.	Cllr Longstaff	Will the Cabinet Member continue his robust and misplaced support for Transport for London over Barnet residents, in TfL's desire to introduce bus lanes between Wood Street and Meadway in Chipping Barnet, that no residents have asked for, but will increase traffic congestion?	Cabinet member for Environment & Climate Change	It is critical we give Barnet residents transport choices. Reliable buses not only provide a means of transport for those who don't own a car, are looking to save on petrol bills or not worry about parking, but they can also can enable up to 80 people not to have to drive thier cars, easing congestion for when residents do decide to take thier car. Along Barnet High Street (between Wood Street and Meadway) there are almost 7,000 passengers getting on and off buses, many of which are facing delays. We want to take the side of Barnet residents, and ensure that people have a genuine choice between public and private transport. This also supports our Net Zero commitments - cars are responsible for 65% of Barnet's transport-related carbon emissions, buses for 4%. Bus priority measures are part of making using the bus is a practical option.

21.	Cllr Khalick	Can I ask the Leader to thank the Visit my Mosque initiative, building links the the Muslim community and society, and share his reflections on the day.	Leader	I am very happy to express my thanks to the Visit My Mosque initiative. Visit my Mosque is a great initiative and an excellent opportunity to get to know the community. I want to make sure that next year as many councillors as possible participate in the programme.
22.	Cllr Grover	Damage to the wall around a tree on Finchley Road, outside the offices of the Hampstead Garden Suburb Trust, were reported for repair via Members Enquiries in May. Since then, despite multiple reminders, nothing has been done and no timeframe has been given. Please confirm: (a) that the Council intends to make this repair (b) if so - when? (c) if not, why not?	Cabinet member for Environment & Climate Change	This issue is part of the wider review for Temple Fortune between Addison Way and Willifield Way. The wall around the tree is included within the design and will be repaired as part of the scheme. A site meeting is planned for 31 October 2023 to review this location and arrange a date for the permanent repair.
23.	CIIr Innocenti	There appears to be a problem in my ward of Childs Hill with the misuse of resident parking permits, which may be being used as business parking permits. Would the Cabinet Member for Environment and Climate Change look into whether this is a problem in the wider brough and what can be done about it?	Cabinet member for Environment & Climate Change	Residents are able to purchase vouchers for the use of visitors. When validated, these vouchers are valid in applicable bays throughout the zone for which they are issued. Reports of misuse of paper resident visitor vouchers are investigated jointly by the council's parking team and the Corporate Anti-Fraud Team (CAFT) to identify whether there is any evidence of misuse and appropriate action. If a voucher is not used according to the conditions of use it may be invalid and a Penalty Charge Notice may be issued. I do understand that residents are worried about a particular problem in Childs Hill and I would be happy to continue the discussion with Cllr Innocenti and ask officers to investigate.
24.	Cllr Grover	As of the 15th of September, Barnet's web pages regarding the East Area Committee confirm that the Committee will 'Consider petitions which receive between 25 and 6,999	Leader	The rules relating to petitions changed on 23 May 2023. Prior to the changes, petitions with 25 – 500 signatures which related to the functions of an Area Committee were reported there for consideration. Following the changes, petitions within that threshold now have a written response from the Cabinet Member only and are no longer reported to the relevant Area Committee. In July

		signatures relating to the functions and responsibilities of the Area Committee.' A group of residents in Garden Suburb submitted a petition in July that received over 25 signatures. Following this I checked with the relevant Governance officer who confirmed that it would be brought before the East Area Committee on 19 September. It wasn't - instead I was informed, 4 days before the Committee meeting, that as the petition achieved less than 500 signatures it would not be brought before the Committee. Why is the website misleading our residents?		an officer from the Governance Team incorrectly advised the Lead Petitioner that the petition would be reported to the East Area Committee when in fact it should have been referred to the relevant Cabinet Member for response. It was also identified that some of the web pages linked to the Area Committees still included the previous petition arrangements. The incorrect webpages have now been updated. The petition has now been responded to by the Cabinet Member and the Lead Petitioner has been informed of the response. Officers in the Governance Team have been briefed on the new arrangements relating to petitions to ensure such issues do not reoccur.
25.	Cllr Young	The Golders Green Town Centre Strategy was approved in 2020 by the previous Conservative Administration. On page 37 of the strategy it sets out a priority action to be delivered in the first two years of the strategy to be the introduction of 'Trial vehicle access restriction into Golders Green Crescent Junction to create new temporary public amenity space. There is a strong message from residents on accessibility and travel. The survey indicates that older residents perceive their ability to access the borough's outdoor spaces declines as they age, and female respondents highlighted the availability of public toilets. This is already a key priority and something we will be looking at addressing with partners. Ease of accessing public transport also diminished and was a theme of discussions of the focus groups, which highlights that public transport can do more to be age friendly. There are also some stark differences between male and female respondents, and between white and black, Asian and minority ethnic respondents on their perception of employability. We also recognise that our oldest residents reported concerns regarding ease of access to local health services and a lack of confidence with digital technology. The council has a valuable role in acting as an advocate and driver of change with our partners in response to these messages. We can see ahead of us work with Transport for London on making public transport more accessible and age friendly (example of training bus drivers to move off more slowly and brake carefully). As it currently stands, MMR uptake in Barnet is at 77% (this is uptake of a 2 <sup>nd</sup> dose among 5 years old), the highest in North Central London but still far from WHO recommended coverage of 95%.  We have been running a Community Vaccine Champion (CVC) programme for the last 18 months, working with voluntary and community sector grantees. Health Ambassadors from the CVC programme continue to engage with their communities to dispel vaccine myths, increase vaccine uptake and improve health outcomes.  Funding has been extended for three specific community groups where immunisation uptake remains low: the Somali group Centre of Excellence, Belifted – working with young children, and the Romanian Eastern European Hub. We also have ongoing work to increase vaccination uptake amongst Orthodox Jewish Communities and are working closely in collaboration with London Jewish Health Partnership to develop communications strategies. A Public Health Measles letter was sent to parents before schools broke up for summer holidays and a follow-up letter to parents and headteachers on return to school, in September. This letter has been translated to 7 different languages. We will deliver a Health protection webinar for schools mid- October . In addition, a

				communication toolkit will be sent to further education settings to promote vaccination uptake of MMR, MenACWY and HPV.  NCL NHS ICB and the school immunisation team are gathering data to identify the 20 primary schools with lowest vaccination rates.
