1.	Cllr Thomas	What efforts has the Leader made to assist the council recover monies owed by NHS?	Leader	<p>Officers are holding fortnightly meetings with finance colleagues from the North Central London Integrated Care System Integrated Care Board – NCLICS - and escalating any disputes with relevant services. The council has settled a considerable number of queries and arranged a payment plan. Barnet Council’s CEO John Hooton has written to the NCLICS CEO to escalate where disputes or still outstanding. CFOs across NCLICS boroughs are discussing the ongoing difficulties and agreeing positions regarding the release of funds flowing to the NCLICS pending the settlement of ICB debts outstanding.</p> <p>The Leader and the Cabinet member for Health and Wellbeing have been supporting officers in recouping this money and will continue to use every opportunity to raise this issue.</p>
2.	Cllr Wakeley	What’s the progress with the CPO on the Railway Hotel in Edgware?	Cabinet member for Housing & Regeneration	<p>The Estates and Place teams are currently working with the planning enforcement team, who have served a number of planning related notices and have been pursuing prosecutions that seek to protect, secure, and repair this heritage asset since 2019. These have included:</p> <ul style="list-style-type: none"> <li>• An Urgent Works notice that requires the owner to make repairs which prevent further damage.</li> <li>• When the owner did not carry out all works under the notice, the council carried it out and is looking to recoup costs.</li> <li>• An Untidy Land Notice which obligates owners to clear fly tipping</li> <li>• When this was ignored, the council prosecuted leading to £8,000 in fines</li> <li>• Two Repairs Notices</li> </ul> <p>Considering recent changes in legislation (Levelling-up and Regeneration Act 2023) the teams are considering options and exploring the case for the potential</p>

3.	Cllr Greenspan	Countless residents have emailed councillors about the sorry state of pavement slabs across the borough and the danger they cause. I was one of those residents who had been sent to the hospital after tripping on a loose pavement slab. Will the cabinet member please inform residents of their rights and paths to compensation for injuries caused by loose pavement slabs and the steps the council is taking to rectify these?	Cabinet member for Environment & Climate Change	<p>The Highways Inspection Team also undertake cyclical inspections across all roads within the borough, these cyclical inspections are either annually, biannually, quarterly, or monthly depending on location. The team will undertake ad hoc inspections outside of the cyclical inspection upon receipt of resident/member enquiries. The ad hoc inspection is for specific locations as reported and may result in a work order should the defect reach the council's investigatory level.</p> <p>Council Investment in footways has increased from £2.6 million in 2021/22 to £3.4 million in 2023/4 and will be at £3.4 million for 2024/5</p> <p>Residents can make insurance claims, via email, to <a href="mailto:insurance@barnet.gov.uk">insurance@barnet.gov.uk</a> or in writing to:  Insurance Section  London Borough of Barnet  2 Bristol Avenue  Colindale  London NW9 4EW</p>
4.	Cllr Longstaff	The Labour manifesto is full of comments about helping residents and businesses as much as possible with the cost of living. Please explain how ending the annual Christmas Free Parking at weekends helped residents and businesses.	Cabinet member for Environment & Climate Change	We want as many people as possible to visit Barnet's town centres, particularly during the festive period. We therefore offered half price parking at weekends in the run up to Christmas. This encouraged the turnover of vehicles, and I was pleased to see that our car parks and on street parking spaces were being well used. For the first time, we also offered free Dr Bike safety checks in car parks over the same period. These were popular and helped to encourage cyclists to visit our town centres and be able to cycle safely.

5.	Cllr Mittra	Was the local government funding settlement adequate and fair for the people of Barnet?	Leader	<p>The general view is that the local government funding settlement was not fair for many councils. A cross party group of councils, SIGOMA, reacted to the settlement by noting that half of the increased funding provided to cope with the post Liz Truss inflation depended on local authorities raising their council tax by the maximum allowed without a referendum. It added: "There is nothing new to address the funding pressures in children's services, the biggest pressure our members currently face. Council finances will remain on a knife-edge until funding levels are returned to a sustainable level and the distribution is fairer, fully recognising need. The final settlement in late January is now the Government's last opportunity to provide councils with the funding and flexibility they need to stabilise their finances. If this is not done, then there will be a surge of Section 114s next year.". We are ensuring that Barnet is on a long-term sustainable footing but clear what the Governments intend for our residents – cut services and maximum tax increases at a time of a cost-of-living crisis.</p>
6.	Cllr Greenspan	Many of us called for the council to host an event to support the hostages kidnapped from their homes on 7 <sup>th</sup> October. Many residents have contacted me asking why the council did not do this. Will the cabinet member publicly explain why this was the case and why any show of solidarity could not have taken place?	Cabinet member for Community Safety & Participation	<p>The Council showed its support for the victims and hostages of the attack on 7 October by flying the Israeli flag from Hendon Town Hall and illuminating the building in blue, followed by a minute's silence at Full Council and other council events. We are twinned with the Israeli town of Ramat-Gan and a letter of support was sent to its Mayor, Carmel Shama.</p> <p>In terms of practical help, we have been listening to the community to ensure people are properly supported, including a 60-person roundtable discussion. Councillor have been attending community vigils and synagogue services for Kidnap victims, supporting community-led events.</p>
7.	Cllr Monasterio	Is the Council Leader aware of the assessment of the Government's latest settlement for Local Government by the chair of the cross-party Local Government Association,	Leader	<p>Yes, I am. The full quotation from Cllr Davies is that the 'settlement does not provide enough funding to meet the severe cost and demand pressures which have left councils of all political colours and types warning of the serious challenges they face to set balanced budgets next year. Councils in England continue to face a funding gap of £4 billion over the next two years as today's</p>

		Shaun Davies, which he referred to as 'unthinkable' and that "No council is now immune to the growing risk to their financial sustainability."? How would you assess the Government's approach to supporting local government?		<p>announcement does not change the funding gap facing councils this year and next.</p> <p>"It is therefore unthinkable that government has not provided desperately needed new funding for local services in 2024/25. Although councils are working hard to reduce costs where possible, this means the local services our communities rely on every day are now exposed to further cuts."</p> <p>I think that Cllr Davies' description of the Government's approach to local government funding as 'unthinkable' is a very good one.</p>
8.	Cllr Grocock	During a members' briefing, Cllr Conway said that our CCTVs could pick up sound then in a subsequent meeting said they did not. Can we have some clarification on the ability of these cameras to pick up sound?	Cabinet member for Community Safety & Participation	Public Space CCTV would not be permitted to 'pick up sound' as this would constitute directed communications surveillance. We are currently in the process of installing a public address system in libraries which will allow a CCTV operator to announce / address issues. We are actively looking at the possibility of a similar system in the public realm spaces. This is what was being outlined during the members' briefing.
9.	Cllr P. Cohen	Has the Council Leader seen the reaction of to the Local Government Settlement by Cllr Barry Lewis, Finance lead for the County Council Network and Conservative Leader of Derbyshire County Council who said that the Government's decision was 'bitterly disappointing' and that 'councils will have no choice but to implement more severe reductions to services.' What kinds of impacts will	Leader	<p>I have. Let me share more fully what Cllr Lewis said:</p> <p>"The announcement of the Provisional Local Government Finance Settlement is bitterly disappointing ... With no additional funding announced, our councils will have no choice but to implement more severe reductions to services and to levy higher council tax rises. This will undoubtedly be a double whammy for residents during a cost-of-living crisis, while an increasing number of local authorities will struggle to deliver a balanced budget next year".</p> <p>Yes, there will be impacts on Barnet, cuts made that we do not want to cut. But we will do so in a way that is fair to all Barnet residents.</p>

Cllr Longstaff	One of the major issues affecting Barnet residents is anti-social behaviour, what impact does the cabinet member think a reduction in the number of CST officers will have on the perception of safety in Barnet Vale and across Barnet?	Cabinet member for Community Safety & Participation	<p>The Metropolitan Police estimate that it needs £250 million more from central government to do its job properly and that is having an impact on us in Barnet.</p> <p>We have taken several measures to make residents feel safer:</p> <ul style="list-style-type: none"> <li>• Having inherited a CCTV system where around 2/3<sup>rd</sup>s of cameras were broken, we have replaced with a state-of-the-art CCTV system where cameras are fixed promptly.</li> <li>• Ward Walks and Community Safety Hubs mean that residents have more ways to identify problems to the Council and the Police</li> <li>• Our Public Safety Protection Order means anti-social behaviour can be reported in any public area.</li> </ul> <p>However, given the situation the Government has left us with, we are going to have to make efficiencies which residents may notice.</p>
11.	Cllr Zubairi	The Conservative Leader of Surrey County Council has described the latest Government local Government settlement as 'worse than austerity'. Can the Leader explain why Rishi Sunak's Government is continuing this discredited policy, which has failed Barnet residents so badly?	Leader	<p>It is beyond understanding that the Government continues to hammer councils. Potentially in the early years of the Conservative Government it was believed that this was a way of delivering cuts that would not go noticed. Not, only do people notice when local services suffer, but there is a cost shunt to the NHS, schools and other services. It is worth repeating what the Conservative Leader of Surrey County Council, Tim Oliver, described the Government's financial plans like this:</p> <p>"The failure to address these severe pressures in the Autumn Statement will be deeply disappointing. This mounting tide of costs is threatening the financial sustainability of high performing councils across the country, with many now likely to have to make cuts and reductions to local services in order to balance their budget."</p>

				If this is what Conservative Council leaders are saying, we can see the scale of the Government's failure.
12.	Cllr Grocock	At Overview and Scrutiny, questions were raised as to the impact of the borough's well-publicised 'Clear, Hold, Build' on creating displacement of crime from the Colindale areas to other parts of the borough. Members received reassurance that this would be looked into. Can the cabinet member update us on that inquiry?	Cabinet member for Community Safety & Participation	Police react to all incidents of crime across the borough. The CHB program acknowledged that displacement of crime could take place and as such sufficient police resource would be available to tackle the effects. We do not believe there has been significant displacement. We can confirm there was police resourcing available and it was deployed to manage this. We continue to monitor vulnerable areas with patrols, CCTV and other intelligence. It is therefore important to continue to encourage the public to report to police any incidents of crime they encounter.
13.	Cllr Radford	The Institute of Government described the Governments latest budget - starving public services including local government and neglecting to reduce the deficit while implementing politically driven tax cuts as "a bad way to conduct policy - good news is spent, bad news is swallowed, and debt is ratcheted up over time." How can we choose a different path to Conservative chaos in Barnet?	Leader	<p>Let me share the Institute of Government's assessment of how the Government has spent its apparent windfall driven by inflation, that really needs to be spent on increased costs to public services:</p> <p>"Rather than allow his headroom to increase he chose to spend virtually all of it, predominantly on two large tax cuts. This stands in contrast to his approach last November, when forecasts worsened but he did not offset all of the underlying forecast change with a policy tightening. Such asymmetric behaviour leads to debt ratcheting up over time, as good news is spent, and bad news swallowed. This is a bad way to conduct policy – especially when forecasts are so uncertain."</p> <p>Such a reckless approach to economics shows that the Conservative Government still follows the erratic Liz Truss approach to economics. Here in Barnet, we are going to make difficult choices, but also invest in the future to bring down costs in the long term, from building more social housing and bringing children's services in house.</p>
14.	Cllr Shooter	Why has crime risen by 50 per cent year on year in Hendon according to	Cabinet member for	This statistic is not recognised. Our crime figures suggest that from December 2022 to November 2023, crime increased by 6.45% compared to the previous 12

Community Safety & Participation	<p>months.</p> <p>From December 2021 to November 2022 increased by 6.11% compared to the previous 12 months.</p> <p>From December 2020 to November 2021 decreased by 0.85% compared to the previous 12 months.</p> <p>There has been a regrettable significant increase in hate crime reporting since October resulting from events in the Middle East. This continues to generate crime reports adding to an increase in overall crime reporting. Weekly Police hate crime reporting is shared with council officials and appropriate lead and shadow members for crime.</p> <p>I would like to thank all the police, community organisations and council officers who continue to work so hard on community safety at this particularly challenging time. Cabinet member for Family Friendly Barnet	Yes, I do, which is why I am very pleased to see the motion calling on political parties nationally to move against excess profiteering on placements for vulnerable young people. The fact that hedge funds are now making profits in this area is a scandal.

18.	Cllr R Cornelius	Is the bid for Borough of Culture a vanity project that will be regretted as the deterioration in the council's budget becomes more apparent.	Cabinet Member for Culture, Leisure, Arts and Sports	<p>Nine boroughs are currently bidding to be London Borough of Culture. There is no reason why the ambitions for Barnet should be lower than that of Havering, or Wandsworth or Greenwich.</p> <p>Barnet residents agree with 82 per cent backing the bid and 90 per cent saying they wanted to see more cultural activities in the borough. Winning the bid would bring £1.35 million in funding. Putting the bid together has helped drive our five-year culture strategy.</p> <p>Previous winners have seen an influx of cultural facilities like theatres into their boroughs and millions add to the local economy. Culture increases local pride, and we think we should be proud of Barnet.</p>
19.	Cllr Whysall	Would the cabinet member for Culture, Leisure, Arts and Sport join me in congratulating all the volunteers who organised the Barnet Fayre in December?	Cabinet Member for Culture, Leisure, Arts and Sports	<p>The Barnet Fayre, held in December is one of many events hosted throughout the year that takes place in our parks and town centres. I know that for many residents it is a regular fixture of their festive calendar.</p> <p>Much like many of our community festivals, it is organised by a group of dedicated volunteers who have been supporting to deliver this event for over 20 years. I congratulate them on putting on such a great event year after year, really helping make Christmas in Barnet.</p> <p>We hope that the Barnet Fayre will return in 2024, alongside many other events for residents to attend.</p>

Can I ask whether the written response has been sent, and for the response to be made public?</p>	<p>Cabinet member for Environment &amp; Climate Change</p>	<p>A written response was provided on 28 November directly to the requestor on behalf of Cllr Schneiderman as below .</p> <p>Further to the deputation to Council of 17 October 2023 and the aligned resolution I am taking this opportunity to write to you with regard to the next steps in relation to the implementation of 20 mph zones within the Borough.</p> <p>By way of context the administration through the May 2022 elections introduced a manifesto pledge of May 2022, which stated: ‘We will introduce 20mph zones where residents want them’.</p> <p>At the council meeting on 1 November 2022 a motion was passed setting out the approach the administration intends to take: Council notes that: 1. The LB Barnet Labour administration has a policy of agreeing 20mph zones on roads where a majority of residents support this. Council believes that: 1. Varied speed limits should be left in where residents want them. 2. 20mph zones can serve a good purpose in certain localities, for example, outside schools. 3. Speed limits should be based on evidence. Council resolves to: 1. Commit to listening to residents and only introduce 20 mph zones where residents want them.</p> <p>The Council intends to approach the issue by putting in place a borough-wide policy setting out the principles and parameters for local implementation, both to provide a consistent basis for assessment of proposals as well as setting out a defined approach for how residents and neighbourhoods can apply for their area to be considered for designation as a 20 mph zone.</p> <p>The work to develop this borough-wide policy is currently being commissioned</p>

The station has drawn a significant amount of media interest and the reception to date has been overwhelmingly positive.</p> <p>Delivering Brent Cross West has been a long-standing goal of the council and plays a fundamental role enabling the comprehensive redevelopment of the area. We can already see the benefits materialising, with nearly 1,000 new homes under construction around the new station. Over 20,000 new jobs are expected to be created in the area over the coming years.</p> <p>We look forward to more success on the project later this year with the first new residential plots completing in early Autumn, as well as the start of works on the first new office plot.</p>

Cabinet Member for Culture, Leisure, Arts and Sports	<p>The bid was submitted on 30 November 2023 and the result will be announced in March.</p> <p>All shortlisted boroughs have been invited to an interview. Barnet has been notified that our interview will take place at City Hall on Wednesday 7 February, where the Lead Member for Culture, Leisure, Arts and Sport will be accompanied by culture officers, members of the bid writing team and a representative from the local arts sector.</p> <p>The final decision will be made on the basis of that interview.</p>

Cllr Wakeley	Can the Leader explain why it took hundreds of litres of high-pressured water to clean off the paint that this council left on the street during the festival of architecture in Edgware, why there was a complete breakdown of communication between the Town Centre team and the street cleaning crew and how much it cost to attempt to clean up the mess that was created (which has still not been cleaned up)?	Leader	<p>Local artists were engaged in this project in Garden City, so they could develop their experience and build their capacity through delivering a project.</p> <p>The project underwent risk assessment and governance within the planning and delivery stages including ensuring sustainability, quality and durability of materials. The paint selected for use in Garden City was used according to the specification which fit this brief in consultation with the supplier. The paint selected was water based so it could be removed without the use of chemicals.</p> <p>Communication was clear between Town Teams and Street Cleansing Teams and included prompt action over email and collective in person site visits to tackle the remainder of the paint and resolve the issue as quickly as possible. The overall cost for the removal of the paint onsite amounted to £1,150.</p> <p>To achieve the colour result for the design, more paint was applied resulting in more vigorous jet washing to remove than originally anticipated.</p>

49.	Cllr Perlberg	Why is the council installing JOLT electric vehicle charge points in the borough's town centres?	Cabinet member for Environment & Climate Change	<p>In order for the Council to provide fit for purpose Electric Vehicle (EV) charging infrastructure various solutions are required to suit the differing needs of EV drivers. This ranges from providing chargers that are suitable for longer dwell times such as overnight in residential streets, those that are suitable for dwell times of between half hour and three hours such as Town Centres and Car Park stays and those where dwell times will be very short such as those travelling to a destination and needing a quick top up charge.</p> <p>Following a successful grant funding submission to the Office for Zero Emissions Vehicles (OZEV) by the Council, JOLT was appointed to undertake installations of 25kW/DC fast charge points across the borough. These units are ideal for providing the half hour to three-hour charge time requirement.</p> <p>So far, six of the Jolt charge points have been installed with the first one becoming operational at the end of October 2023. They are already proving to be very popular with over 700 charging events having occurred so far with over 12,000KWhrs of charging taking place.</p> <p>The chargers were being actively used within an hour of being commissioned and positive feedback has been received from users, most of which are Barnet residents. EV drivers particularly like the initial free charging period which is available daily for registered users. The free charging period is possible due to a subsidy from the advertising income and saves the average EV driver around £800 a year. This will provide a user around 30 miles of range daily.</p>

				<p>This free EV charging has proven, in other markets, to bring shoppers to a location where a charge point is installed – a JOLT survey indicated that over 55% of drivers using a charging point visit local shops as they wait for their vehicle to charge.</p> <p>The Council has also worked with Jolt to make arrangements for unused advertising space to be donated to local businesses, further supporting economic development in the areas where the charge points are located.</p>

Cabinet member for Community Safety & Participation	<p>During the clear phase there were 528 offences identified resulting in 311 arrests since the 1st of September 2023. 44 Offensive weapons were recovered, there were 60 arrests in relation to Supply of class A drugs and Possession with intent to supply Class A drugs. 55KG of class A drugs were seized. £30,000 cash seized. Going forward the CHB partnership approach will see the lead gradually shifting towards the local authority working in partnership with the police and local community organisations. Residents of Stanhope House and Holmsdale House were told about the two options being considered, to either remediate or redevelop the blocks. They were asked which option they preferred. The decision to redevelop the blocks was strongly supported by the feedback received from residents.</p> <p>Following the Cabinet decision, the residents of Stanhope and Holmsdale House were sent a letter letting them know that the decision had been made and that the option to redevelop the blocks had been approved. Passenger numbers will be shared with the council by GTR (the train operator) on a regular basis.</p>

Cabinet member for Environment & Climate Change	<p>The East Finchley CPZ will be implemented using Experimental Traffic Management Orders (ETMOs). The design of each zone and subsequent ETMO are based on the outcome of informal engagements with residents, community organisations, businesses, and ward members of the proposed area.</p> <p>ETMO's can stay in force for up to a maximum of 18 months while the effects are monitored and assessed. The Council welcomes feedback throughout the process, however the first six-months from the orders coming into force is the statutory consultation period in which stakeholders can make representations.</p> <p>The council must consider these responses. If changes to the zone design and scope are made there is a requirement to start the six months consultation period again to allow for further representations to be made. Depending on the nature of the changes this further consultation may relate to the whole or part of the scheme.</p>

Cabinet member for Community Safety & Participation	<p>It is essential that the council listens and responds to residents, and we have a host of mechanisms by which we do that. There are service specific feedback loops like My Say Matters where children and young people in the borough can tell us how they think we are doing that can help shape our policy.</p> <p>We are increasingly using co-production to develop strategies and policies with residents and community groups, like, for example, with the emerging culture strategy. We are updating the Resident Perception Surveys (field research is underway now) and have introduced new approaches such as the Citizen’s Panel, where over 1,000 residents have been recruited to participate in surveys on particular issues, proposals or pieces of work.</p> <p>Through the Resident Experience programme we have implemented a new telephony solution, improving responsiveness whilst enabling a more secure and resilient solution. Callers can now be proactively routed, if they are calling back about the same issue or require more support if the resident need is more complex.</p> <p>Improved data also supports continuous improvement reducing failure demand so resources can be more responsive in supporting residents who need it most. Automated texts can be prompted to signpost residents to relevant information or services, such as digital inclusion &amp; wellbeing support.</p> <p>More than 100 residents have been involved in the design and implementation of these (and other) improvements responding to what matters most to our residents, when improving services. As an example of this, residents have been involved in a re-design of the Council website, with changes going live over the</p>

				<p>coming months.</p> <p>A digital inclusion action plan is in place offering increased access to training, devices, broadband services and data packages being distributed to residents. In October 2023, 25 specific events were run to support residents get online and raise awareness of the support available.</p> <p>A new British Sign Language (BSL) service has been introduced to support residents who are deaf or hard of hearing and a new tool has been added to the website to support residents who have visual impairments, English as a second language or other residents who encounter barriers when trying to read and understand content online.</p>

As of December 2023, we have now secured funding to develop a planning application for the site, ahead of doing so we are in the process of concluding the governance arrangements to the Investment Partnership and expect to start mobilising (preparing a design/consulting) by the end of February.</p>
