The Lead Petitioner presented the petition and outlined the accidents and near-misses which have taken place because of cars turning too quickly into Tithe Walk from the A1. The Panel talked in depth about how these problems might be resolved, however it was noted that the responsibility for the A1 lies with Transport for London (TfL), rather than the Council. Officers noted that the Council could collect data (for example vehicle

counts and speeds) and present the results to TfL to encourage them to undertake any necessary modelling on the A1/Tithe Walk, and that this would require funding from the Area Committee.

RESOLVED – That the petition be referred to the Hendon Area Committee to consider undertaking any necessary surveys to encourage TfL to resolve the problems highlighted on the A1/Tithe Walk.
