1. MINUTES OF LAST MEETING

The Chair of the East Area Committee, Councillor Danny Rich welcomed all attendees to the meeting.

It was **RESOLVED** that the minutes of the previous meeting of the East Area Committee held on 24 October 2022 be agreed as a correct record.

2. ABSENCE OF MEMBERS (IF ANY)

3. DECLARATION OF MEMBERS' DISCLOSABLE PECUNIARY INTERESTS AND OTHER INTERESTS (IF ANY)

Councillor Dean Cohen declared an interest (non-pecuniary) in relation to agenda item 6 (Neville Drive Parking petition) by virtue of knowing the lead petitioner.

Councillor Arjun Mitra declared an interest (non-pecuniary) in relation to agenda item 10 (NCIL Member's item Halliwick Recreation Ground) by virtue of being school governor to neighbouring school.

4. REPORT OF THE MONITORING OFFICER (IF ANY)

5. PUBLIC COMMENTS AND QUESTIONS (IF ANY)

6. PETITIONS (IF ANY)

The Chair noted that four petitions were received which were considered in turn.

a) Petition: Parking in Neville Drive

The lead petitioner, Sandra Teacher presented the petition and outlined the issues. The Committee welcomed the item and Officers agreed to conduct a site visit to explore the options.

It was RESOLVED that the matter be referred to a chief officer to provide a written response to the lead petitioner within 20 working days.

- b) Petition: Stop proposed perimeter path on Lyttleton Playing Fields

The Committee noted the matter outlined in the petition. In order to provide clarification, Councillor Grover informed the Committee that no such proposal has been made as referred in the petition and the Council is not aware of such proposal being made.

It was RESOLVED that the Committee noted the petition and the information provided during the meeting as set out above and that no further action is taken.

- c) Petition: Include Ravensdale Avenue and Friern Watch Avenue in Friary Park traffic plans

The lead petitioner, Tony Allaway presented the petition and outlined the issues.

It was RESOLVED that the matter be referred to a chief officer to provide a written response to the lead petitioner within 20 working days.

- d) Petition: Parking in N11 - Oakleigh Rd South/Brunswick Park Road and adjoining roads

Councillor Paul Lemon spoke on behalf of the lead petitioner and outlined the issues as set out in the petition.

It was RESOLVED that the matter be referred to a chief officer to provide a written response to the lead petitioner within 20 working days.

7. RESIDENTS' ISSUES (IF ANY)

The Committee noted the submitted residents' issue and the written response which was published and circulated.

- a) Issue: Road prioritisation Ballards Lane (West Finchley Ward)

Elizabeth Wan presented the issue to the Committee.

It was RESOLVED that the Committee, having noted the issue and the written response, decided:

- **that an appropriate named officer contact the resident within 20 working days to provide an additional response and that this response be published in the meeting documents available on the website.**

8. AREA COMMITTEE FUNDING - NEIGHBOURHOOD COMMUNITY INFRASTRUCTURE LEVY (CIL) & ROAD SAFETY AND PARKING FUND UPDATE

The Chair welcomed the report which sets out the CIL budget and Road Safety & Parking budget allocations for the East Area Committee and the status of current schemes.

It was RESOLVED:

10. MEMBERS' ITEMS - AREA COMMITTEE FUNDING APPLICATIONS (IF ANY)

The Chair noted that each NCIL application would be considered in turn.

a) Councillor Anne Hutton – Summerside Primary Academy

Councillor Anne Hutton presented the application. The Committee welcomed speakers from Summerside Primary School who spoke in relation to the application and provided the Committee with information about the benefits of the scheme.

It was RESOLVED that the Committee having considered the application decided to award funding fully for £58,577.05 and any conditions attached noting the implications to the Committee's NCIL funding budget.

b) Councillor Paul Lemon – Brunswick Park – Playing Facilities

Councillor Paul Lemon presented the application.

It was RESOLVED that the Committee having considered the application decided to award funding fully for £35,000 and any conditions attached noting the implications to the Committee's NCIL funding budget.

- c) Councillor Pauline Coakley Webb – Halliwick Recreation Ground – environmental project

Councillor Pauline Coakley Webb presented the application. The Committee welcomed the Chair of the Friends of Halliwick Recreation Ground who spoke about the scheme and its benefits.

It was RESOLVED that the Committee having considered the application decided to award funding fully for £ 50,000 and any conditions attached noting the implications to the Committee’s NCIL funding budget.

- d) Councillor Daniel Thomas – St Mary at Finchley improvements

Councillor Daniel Thomas presented the application. The Committee heard from guest speaker who spoke about the partnership working with Barnet Mencap.

It was RESOLVED that the Committee having considered the application decided to award funding partially for £100,000 and any conditions attached noting the implications to the Committee’s NCIL funding budget.

- e) Councillor Arjun Mittra – Warm Hub for Green Man

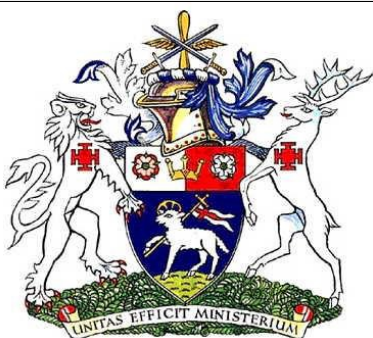

It was RESOLVED that the Committee having considered the application decided to award funding fully up to the requested amount £15,260 and subject to compliance with financial audit and CIL funding requirements and any required due diligence - noting the implications to the Committee’s NCIL funding budget.

The Chair invited Officers to provide an update on the previously considered petition (Improvements to the Underpass between Trinity and Manor Park Road East Finchley Underpass). 1. WHY THIS REPORT IS NEEDED

- 1.1 The following petitions from Barnet residents have been received prior to the deadline for submission of petitions.

1.	<p>Petition: Additional controlled parking restrictions on Sat and Sun betw. 6-8PM St Georges Road</p> <p>Lead Petitioner: Michael Joubert</p> <p>Ward: Golders Green</p> <p>Number of signatures: 40</p> <p>Details:</p> <p>We the undersigned petition the council to Petition to introduce additional controlled parking on Saturday and Sunday evenings between 6pm and 8pm on St Georges Road.</p> <p>We request that Barnet Council introduce additional controlled parking restrictions in the existing controlled parking zone (CPZ “H” zone) in the early evening at weekends to enable residents to park on St Georges Road and surrounding roads more easily.</p> <p>The “party venue” at the old Sorting Office has resulted in a significant problem for residents trying to park on the road and we believe that adding additional CPZ times will ensure residents can park more easily.</p> <p>The suggested additional zone would apply on Saturday and Sunday evenings between 6pm and 8pm which appear to be the peak days / times for party guests parking and when residents struggle to find parking.</p> <p>The additional zone should then be reviewed at a later date to assess the effectiveness of the change.</p> <p>The congestion caused by the party events at the Old Sorting Office St Georges Road, in the area between Finchley Road and Templars Avenue are an additional safety concern. We request that the Council review the cross-road junctions where St Georges Road meets Temple Gardens and Templars Avenue (close to the party venue) as the constant cars reversing / cars turning / cars parked illegally at the junctions / cars speeding creates a dangerous situation for both pedestrians and drivers.</p>
2.	<p>Petition: Increase the Residents CPZ Hours on Temple Fortune Lane NW11</p> <p>Lead Petitioner: Rebecca Sudwarts</p>

	<p>Ward: Golders Green</p> <p>Number of signatures: 40</p> <p>Details:</p> <p>We the undersigned petition the council to increase the Residents parking hours to ensure that residents can park easier and safer.</p> <p>The road is extremely busy and it is often impossible to be able to park outside our houses due to heavy parking traffic. Most of the properties on this road do not have driveways. During the 1-2pm residents only hours it is extremely easy to park, proving that people are using this road to park for the Doctors surgery and Temple Fortune Highstreet. The re development of the Medical Centre we anticipate will make this parking issue even worse. We propose for the Residents CPZ hours to be increased to solve this issue. It will also match the neighbouring roads around the area who have longer Residents only hours.</p>
<p>3.</p>	<p>Petition: Church Hill Road Pedestrian Crossing</p> <p>Lead Petitioner: Aideen Dunne</p> <p>Ward: East Barnet</p> <p>Number of signatures: 30</p> <p>Details:</p> <p>We the undersigned petition the council to Install a new pedestrian crossing on Church Hill Road at or close to the junction of Cedar Avenue.</p> <p>An additional safe crossing point is required on Church Hill Road at the junction of Cedar Avenue for the following reasons:</p> <ul style="list-style-type: none"> - to facilitate the safe crossing of pedestrians both to and from Oak Hill Park, where there is already an existing desire line - the nearest alternative safe crossing points are outside St Mary's School, or at the top of the hill close to Church Hill School. Both are too far for the use of the significant numbers of school children, commuters and park users at this location. - an additional crossing will also serve as a further incentive to drivers to manage their speed (30mph) as they travel down Church Hill Road into East Barnet Village. This particular part of the road frequently experiences excessive speed limits and is increasingly unsafe for pedestrians to use. The resulting cost of a potential collision here will far outweigh the cost of installing a crossing, so it is a preventative measure - an additional crossing and safer route to school will further incentivise sustainable choices for school children and parents.
<p>4.</p>	<p>Petition: Support School Streets Around St John's CE Primary School, Friern Barnet School and Holly Park Primary School</p> <p>Lead Petitioner: Isabelle Spencer</p>

	<p>Ward: Friern Barnet</p> <p>Number of signatures: 74</p> <p>Details:</p> <p>We the undersigned petition the council to Implement School Streets schemes around the areas of St John's CE Primary School, Friern Barnet School and Holly Park Primary School in the N11 area to allow children to walk safely and reduce disruption for local residents</p> <p>The streets around these schools currently attract a dangerous and disruptive amount of traffic at school pick up and drop off times.</p> <p>School Streets are temporary restrictions on short stretches of road, that prevent non-residents from driving into the restricted areas at specified times. This applies to both school traffic and through traffic. These time slots are typically one hour at school drop off and pick up, Monday to Friday, during term time only.</p> <p>This reduces traffic in the area at those times. This means:</p> <ol style="list-style-type: none"> 1. Children can walk to school safely with reduced risk of traffic accidents from vehicles driving and manoeuvring outside schools. 2. Pollution is reduced and air quality is improved for everyone in the area. 3. Traffic disruption for residents during these busy times is reduced. <p>Emergency services and residents can continue to come and go at any time without restriction. Exemptions are allowed for blue badge holders.</p> <p>No further restrictions exist outside the specified times.</p>
<p>5.</p>	<p>Petition: Road safety review Moss Hall School</p> <p>Lead Petitioner: Lauren Farber</p> <p>Ward: West Finchley</p> <p>Number of signatures: 52</p> <p>Details:</p> <p>We the undersigned petition the council to review road safety surrounding Moss Hall School. Issue around double parking and parking on double yellow lines leading to unsafe road crossing conditions.</p> <p>To consider road calming measures on Nether Street and to consider other road safety measures on roads surrounding Moss Hall School (both on Moss Hall Grove and Essex Park/Wentworth).</p> <p>Concern over speed of cars down Nether Street and parking on both sides of Nether Street after junction with Moss Hall Grove.</p>

We the undersigned petition the council to Review the policy restricting us as homeowners of Hampden Way to obtains drop kerb outside our own homes so that we can safely park our cars on our driveways.

We live at Hampden Way. We are looking for support from people who believe in our cause, which is to fight for the right to build driveways outside our homes and most importantly access it though a dropped kerb which is paid for by us through the council.

At this point in time, those who have applied for a drop kerb after 2017 have had to applications rejected due to a new policy in relation to the grass verge between the pavement and the road.

This change in policy has resulted in many homeowners unable to park their cars on driveways and risk their personal safety and cars as they park on Hamden Way. This road is not only very busy but it is very tight as cars/ buses/ large vehicles pass by in both directions at speed- there has been 2-3 serious accidents in the past few months! We have paid good money to live here, it should be our right get a drop kerb outside our houses. Many of us are already enjoying ours as we applied before 2017- this is unjust!

We would like to get the homeowners of Hampden Way to support us in requesting the council to change this policy.
