#### *General points*

The following procedure is based on Regulations made by the Secretary of State under the Licensing Act 2003 (“the Hearings Regulations”) which may be viewed or downloaded from the website of the Department for Culture, Media and Sport by following links from [www.culture.gov.uk](http://www.culture.gov.uk)

The procedure is intended as a general framework to ensure natural justice and a fair hearing. The conduct of individual hearings may vary slightly according to circumstances and the discretion of the Chairman. In all cases, however, this general framework will be followed.

The procedure allows each party a maximum period of 5 minutes in which to present their case (Regulations 16 & 24). At the end of the time allowed, the Chairman will terminate the presentation and the hearing will proceed in the form of a discussion led by the authority to explore points of dispute. The discussion will not be timed.

The procedure is subject to periodic review and amendment to reflect best practice and relevant legislative changes. An updated version of this procedure is published as soon as possible following any such amendments.

#### **Governance Officer**

- To seek nominations for Chairman
- Elect Chairman
- Hand over to the Chairman

#### **Chairman**

- Introduces him/herself and Members of the Committee, and outlines their roles.
- Introduces Licensing, Legal and Governance Officer.
- Explains that Legal and Governance Officers will be present during the Committee’s deliberations to advise only, and that the Licensing Officer will be excluded from deliberations.
- Asks parties present to introduce themselves.
- Outlines procedure to be followed.
- Asks all parties to confirm their understanding of the procedure.
- Clarifies any aspect(s) of the procedure where any parties are uncertain or asks Legal or Governance Officer as appropriate to clarify.

#### **Governance Officer**

- Informs Committee of absent parties.
- Details persons whom a party is seeking permission to represent them at hearing.
- Panel confer regarding permission.
- Chairman announces decision regarding permission.

### **Licensing Officer presents the report to the Committee**

- Is a statement of the facts including details of the application and operating schedule, relevant policy details, detail representations made, a chronology of events and highlights the points on which the Authority requires clarification.

### **Applicant**

- Presents opening submissions and clarifies points raised by Authority in notice of hearing. Time allowed 5 mins.

### **Other parties**

- Presents opening submissions either in person or by spokes person  
Time allowed 5 mins per interested party.

### **Note regarding use of video evidence**

Video evidence must be in DVD format and will form part of the relevant party's five minutes opening submission. Any party wishing to use video evidence must submit a copy to the Authority along with sufficient, identical extra copies to serve on all the opposing parties – i.e. if the applicant is submitting it, there must be enough copies for all parties making representations and if a party making representations is submitting it there must be a copy for the applicant. The recording must be edited down to the highlights, containing only relevant matter which relates to the written representation previously submitted. In addition, a description of how, when and where the video was recorded and what it contains must be submitted. These must be supplied to the Authority at least five working days before the hearing.

### **Members question Licensing Officer on Policy**

### **Discussion**

#### **Chairman leads a discussion concentrating on points of dispute:**

Chairman asks Applicant what he disputes in other parties' submissions, and asks other parties to comment.

Chairman proceeds through all objectors dealing with all matters of contention.

When Chairman feels all matters have been thoroughly discussed and all parties have been given a fair and equal opportunity to comment and make representations, she/he closes discussion.

### **Determination**

There are two procedures depending on whether or not determination is to be made at the end of the Hearing or within five working days of the Hearing. This later announcement of determination is permitted in terms of the Legislation for certain types of applications.

#### **Chairman informs all present that the Committee will deliberate, that Legal and Governance Officer will remain to advise but will not be part of decision-making process, and that all others must leave (under Regulation 14).**

- Parties, apart from Legal and Governance Officer, leave the room.
- The Committee deliberates, with advice as required from Legal and Governance Officer, and reaches a conclusion. The Legal officer may assist, as required, in formulating the wording of the determination.
- Parties return.

- Chairman reads out determination, and advises it will be sent in writing to all parties.
- Opportunity for determination to be clarified by any interested party who is unclear.
- Chairman gives advice about appealing against the determination.
- Chairman thanks all for attending and closes the meeting.

**...Within five working days of the hearing**

- Chairman explains requirement to determine the Hearing within five working days, and advises that the Committee will proceed to deliberate and announce the determination within that time.
- During deliberations, Legal and Governance Officers remain to advise on law and procedure as required. The Legal Officer may assist, as required, in formulating the wording of the determination. The Licensing Officer plays no part in the determination and withdraws for this part of the proceedings.
- Chairman advises all parties that they will receive written notification of the determination within five working days of the Hearing date, together with general information on how to appeal against the determination.
- Chairman thanks all parties for attending and invites the applicant, objector(s), other party(ies) and the Licensing Officer to leave.

**Information on Appealing against the decision**

You may at any time before the expiration of a period of 21 days from notification appeal to Willesden Magistrates' Court, 448 High Road London England NW10 2DZ (Telephone 020 8955 0555, DX 110850 Willesden 2) by way of Complaint for an Order. The Court may either dismiss the appeal, substitute for the decision appealed against any other decision which could have been made by the Licensing Authority or remit the case to the Licensing Authority to dispose of it in accordance with the directions of the court, and can make such order as to costs as it thinks fit.

## Summary

## **Officers Recommendations**

- 1. This report asks the Sub-Committee to consider an application for a Variation of a Club Premises Certificate, under section 84 of the Licensing Act 2003 for Camden Playing Fields Sports And Social Club, Camden Playing Fields, Burtonhole Lane, London, NW7 1AS**

### **1. WHY THIS REPORT IS NEEDED**

- 1.1 The licensing authority having received valid representations against the application for a variation of a premises licence is expected to hold a hearing to consider those representations. The application can be determined by the licensing authority without a hearing in certain circumstances.

### **2. REASONS FOR RECOMMENDATIONS**

- 2.1 Where a representation is submitted under Section.35(3) of the Licencing Act 2003 the authority must hold a hearing to consider such representations, unless the representation is withdrawn, the applicant or any party or responsible authority who has made a valid representation agrees or where the authority considers that the representations are frivolous or vexatious.

### **3. ALTERNATIVE OPTIONS CONSIDERED AND NOT RECOMMENDED**

- 3.1 The Licensing Sub-Committee is required to give appropriate weight to the representations (including supporting information) presented by all the parties, the Guidance issued pursuant to section 182 of the Licensing Act 2003, the Council's statement of licensing policy and the steps that are appropriate to promote the four licensing objectives.

Having considered those relevant matters, the Licensing Sub-Committee is required to take such of the following steps (if any) as it considers appropriate for the promotion of the licensing objectives.

The steps are—

(a) To vary the licence subject to—

(i) conditions that are consistent with the operating schedule accompanying the application modified to such extent as the authority considers appropriate for the promotion of the licensing objectives, and

(ii) any condition which must under section 19, 20 or 21 of the Licensing Act 2003 be included in the licence;

- (b) to exclude from the scope of the licence any of the licensable activities to which the application relates;
- (c) to refuse to specify a person in the licence as the premises supervisor;
- (d) to reject the variation

For the purposes of 3.1(a) (i) above, the conditions of the licence are modified if any of them are altered or omitted or any new conditions added.

#### 1. The Applicants

The application before the subcommittee was submitted under Section 84 of the Licensing Act 2003. It is an application for a Variation of a Club Premises Certificate, submitted by Ian Salter on behalf of Camden Playing Fields Sports and Social Club.

#### 2. Application

The original licence was granted on 29<sup>th</sup> July 2005 following the introduction of the Licensing Act 2003. The table below shows the activities and hours they are currently licenced for. It also shows the hours the applicant would like to vary the activity for sale or supply of alcohol.

The applicant requests that the premises be permitted for the sale of alcohol, performance of live music and the playing of recorded music until 02:00 into New Year's Day.

In addition to the above-mentioned variations, they would like to amend the premises name to Old Camdenians Sports & Social Club.

### **3. Representations**

The Licensing Team received 17 valid representations from residents. The resident's representations cover matters relating to all four of the licensing objectives.

The representations and supporting information can be seen attached to this report in **Annex 4**.

### **4. Attaching conditions**

The operating schedule, which is part of the application, includes certain additional steps that the applicant will take to protect the licensing objectives. These will become enforceable conditions, should the licence be granted. Additional conditions may be attached to the licence if the committee thinks it appropriate.

The Committee must have regard to all of the representations made and the evidence it hears and is asked to note that it may not attach conditions or reject the whole or part of the application merely because it considers it desirable to do so. It must actually be appropriate in order to promote the licensing objectives.

In relation to conditions, the statutory guidance at chapter 10.8 states that "The licensing authority may not impose any conditions unless its discretion has been engaged following receipt of relevant representations and it is satisfied as a result of a hearing (unless all parties agree a hearing is not necessary) that it is appropriate to impose conditions to promote one or more of the four licensing objectives.

Full Copies of the Councils Statement of Licensing Policy, the Statutory Guidance to the Act and the Council's Guide to Good Practice at Licensed Premises will be available at the Licensing Sub Committee hearing or in advance if required.

  - (2) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.

Slight Change of name from Camden Playing Fields Sports and Social Club to Old Camdenians Sports & Social Club. We are the same organisation but the previous name seems to be a merger of the trust which owns the lease and the club which has always run the premises on their behalf.

We would like to amend our licensing hours for the supply of alcohol on Fri-Sun to extend these slightly to 10:00 - 00:00 in compromise to this we have reduced our hours Mon-Thurs to keep the overall amount the same. We do not foresee this small adjustment having any impact on the licensing objectives.

We are also looking to include regulated entertainment on our license for Live & Recorded music, Both amplified & Unamplified for the same hours as our alcohol license. This had been included previously on our license but was removed recently as the council advised it had been included by error.

The club has always held small functions for its members such as birthday parties which include music from a DJ and this is something we wish to continue to do. My understanding is that a license isn't necessarily required up to 11pm but would be required for the additional hour to midnight. The inclusion of this would more than anything else cover any doubt around the provision of music on our premises. Once again with this being included previously and only being extended slightly outside of permitted times anyway, we don't foresee any adverse effects to the licensing objectives from this.

We are in receipt of the application to vary this licence.

I understand the changes you wish to implement are;

*"1. Slight Change of name from Camden Playing Fields Sports and Social Club to Old Camdenians Sports & Social Club. We are the same organisation but the previous name seems to be a merger of the trust which owns the lease and the club which has always run the premises on their behalf.*

*2. We would like to amend our licensing hours for the supply of alcohol on Fri-Sun to extend these slightly to 10:00 - 00:00 in compromise to this we have reduced our hours Mon-Thurs to keep the overall amount the same.*

*3. We are also looking to include regulated entertainment on our license for Live & Recorded music, Both amplified & Unamplified for the same hours as our alcohol license. "*

At this time I have been advised by LBB Council that the existing conditions are;

1. a. The supply of alcohol must be at a time when the premises are open for the purposes of supplying alcohol, in accordance with the club premises certificate, to the member of the club for the consumption on the premises
- b. Any alcohol supplied for consumption off the premises must be in a sealed container
- c. Any sale of alcohol for consumption off the premises must be made to a member of the club in person.
2. (1) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.
- (2) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.

In order to ensure promotion of the licensing objectives we would ask the addition of the following (in line with the points offered within section 16 of the application);

- Signage at all exits regarding leaving the premises respectfully to our neighbours
- Provision of CCTV and alarm systems on the premises. The CCTV system, must record footage and store for a minimum of 31 days. This system must be properly maintained and of sufficient quality to enable identification of subjects recorded.
- Key areas to be covered by CCTV are;
  - All bar areas where alcohol is served
  - Comprehensive coverage of all areas where alcohol will be consumed by members
  - Entrance to the premises
  - Approach to the toilet facilities
- Suitable external lighting must be installed and properly maintained

- Provision of toughened or plastic glasses for use when needed. The need for these must be risk assessed for any event held at the venue
- Provision of a sufficient number of people employed or engaged to secure the safety of the premises and patrons
- Appropriate instruction, training and supervision of those employed at the premises. All bar staff must be trained in their responsibilities with regards to the sale of alcohol
- Children to be accompanied by an adult at all times. Children must only be permitted on the premises when it is suitable. Events at the premises must be risk assessed for those that are not suitable. Adults in charge of children on the premises must not be permitted to become intoxicated.

Fortunately serious incidents at club premises like this are few and far between, but when they do happen, it is often extremely hard for police to establish what has gone wrong and who is responsible due to poor/no CCTV and a general lack of knowledge around responsible running of a licensed premises. I hope that the proposed conditions above would go some way to avoid this becoming the case at Old Camdenians Sports & Social Club.

We can hear their music and singing very clearly even when windows are closed. Sound travels unexpectedly far in our rural corner of Barnet. While we understand the need for social life we'd resent being disturbed beyond the hours that the current license permits. Extending licensing to midnight on Friday, Saturday and Sunday would result in misery for us and other local residents caused not only by the noise from the event late into the night but the rowdiness of people leaving afterwards. I urge you not to allow this extension.

### **Aprox 2010**

**The very generous licensing hrs** were applied for around this period during summer hols with just a sign on front door but 100 meters behind gates & add in local paper which of course no one knew about to object.

However this was not initially a problem under the new/old management as they had few evening functions and limited hours same as a pub (which is what it should be) and at a lower volume.

This amount of use of course they could of course choose to change at any time unless reviewed ?

### **2011**

They cut down 70-85 mature tree & brought in 100's of full 8 wheel tipper truck's delivering free soil without any planning application & Car park was enlarged seven fold

I advised Barnet & local papers & preservation societies and Barnet forced them to stop ( and they then put in a "Retro Planning Application" ) No one thought the raised terrace would be used for evening events rather than just watching sports

### **2013**

**See attached** my letter re retro planning application were I actually praised some of the management changes to get things right and at that time we got on well and their future plans were within reason or so they told me ?

**However is no longer the case** as in the last 9 Years things have just escalated in what you might call creep

It is no longer just a Sports & Social Club but seeking to become a full blown Evening/Weekend exertainment Hire Venue/Destination money earner 7 days a week with live music including Sundays open to the Public and into the early hours where I have had to call Barnet Noise Control on numerous occasion up till 03.00 in the morning despite the license finishing earlier. The police have also had to attend in the past.

### **The Problems are totally related to evening Commercial Events NOT Sports**

1/ The existing hours are just way to generous much longer than even a pub and were given without thought as at that time there were no objections as no one knew about the application !

2/ The ambient noise here at the end of a lane is Nil except for cows and birds with no passing traffic so any sound is amplified

3/ You must realise that it's Difficult to get so many objections as there are only around 10 houses + a farm nearby but we can all still expect to live in peace ? and an Englishman's home is his castle.....etc

4/ There is no power cut "**Noise Limiting Devices**" as in other venues this includes Bass which as you know travels further ( although this does not help with shouting )

5/ It's use and disturbance is linked to the drinking hours given ( way too long at present ) & whether or not double doors are to be shortly fitted and used ? front & rear to contain music & shouting noise when inadvertently opened.

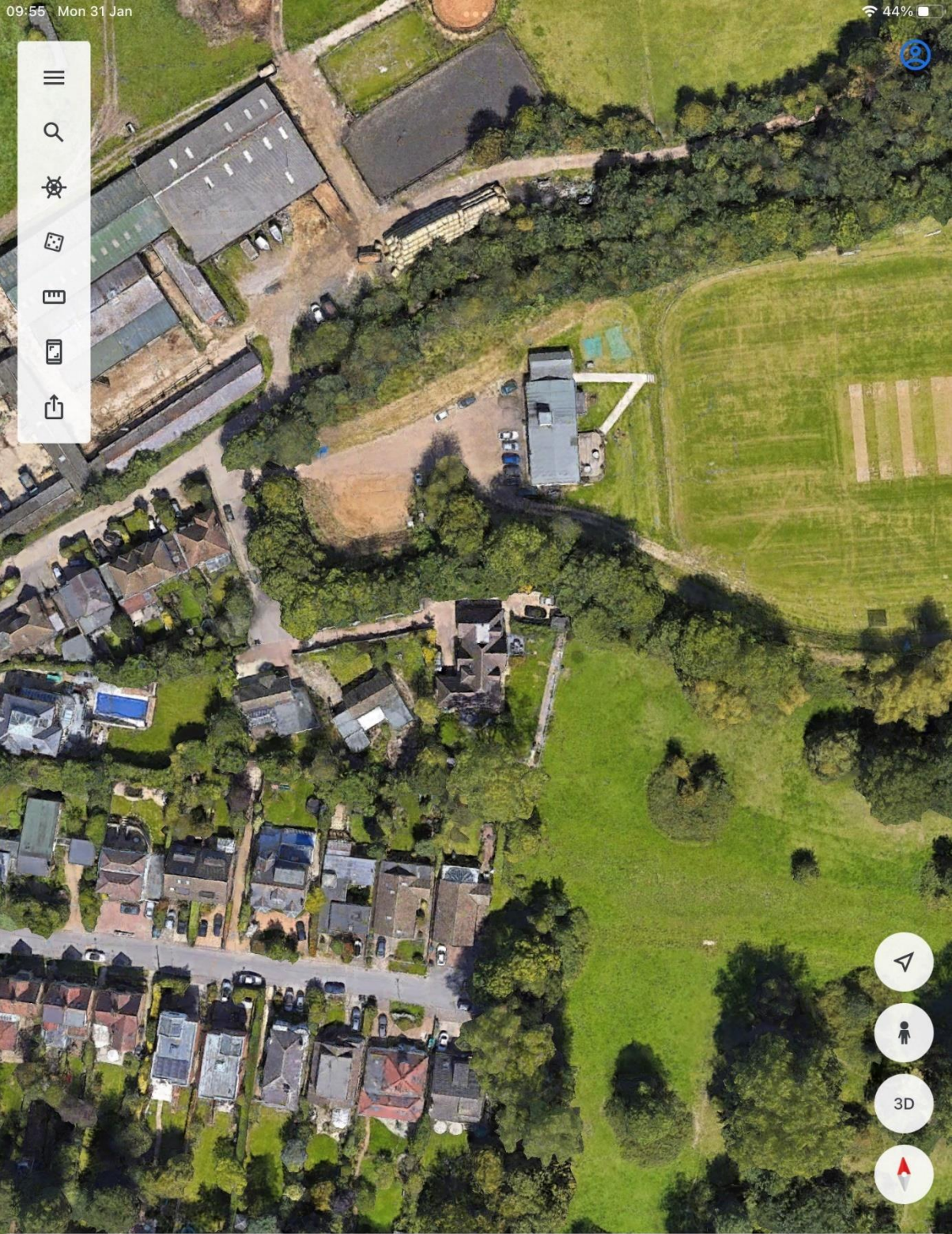

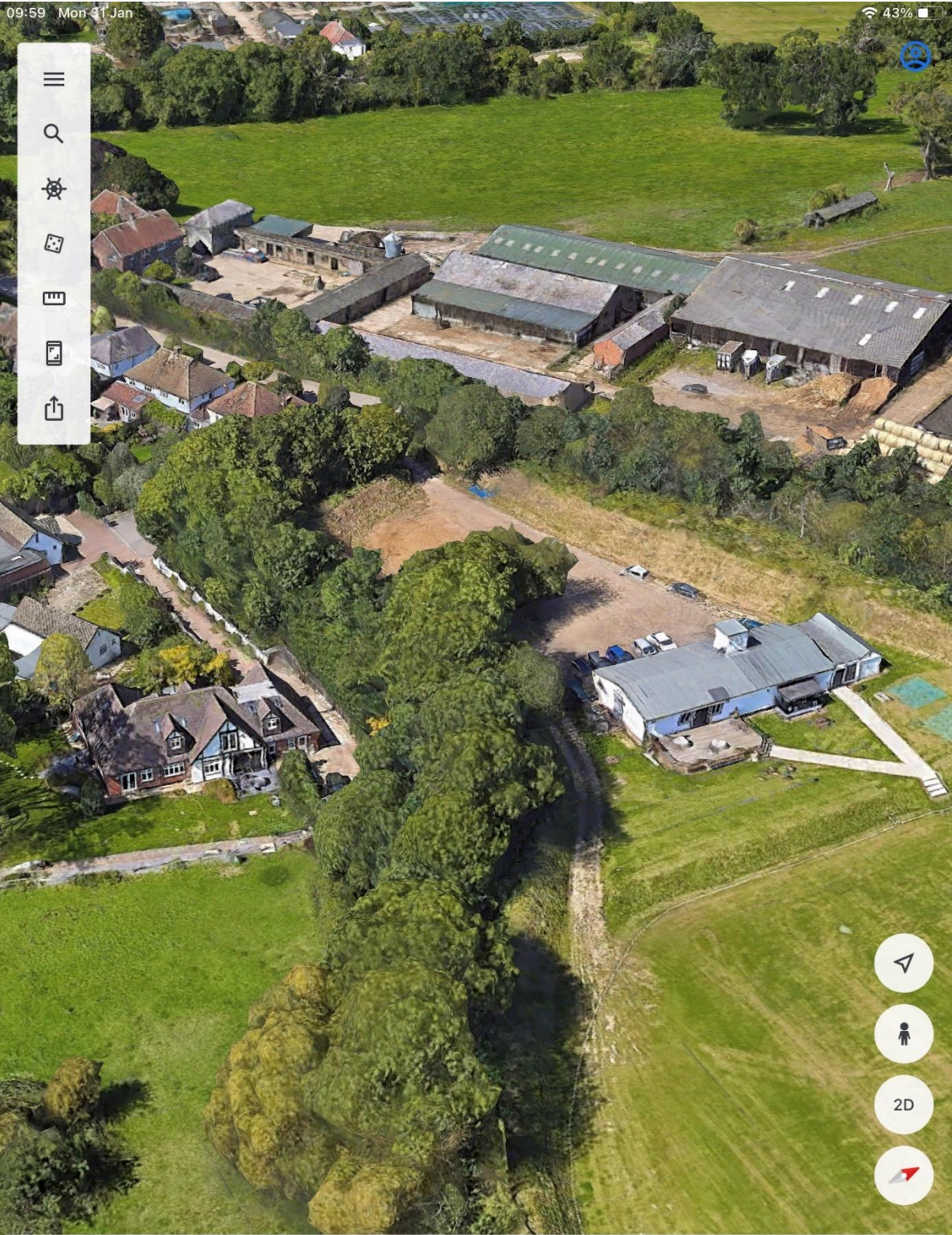

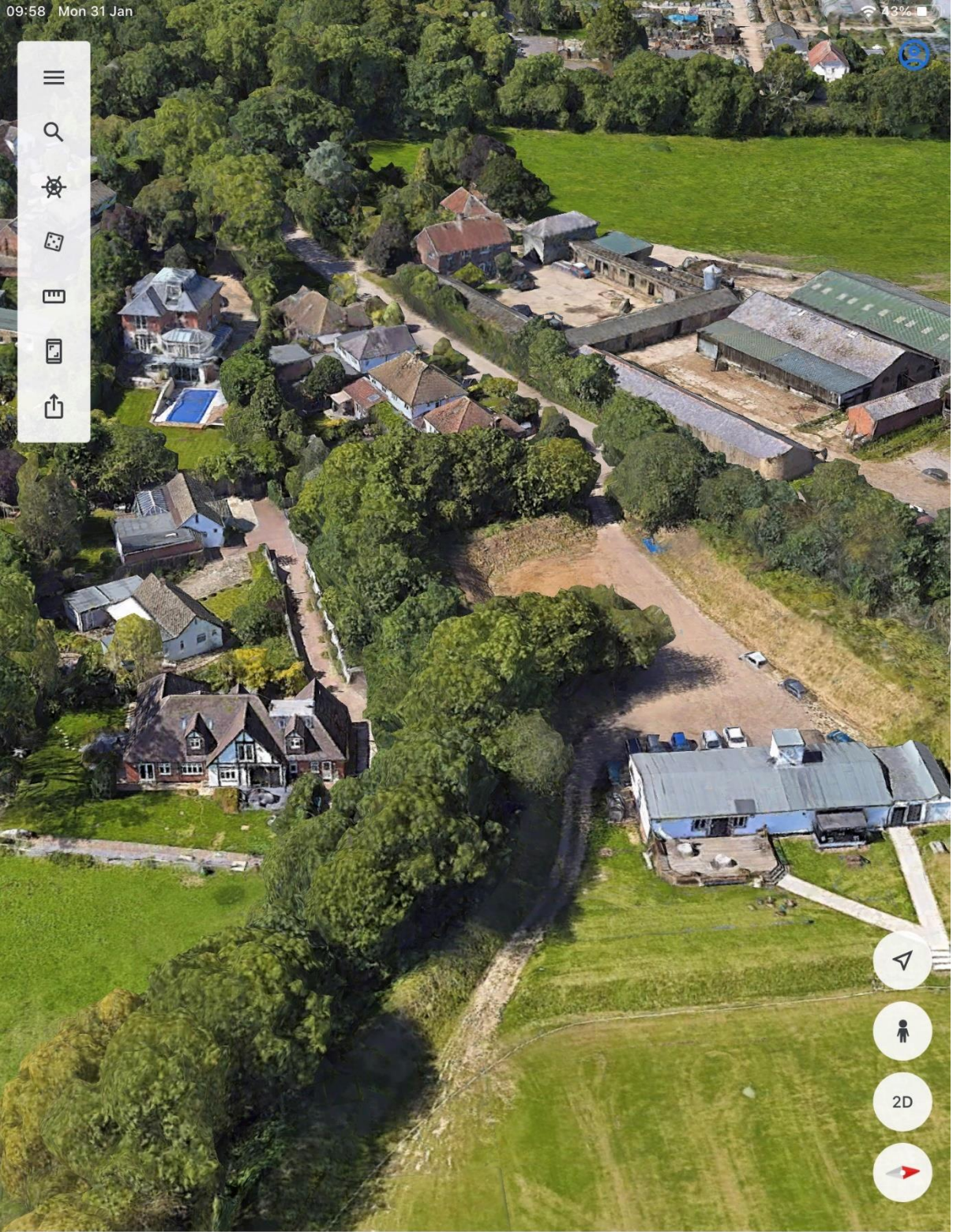

I am one of the very few neighbours and also directly affected as my bedroom is 50 Feet from the club house in what is of course a very,very quiet sparse special area of London & Green belt/Conservation etc.

*I enclose a copy of the most recent exchange of emails with your planning dept, who have to date done a great job when made aware of the situation.*

As you may know the previous management caused the existing problems and fortunately the new management ( Which are actually the original long ago management now back in the hot seat ) are now trying to put things in order.

**The main changes** ( Caused by original management ) have been – The Loss of trees/The Enlarged car park/ The Issue of Extension of drinking license hrs / The raised level of soil with wood Decking on top at rear of clubhouse and attached to the bar/ The Earth bund

**1/ The Trees** mostly already gone so little can now be done except perhaps a few more saplings

**2/ The enlarged car park** except for more car door noise this makes little difference in fact is better now as less cars trying to park outside where there is **absolutely nil** parking spaces

**3/ The licensing hrs** were applied for couple of years back during summer hols with just a sign on door 100 meters behind gates & add in local paper which of course no one knew about to respond.

However this was only a problem during the period of the old management who used this facility to extreme thereby involving numerous noise control out of hours registered evening calls etc.

However this has not recently been a problem under the new management as they have recently had fewer evening functions and limited hours same as a pub (which is what it should be) and at a lower volume.

This amount of use of course they could of course choose to change at anytime unless reviewed ?

This very late license was the wish of the Old management to turn the club into something that it was not suitable but now under new management these times are no longer needed. There is also already another club in the area that can cater for this type of use The Middlesex Sports Club near the Garden Centre & nursery

**4/ The raised level outside club + new wood decking area**

This is a new outside raised drinking area ( connected with the license ) built on top of a new raised mound of soil and paving adjacent to my back garden & 50 feet from my Bedroom. It's use and disturbance is linked to the drinking hours given ( to long at present ) & whether or not double doors are to be shortly fitted front & rear to contain music & shouting noise when inadvertently opened.

Previously there was no outside drinking area except the lower field so no people outside unless interested in actually watching the sports

If the existing license & new raised outdoor drinking area where used to there full it would cause a big problem !!

**5/ The earth bund boundary**

This is a brilliant idea and has gone leaps and bounds to protect the near neighbour's privacy from noise & disturbance.

However, after all the changes including 100's of 8 wheel tippers of soil

The bund build now seems to have very recently just stopped and of course just short of the boundary between my house and the clubhouse which of course is the **most critical area ?**

The variation hearing will be ample opportunity for residents who made valid representations to express their concerns, amid any issues they are experiencing with the premises, to the Licensing Sub-Committee, which is made up of Barnet ward Councillors. The premises licence holder will also be present at the hearing, giving the committee scope to ask the licence holder questions regarding resident's concerns. The committee may be minded not to grant the variation and/or impose further conditions on the licence to ensure the best possible outcome for all parties.

There is not sufficient cause for the Licensing authority to consider a review of the licence at present. However, a Review application can be submitted by the public or any other interested party for example, a Responsible Authority recognised under the Licensing Act 2003, such as the Noise team. Although, please bear in mind that for a Review to be considered, there would need to be substantial cause for concern regarding the premises. I am writing to object to the extension of the alcohol licence and the licence for live and recorded music at this Club from 22.00 hours until midnight on Friday, Saturday and Sunday nights.

My house is directly opposite the entrance to the Club car park. When parties or functions are held at the Club in the evenings, I usually hear noise coming from the Club, and also from people leaving, often shouting in the street outside my house, car doors slamming and car engines revving. This can carry on for an hour or more after the end of the licence period.

On occasion there has been drunken behaviour. Last night, Saturday 29 January, the behaviour of teenagers at a party in the Club was so bad that police were called and there were three police vehicles and about eight police officers in the road outside my house until nearly 11 p.m.. Dozens of youngsters were milling around in the street, shouting and squealing, propping themselves up on the wall of my house etc.

If the licenses were extended until midnight it could result in this type of nuisance going on until 1 a.m. for three nights a week, which is completely unacceptable in a quiet residential neighbourhood.

I would like to object to the above application for increased hours in the supply of alcohol until midnight on Friday to Sunday and for the corresponding increase in the permitted music and entertainment times. My objection is on the following basis:

1. The acoustics of the Totteridge Valley are very peculiar and we currently hear the sounds produced by this venue as though it was happening in our own garden. An extension of the permitted hours until midnight will cause a serious noise nuisance to us and to our neighbours past "normal" licensing hours, which is not fair in this quiet semi-rural neighbourhood.
2. The current "end time" of events at the venue is 11.00. By the time that party-goers and others who hire the premises finish and actually leave it is often closer to midnight. We hear cars revving and tyres screeching and people on-foot shouting (and not infrequently other drunken behaviour). If the permitted alcohol and entertainment times are extended to midnight, this will take place nearer to 1am. Again, this is unacceptable and unfair to residents of the quiet neighbouring roads.
3. As explained above, the application for extended hours will, I am convinced, increase disorder and public nuisance and if, as quite likely, it results in increased alcohol consumption, it will also threaten public safety as the drunk drivers drive home.

Dear Sirs

I am writing on behalf of my wife Yvonne Catherine Saville and myself to object to an application to extend the alcohol licensing hours, and to extend the hours for live and recorded music (amplified and non-amplified) entertainment at Old Camdenians.

My wife and I live at xx Hillview Road, Mill Hill, NW7 xxx which is situated at the crossroads with Burtonhole Lane, close to the Old Camdenians premises. At present we suffer from noise nuisance caused by patrons of the Old Camdenians Sports & Social Club when they depart from the premises when the club closes. This noise consists of shouting, laughing, loud conversations in the street (i.e. Burtonhole Lane) as well as the starting and revving of car engines. Often this goes on for a considerable time after closing time, as no doubt the customers continue their conversations in the street and do not disperse promptly. The customers tend to dawdle, and so the noise goes on for some considerable time. This happened again last Saturday 29<sup>th</sup> January.

In the interest of neighbourliness we do not complain about this but put up with it with the hours as they are at present. However, it would be very different if the hours are extended and that would create a really significant nuisance. I would imagine that the residents of those houses in Burtonhole Lane situated between the cross roads and the club premises would really be affected badly in that eventuality, but even our house, which is situated about 200 metres from the club premises are adversely affected.

I would also mention the acoustics of the Totteridge Valley are unusual in that sounds in the valley are magnified. The consequence of this is that conversation in the street appears to be taking place very loudly, nearer to our house than it actually is. Sometimes I think these people are in our garden, but of course this is an illusion. Likewise Mill Hill Cricket Club is quite a distance from our house, and yet because of the magnification of sound in the Totteridge Valley, we can hear every ball being bowled. This makes the nuisance from the Old Camdenians even greater, so it would be a real nuisance if the hours of the club were extended. However, we would be quite content to leave the house as they are without making further complaint.

We therefore ask that the licensing hours are not extended.
