1.	Issue: Burnt Oak Broadway / Deansbrook Road traffic lights Resident: Mr Samuel Ward: Edgware  Burnt Oak Broadway / Deansbrook Road traffic lights has an island and car phases but we have been unable to see a green man phase and crossing for pedestrians installed as part of the junction, in line with the new hierarchy of transport. This is an issue we face right across Greater London; such as the junction with Stag Lane / Watling Avenue. Furthermore, a previous London mayor had prioritised motor traffic flow by reducing the crossing times of these type of green man crossings. An architect told me he measured 5 seconds on Watling Avenue. I had hoped the change of administration would see renewed cooperation with the London Borough of Brent and the authority that manages the A5 high road. All our taxes pay for this traffic light yet there seems to be no accountability.  Please will our Councillors bring together relevant people who can make this crossing more pedestrian and cycle-friendly?	The junction of Burnt Oak Broadway with Deansbrook Road and Camrose Avenue is one of a number of traffic signalled junctions in Barnet without a red/green man pedestrian facility.  I can advise that this is something that the LBB and TFL are currently looking at however, we need to do so in a way that will not have an adverse impact on the surrounding road network.  Changes to a signalised junction are major proposals, which require traffic modelling of the junction in advance to identify a suitable solution.  Previous investigations into the introduction of a pedestrian facility at the junction, alongside other improvements, required major changes that were not considered feasible at the time. However, we have identified the location for future consideration of a scheme focusing particularly of pedestrian and road safety issues.

#### **Issue Raised** Response Issue: Water Pooling - Junction of Golders Green Road and Woodstock Avenue The Junction of Golders Green Road and Woodstock Avenue Resident: Mr Levy is an area where multiple issues have been identified. Ward: Childs Hill Thames Water were on site earlier this year and identified a Pursuant to item 18 of the Finchley and Golders Green Residents Forum, 6 January 2021, leak on their water main. This was subsequently repaired. concerning storm water pooling on the two drop kerbs at the east corner of the junction of Following the repairs to the Thames Water network, the LBB Golders Green Road and Woodstock Avenue (facing the respective two roads). This storm drainage team undertook gully cleansing with the most recent water can span both drop kerbs, persisting thus for many hours after heavy rain. It then clearance being July 2023. defeats the purpose of the said dropped kerbs, one of which serves a zebra crossing, and makes crossing difficult for the less able-bodied. At least one other resident has raised this However, Inspection by the Highways Construction team issue. See pics. identified undulation on the footway in part caused by vehicles illegally driving on to the footway. The Council has made three separate announcements of timeframes in which it planned to do remedial works, none of which have materialised. On the last occasion (see above) I can confirm the Highways Construction team are it stated that gully works were considered the best solution. investigating crossing improvement works to level the footway and protect the junction. I am seeking that the Council conduct remedial works, and specifically that this Committee now refer the issue to the Director of Highways in order to seek certainty on the matter.

# Issue Raised Issue: School Street signage for Thorverton Road Resident: Mr Levy Ward: Childs Hill

Response

Thorverton Road School Street lacks a sign at the west corner of its entry point at the junction with Cricklewood Lane. It is almost impossible for motorists approaching from the west to read the one sign on the east corner when displayed during term time, before turning into the street. See Street View image herewith.

In April 2023 a tribunal overturned a PCN issued by Islington Council where a School Street was better signed than this with a sign on both sides of an entry point, after the driver argued they couldn't be read until he had committed to the turn (Islington Gazette article).

#### I would like the Council to

(i) install a School Street hours sign on the west side of the junction which can clearly be read by motorists approaching from the west during term time, in addition to that on the east side;

Before the installation of the pedestrian and cycle zone signs for the School Street, this road was already a 20-mph zone with the required signs to enforce the 20-mph speed limit. In order to minimise sign clutter, it was decided to keep the 20-mph restriction on one side and the new one for school streets opposite.

Nevertheless, we have installed advance signs informing of School Street restriction so drivers will be aware of the restriction before entering the road. Officers are happy to revisit Thorverton Road to review the existing signage.

However, all motorists receiving a penalty have the option to make representation against a penalty charge - and to refer a case to adjudication if representations are not successful - through the statutory process and within the timescales set by that process. All such cases are considered on their individual merits.

#### Summary

This report provides Members with an update on the CIL budget allocations for the West Area Committee, to enable consideration of applications for funding during 2023/24, and an update on the Road Safety & Parking budget allocations for 2023/24 and the status of current schemes.

#### Recommendations

- 1. That the West Area Committee notes the Community Infrastructure Levy (CIL) funding available for allocation during 2023/24, as set out in paragraph 5.4 of this report and in Appendix 1.
- 2. That the West Area Committee notes the CIL amount and re-allocated underspends & overspends in paragraph 1.7 of this report and in Appendix 1.



3. That the West Area Committee notes the Road Safety & Parking Fund available for allocation during 2023/24 in paragraph 5.8 and as set out in Appendix 2

#### 1. Reasons for the Recommendations

- 1.1 This report indicates the allocation of part of the Community Infrastructure Levy ("CIL") to the West Area Committee (Area Committee). This will enable the Area Committee to determine the amounts that can be allocated at this, and future meetings.
- 1.2 This report also sets out the allocation of Road Safety & Parking Budget, part of the Community Infrastructure Levy ("CIL") to the North Area Committee.
- 1.3 The amounts approved from the CIL reserve were based on estimates from the service department, with a view that should the estimate prove to be understated there would be no further call on the Area Committee budgets without an additional approval. Expenditure exceeding 15% of the original estimate will require an explanation to enable the Area Committee to agree any additional funding.
- 1.4 Detail as to the activity to date of this Area Committee and the balance available are attached as Appendix 1 to this report.
- 1.5 This report also includes an update of the Road Safety & Parking budget allocation and schemes as Appendix 2 to this report.

#### 1.6 CIL activity

- 1.7 The latest position shows expenditure to August 2023. The total amount of underspend on schemes completed between June and September Area Committee is £820 which is add to the 2023/24 allocation (see Appendix 1).
- **1.8** The over & underspends from the prior year schemes that are still open will impact on the total Area Committee available balance, until the schemes are certified as complete.
- 1.9 All CIL funding allocations should be submitted in accordance with the approved CIL funding application guidelines detailed in the Policy & Resources Committee report dated 22 February 2023.

#### 1.10 Road Safety & Parking Budget Activity

- 1.11 The latest position as set out in Appendix 2 shows the agreed allocations to date and the remaining budget available for future schemes.
- 1.12 Funding has been allocated to various organisations and/or projects and this will enable the Area Committee to note the amount available for future allocation.

#### 2. Alternative Options Considered and Not Recommended

**2.1** No alternative options were considered.

#### 3. Post Decision Implementation

3.1 CIL Activity Decisions can be made by the Area Committee to allocate funding to organisations from the Area Committee general reserves based on member supported applications and from the Area Committee CIL reserve for requests for infrastructure related surveys and works and anything else that is concerned with addressing the demands that development places on the area.

3.2 Road Safety & Parking Activity Approved Road Safety & Parking schemes arising from member requests, petitions or area committee report funded schemes to be implemented by Highways in line with timelines provided.

#### 4. Corporate Priorities, Performance and Other Considerations

#### **Corporate Plan**

4.1 CIL is a mechanism whereby the council can care for its People, Places and Planet, and to be a council that is effective and engaged with residents.

#### **Corporate Performance / Outcome Measures**

4.2 Not applicable in the context of this report.

#### Sustainability

4.3 There are no direct environmental implications from noting the recommendations.

Implementing the recommendations in the report will lead to a positive impact on the Council's carbon and ecology impact, or at least it is neutral.

#### **Corporate Parenting**

4.4 Not applicable in the context of this report.

#### **Risk Management**

- 4.5 To mitigate the guidelines becoming out of date, a review of the arrangements will be completed annually.
- 4.6 Area Committees have requested clarification of the CIL funding eligibility criteria to ensure that funded schemes are within eligibility guidelines. This is a possible reputational risk to the Council. The new guidelines provide clarity on CIL eligibility.

#### Insight

4.7 Members should consider using insight data during the consultation process to formulate local priorities for 2023/24, and when proposing schemes for Area Committee consideration.

#### **Social Value**

4.8 CIL is itself a mechanism for providing social value from private sector investment.

### 5. Resource Implications (Finance and Value for Money, Procurement, Staffing, IT and Property)

#### 5.1 CIL Activity

- 5.2 An annual allocation of £1.8m is made to Area Committees for 2023/24.
- 5.3 Policy and Resources committee (22 February 2023) agreed that the split of funding across all Area Committees should be proportional to population within that area. The wards pertaining to West Area committee have a population of 143,000 residents (ONS 2021 Census).
- 5.4 The total budget available to this committee as of September 2024 for the allocation to new schemes is £555,186.
- 5.5 Appendix 1 lists all the schemes in progress as at the time of publication and shows a detailed breakdown of how the available balance is derived, noting that a total of £58,160 was allocated to new schemes.

#### 5.6 Road Safety & Parking Activity

- 5.7 An allocation of £450,000 was made to the Road Safety & Parking Budget for the financial year 2023/24. This budget is under review in consideration of emerging findings from feasibility studies that are now concluding.
- 5.8 The total amount available as at the date of this meeting, totals to £48,430. This is the total amount available for allocation to new schemes. This takes into account all of the agreed allocation authorised by the Director, Highways & Transportation.
- 5.9 Appendix 2 lists all the schemes where budget has been allocated and approved by the Director, Highways & Transportation as at the time of publication with listing of the schemes in progress and summarises the headline balance position.

#### 6. Legal Implications and Constitution References

- 6.1 CIL is a planning charge that was introduced by the Planning Act 2008 Part II to help deliver infrastructure to support the development in an area. It came into force on 6 April 2010 through the Community Infrastructure Levy Regulations 2010 as amended ("the Regulations"). Section 216(2) of the Planning Act 2008 lists some examples of infrastructure which CIL can fund. i.e. roads and other transport facilities, flood defences, schools and other educational facilities, medical facilities, sporting and recreation facilities and open spaces.
- 6.2 On 1 September 2019, the Regulations were amended under The Community Infrastructure Levy (Amendment) (England) (No.2) Regulations 2019 ("2019 Regulation"). Part 10A of the 2019 Regulation requires the Council to publish "annual CIL rate summary" and "annual infrastructure funding statements". These statements replaced previous Regulation 123 lists. The "annual infrastructure funding statement" must include a number of matters listed in the new Schedule 2 including details of how much money has been raised through developer contributions and how it has been spent. Both the "annual rate CIL summary" and the "annual infrastructure funding statement" must be published on the Council's websites at least once a year.
- 6.3 The Localism Act 2011 introduced requirements that a 'meaningful proportion' of CIL income is allocated to parish councils to support their neighbourhood infrastructure requirements. Under Regulation 59A(5) of the Community Infrastructure Levy Regulations 2010 (as amended) a charging authority must pass 15 per cent of the relevant CIL receipts to the parish council for that area; this is limited by Regulation 59A(7) to a cap of £100 per dwelling in the area of the Local Council.
- 6.4 Regulation 59F enables a similar application of CIL receipts in cases where, as in Barnet, a charging authority does not have a local council structure, the local or neighbourhood CIL is passed to Area Committees.
- 6.5 Under the Regulations, regulation 59F(3) prescribes how the neighbourhood CIL may be used in these circumstances and provides that it may use the CIL to support the development of the relevant area by funding:
- 6.6 The provision, improvement, replacement, operation or maintenance of infrastructure: or
- 6.7 Anything else that is concerned with addressing the demands that development places on an area.
- 6.8 There is statutory requirement that the Council as charging authorities must have regard to the government 'CIL Guidance'. This Guidance provides additional guidance on how neighbourhood CIL funds should be used where there is no local council in place. Paragraph 146 of the CIL Guidance states that the "charging authority...should engage with the communities where development has taken place and agree with them how best to spend the neighbourhood funding". Charging

authorities should set out clearly and transparently their approach to engaging with neighbourhoods. The CIL Guidance goes on to explain that the use of neighbourhood CIL funds should match priorities expressed by local communities, which should be obtained through consultation undertaken "at the neighbourhood level". This does not necessarily prevent the Council from allocating neighbourhood CIL funds to borough wide (or larger) projects or initiatives, providing that they meet the requirement in regulation 59F. If the Council decides to depart from the CIL Guidance (i.e. by not allocating funds in accordance with priorities expressed by local communities), it should have and give clear and proper reasons for doing so.

- 6.9 In accordance with Part 2B Section 18 Terms of Reference of Committees of the Council's Constitution (Burnt Oak, Edgware, Colindale North, Colindale South, West Hendon, Hendon, Cricklewood and Childs Hill) includes responsibility for the following functions:
- 6.10 Provide an opportunity for any resident to raise matters affecting the area (except matters relating to licensing and planning applications).
- 6.11 Responsibility for all area specific matters relating to the local environment including parking, road safety, transport, allotments, parks and trees.
- 6.12 Consider area specific matters as agreed with the Chair.
- 6.13 Consider matters relating to Town Centre regeneration and designating conservation areas.
- 6.14 Determine the allocation of the Community Infrastructure Levy funding within the area subject to sufficient of the budget allocated to the committee being unspent.

#### 7. Consultation

- 7.1 A public consultation was undertaken prior to adopting the proposed new guidelines, priorities and provisional CIL funding based on population of each Area Committee
- 7.2 Members are encouraged to engage residents and community groups in their wards to raise awareness of Area Committees and the opportunities they provide for delivering community-led improvements to their local areas. Officers will also work with their community networks to promote the Area Committees

#### 8. Equalities and Diversity

- 8.1 An Equalities Impact Assessment (EqIA) was carried out to consider the new proposed CIL funding allocation to be based upon population for each Area Committee.
- 8.2 The Equality Act 2010 outlines the provisions of the Public Sector Equalities Duty which requires Public Bodies to have due regard to the need to:
- 8.3 Eliminate unlawful discrimination, harassment and victimisation and other conduct prohibited by the Equality Act 2010.
- 8.4 Advance equality of opportunity between persons who share a relevant protected characteristic and persons who do not share it.
- 8.5 Foster good relations between persons who share a relevant protected characteristic and persons who do not share it.
- 8.6 Relevant protected characteristics are age, disability, gender reassignment, pregnancy and maternity, race, religion or belief, sex, sexual orientation.





#### Summary

# **SCHEME SUMMARY**

Turning the Vale into a pollinator corridor - enhancing the biodiversity of the 4 grassy islands along the Vale, through the introduction of a range of flowers which will attract a greater variety of insects and wildlife; repairing the fence that runs along the perimeter.

The aim is to turn a relatively unused area of grass monoculture into a small haven for bees and other forms of wildlife, while giving residents something attractive to look at and walk through. (It is the first phase of a 2 year project which will hopefully see wildflowers and perennials planted along the grassy islands.)

(nb: one of the grassy islands already has a perimeter of wildflowers which were planted by the Greenspaces team a few years ago. We wish to take this work further by planting on all 4 islands).

Several initial site visits have been carried out with: Maureen Byrne (resident of the Vale/ Chair of GGERA); Harriet Duffield, Andrew Arliss, Roger Chapman (Chair of Green Spaces Network), Dr Karen Liebreich (Abundance London) and Anika Bakirtzidis (Garden Volunteer Team Leader and Outreach Coordinator/ Our Yard, Clitterhouse).

## **Area Committee priorities**

- Environment: This project fits with the Council's commitment to increasing biodiversity and tackling the climate crisis. We are taking a first step towards turning a stretch of mowed grass, lacking in biodiversity, into a field of different seasonal flowers, which will attract a variety of insects along the Vale, eventually creating a pollinator corridor. We hope it may set the path for similar grassy verges across the borough.
- Environment: The Vale is in an area where a huge number of front gardens have been paved over to make way for driveways. In so doing, the area has lost a large percentage of green land. This project will in effect replace some of the planting / diversity lost by the disappearance of these front gardens.
- Wellbeing: making the area greener and more attractive will contribute to the overall wellbeing of local residents. The

meandering mowed path connecting all 4 islands may encourage passers by to walk through the flowers and long grass, rather than walking on the pavement. We also hope that the impact of the flowers and generally more attractive appearance of these islands (inc repaired fence), will in turn discourage passing cars from littering them.

- Community cohesion this project is an opportunity for local residents to get involved in an environmental project on their doorstep. By planting thousands of bulbs and seeing them flower in vast drifts along the Vale, we hope that we will be laying the foundations for further community involvement in wild flower and perennial planting the following year.
- Community engagement –
- 1. a consultation letter will be sent to local residents: to raise awareness of the importance of increasing biodiversity in this area, to gather any initial input and to generate interest in future bulb planting activities. Residents will also be made aware of the Council's "adopt a space" scheme.
- 2. There will be a bulb planting weekend at the end of Oct/beginning of Nov. Local environmental community groups (listed above) as well as the GGERA have already pledged their support and will contact their own network of volunteers to take part.
- 3. Anika Bakirtzidis (community gardener) is very familiar with this community and lives a stone's throw from The Vale. She will be instrumental in communicating this project to the local community and actively engaging with residents in the lead up and during bulb planting days.

## Who will deliver the scheme

This project will be carried out by the Council (Greenspaces & Biodiversity officers Andrew Arliss and Harriet Duffield); Grounds & Highways teams in collaboration with Anika Bakirtzidis (Community Gardener/ Our Yard, Clitterhouse and local resident); Dr Karen Liebreich (Abundance London) and local residents/ community groups and volunteers.

Dr Karen Liebriech of Abundance London (<a href="https://abundancelondon.com">https://abundancelondon.com</a>) who has a lot of experience in community planting projects and guerilla gardening (see <a href="https://www.bbc.co.uk/programmes/m00184bp">https://www.bbc.co.uk/programmes/m00184bp</a>, Gardeners' World, 38 mins in) will be consulting/guiding the project in its early stages to make sure we hit the ground running and to help avoid any pitfalls.

Anika will be the lynch pin between the Council and the community since she is very familiar with the neighborhood and has a lot of experience in community gardening through her ongoing work at Our Yard, Clitterhouse. Anika will help to deliver the project: draw up a

## Maintenance:

- Meandering path (about 60cm wide) to be mowed every 16 days with a hand held lawnmower. The path will be initially mowed by Annika for the first couple of months, then maintained by the Grounds Team. This will replace the current mowing regime which covers the whole area and is carried out every 16 days.
- The lawn around the perimeter and fence to be strimmed regularly, so that the area looks neat and well maintained, and any planting/ growth on the inside looks intentional.

Strimming the perimeter will also prevent visibility issues for passing motorists. Bulbs require no extra maintenance **Council Service Delivery** Matthew Gunyon, Harriet Duffield and Andrew Arliss from the Greenspaces team have assessed the scheme. Harriet and Andrew have suggested that a new mowing regime (with hand held mower) should be possible, to be confirmed by the Grounds team. Matthew Gunyon has advised that the new lightweight mowing regime will require a final cut & lift at the end of the summer, a service not currently offered by Greenspaces for this stretch of land. So either we need to include it in this budget as a one-off, or we need to mobilise volunteers for an end of summer 2024 raking & clearing of the dead grass, tbc. Harriet and Andrew supplied an initial quote for wildflower/ perennial planting and soil rotavation by an external contractor. The project has since split into 2 phases, in order to allow time for the ground to be scoped in preparation for further wildflower / perennial planting the following Autumn. The only outstanding quote is for the bulb planting (which I have loosely based on half the cost of the wild flower quotation), since no soil preparation is necessary. Final figure to be confirmed. Dependencies/Risks Public consultation – there is relatively little risk with bulb planting, as residents in general would like to see more colour/ vitality along The Vale. Public engagement/volunteers – there is a risk that not many residents (beyond the ones we know already) will take part in bulb planting days/ or adopt a space. Anika knows some of the residents along the Vale so her involvement is crucial in mobilising support and educating people on the importance of doing anything we can to improve the ecology of our local area. We will also use a contractor to help plant the bulbs, so that we are not relying solely on volunteers, who may have differing capabilities. Visibility for drivers – there is a risk that the long grass may cause visibility issues for passing cars. However we intend to mow along the edges to avoid any long grasses/ flowers growing into the road. Phase 2 of this project would see us planting wildflowers along the 4 islands. This is a more risky project as wildflowers aren't always predictable, and when they go to seed they can look a bit straggly, which might generate complaints from local residents. We are hoping to minimise this risk by letting the grass grow in order to see which flowers grow naturally and well in that environment. We also

hope that after seeing the positive impact of the bulbs, local

residents will be more keen to take the next step of seeing what else
might grow.

#### **VALUE FOR MONEY**

How does your scheme offer good value for money?

- By investing in a local gardener who knows this community and is keen to engage local residents, we believe that we are investing in the future of this space. Local environmental groups are also keen to be involved and will mobilise their own volunteers.
- I will be speaking to Related Argent about the possibility of applying for a community grant for The Vale, since it falls within their regeneration area. Anika will also be approaching them about supplying volunteers for bulb planting days.
- We will be working with Abundance London, an organisation known for its inspirational guerilla
  planting on public land. We all know that planting involves taking risks and seeing what
  happens with a lot being learnt and adapted along the way Abundance London offer us
  invaluable knowledge from working on similar projects on public land and will help to minimise
  financial risk.
- Anika will also source bulbs from companies that throw away large unused batches of them.

- An opportunity for local residents to get involved in a community planting project, with the possibility of 'adopting' a space in future.
- An opportunity for local primary schools to participate in bulb planting days, and to get involved through the Green Our Neighbourhood group.
- A more enhanced and beautiful landscape could improve wellbeing and have a positive effect on mental health.
- By using a handheld lawn mower to mow one narrow path, rather than the current ride on mowers which mow the entire area, we will be using less fuel and therefore impacting less on the environment.

#### **Notes**

Path – ideally mown weekly from March through to November to keep it really neat (which is important to make the area look 'well kept' if other areas are allowed to grow more wildly)

Bulbs for autumn planting should be ordered asap (stocks often sell out) – need to consider storage (cool, dry), transport to planting site and tools (trowels / spades) to plant

Volume of bulbs can be adjusted to suit budgets and resource – but for maximum impact, recommend planting in large volumes or the impact is limited

Ground conditions will determine how long it takes to plant the bulbs manually. Volunteers vary widely in terms of capability – very physical work where speed and endurance will vary on a large scale.

Sowing wildflower seed has massively mixed results depending on multiple factors (ground preparation, competing grasses, weather, maintenance). Leaving the grass unmown in year one will highlight what wildflowers already exist which can influence the approach in year 2.
