If the Personal Interest is also a Prejudicial Interest (i.e. it affects a financial position or relates to determining of any approval, consent, licence, permission, or registration) then (unless an exception at 14(2) of the Members Code applies), after disclosing the interest to the meeting the Member must leave the room without participating in discussion of the item, except that they may first make representations, answer questions or give evidence relating to the matter, provided that the public are allowed to attend the meeting for those purposes.

### **\*Disclosable Pecuniary Interests:**

- (a) **Employment, etc.** - Any employment, office, trade, profession or vocation carried on for profit gain.
- (b) **Sponsorship** - Any payment or other financial benefit in respect expenses in carrying out duties as a member, or of election; including from a trade union.
- (c) **Contracts** - Any current contract for goods, services or works, between the Councillors or their partner (or a body in which one has a beneficial interest) and the council.
- (d) **Land** - Any beneficial interest in land which is within the council's area.
- (e) **Licences**- Any licence to occupy land in the council's area for a month or longer.
- (f) **Corporate tenancies** - Any tenancy between the council and a body in which the Councillor or their partner have a beneficial interest.
- (g) **Securities** - Any beneficial interest in securities of a body which has a place of business or land in the council's area, if the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body or of any one class of its issued share capital.

### **\*\*Personal Interests:**

The business relates to or affects:

(a) Anybody of which you are a member or in a position of general control or management, and:

- To which you are appointed by the council;
- which exercises functions of a public nature;
- which is directed is to charitable purposes;
- whose principal purposes include the influence of public opinion or policy (including a political party of trade union).

(b) The interests a of a person from whom you have received gifts or hospitality of at least £50 as a member in the municipal year;

or

A decision in relation to that business might reasonably be regarded as affecting, to a greater extent than the majority of other council tax payers, ratepayers or inhabitants of the electoral ward affected by the decision, the well-being or financial position of:

- You yourself;
- a member of your family or your friend or any person with whom you have a close association or any person or body who employs or has appointed any of these or in whom they have a beneficial interest in a class of securities exceeding the nominal value of £25,000, or any firm in which they are a partner, or any company of which they are a director
- any body of a type described in (a) above.

## **1. Election of Chair and Vice Chair 2023-24**

As the meeting was the first of the 2023/24 municipal year, in accordance with the Welsh Harp Joint Consultative Committee Constitution, the Committee were required to appoint a Chair from Brent Council and a Vice Chair from Barnet Council. Consequently, Councillor Krupa Sheth from Brent Council was nominated by members and unanimously appointed to the position of Chair, and Councillor Alan Schneiderman from Barnet Council was nominated and unanimously appointed to the position of Vice Chair. As a Chair and Vice Chair had been appointed, Councillor Krupa Sheth was handed chairing responsibilities for the meeting and members turned to consider the substantive items on the agenda.

## **2. Apologies for Absence and Clarification of any Alternate Members**

Apologies for absence were received from Councillor Saqib Butt (London Borough of Brent), Councillor Mary Mitchell (London Borough of Brent), Councillor Rishikesh Chakraborty (London Borough of Barnet), Councillor Ernest Ambe Esq (London Borough of Barnet), Councillor Andrea Bilbow (London Borough of Barnet) and Derrick Chung (West Hendon Residents Association).

## **3. Declarations of Interests**

There were no declarations made.

## **4. Deputations (If Any)**

None.

## **5. Minutes of the Previous Meeting**

It was **AGREED** that the minutes of the previous meeting held on Thursday 16 March 2023 be approved as an accurate record.

## **6. Matters Arising**

None.

## **7. Management Plan (Barnet)**

Cassie Bridger (Assistant Director, Greenspaces and Leisure, Barnet Council) presented the report, which provided an update to the Committee on the activities of Barnet Council during Quarter 1 (Apr-June 2023) in relation to the Welsh Harp and West Hendon Playing Fields.

In highlighting the key details of the report, the Committee were informed that Barnet Council had concluded a procurement exercise and awarded the contract to develop a new Parks and Open Spaces Strategy and a Local Nature Recovery Plan (LNRP had replaced Biodiversity Action Plans) to Land Use Consultants (LUC). Although Barnet Council were in the early stages of the commission, members were advised that there would be opportunities to contribute to the development of the documents through public consultations and engagement exercises.

Similarly, following the conclusion of the two stage design competition in partnership with the Landscape Institute, Barnet Council had awarded the contract to design the development of West Hendon Playing Fields to Ove Arup and Partners. Once again, the Committee were informed that a series of consultation and engagement activities, likely to be held in Autumn, would be delivered to help inform the design development for the playing fields.

Furthermore, members also noted that Barnet Council's Community Safety Team had been commissioned to deliver weekend patrols in a number of parks and open spaces over the summer period. It was explained that the patrols were intelligence led and based on known issues and reporting, with the Welsh Harp and West Hendon Playing Fields included in the patrol sites.

In welcoming further support from community groups regarding litter picking, Cassie Bridger detailed that contract litter pickers swept Welsh Harp during the week commencing 3 July 2023. In addition, the burnt-out car adjacent to the West Hendon Playing Fields was removed. It was stated that Barnet Council would arrange another contractor litter sweep in the winter when annual soft vegetation had subsided, and contact would be made with Natural England concerning dead hedging to mitigate bankside litter around the Silkstream trash screen.

To conclude their update, Cassie Bridger explained that, as members of the Thames21 Brent Catchment Partnership Steering Group, Barnet Council had approved the establishment of the following working groups:

- Data, Evidence and Monitoring
- Invasive Non-Native Species Control
- Eradication of Litter

Moreover, it was explained that Barnet Council would attend regular meetings with working group members, such as Thames Water, Canal and River Trust, the Environment Agency and other London Boroughs, to discuss how best to deal with the aforementioned issues across the Brent Catchment, all of which were relevant to the Welsh Harp.

Having thanked Cassie Bridger for the update, the Chair invited comments and contributions from Committee members, with questions and responses summarised below:

- Regarding the Silk Stream bridge, the Committee were informed that a decision had not been taken on the future of the bridge. However, Barratt London was exploring a lighter weight design along the same route which was hoped to be more sensitive to the Welsh Harp area. In response to a suggestion to re-route the bridge amid concerns that a lighter weight alternative in the same place would significantly damage the SSSI, Councillor Schneiderman recognised the concerns but explained that Barratt London had received planning permission to build the bridge in that specific location. Nevertheless, Councillor Schneiderman reassured members that the design would have to be jointly approved by stakeholders such as Natural England, the Environment Agency and the Canal & River Trust, and reiterated that the design would have to be reviewed before making a final decision.
- In response to an issue relating to the condition of the bird hide at the Welsh Harp, which was particularly impacted by litter, members were advised that the issue would be raised with colleagues at Barnet Council and options would be explored to reduce the impact of waste at the bird hide.

As no further issues were raised, the Committee **AGREED** to note the report.

## **8. Management Plan (Brent)**

Leslie Williams (Project Officer, Parks Service, Brent Council) introduced a report that outlined the progress made regarding the Brent Reservoir and Welsh Harp Management Plan since the last Committee meeting and during 2023/24. The Committee noted that the Action Plan for the Management Plan, attached in Appendix A of the report, had undergone a format review which replaced the 'Red', 'Amber', 'Green' rating with a text description of the action to provide a more accurate and nuanced update.

In moving to the main part of the update, Leslie Williams detailed that a new Grounds Maintenance Contract was commencing with Continental Landscapes Ltd on 1 August 2023 for the operational works in Brent Council's parks and open spaces. The contract included the Welsh Harp Open Space, Neasden Recreation Ground and Silver Jubilee Park. Members were also informed that the Park Warden Service was now an in-house Council service.

The Committee were advised that previous work to manage the marshland on the shore of the Welsh Harp Open Space provided for a range of conservation, landscape and recreational needs while retaining a variety of trees within the

marshland. However, shade was continuing to reduce the marshland vegetation on the southwestern shore of the reservoir alongside Neasden Recreation Ground. Thus, Brent Council was planning to review the trees on the marshland to mitigate against overshading.

Following the approval of the proposals for a Post 16 Skills Resource Centre for young people with special educational needs by Brent Council's Cabinet at their May 2023 meeting, the Committee were informed that the Centre would be located in the Welsh Harp and would provide horticulture, work experience and volunteering opportunities. In addition to its main purpose, there was also the potential for use at other times by third sector and community organisations, with Thames 21 continuing to provide some limited services at the existing Centre.

In thanking the volunteers who were vital in the delivery of the programme, an update was provided regarding the Healthy Walks Programme, with walks held at the Welsh Harp taking place on Thursdays from 10am to 1pm, meeting at the Welsh Harp Open Space end of Birchen Grove, Kingsbury NW9.

It was explained that signage had been installed on a new way-marked walking route between Wembley Park Station and the Welsh Harp (Welsh Harp Open Space at Birchen Grove). The route extended through a mix of quieter roads and green spaces including the Canal Feeder and River Brent at Quainton Street Open Space, Chalkhill Open Space, St David's Close Open Space and Chalkhill Park.

In concluding the update, Lewis Elmes (Environment Agency) provided further context to the update on pollution incidents occurring in the southern side of the Brent Reservoir SSSI. In response to an incident occurring in November 2022, a polluter had been identified and contacted regarding potential prosecution. The source of the pollution had been blocked and the suspected polluter had spoken to Thames Water concerning their discharge system. Moreover, the polluter had agreed to 48 hour rolling monitoring and they were in the process of remapping their drainage system. Regarding the pollution itself, the discharge, said to be a white powder, had ceased and PH levels had dropped to normal levels. Whilst there was evidence of ongoing foreign sewage entering the water, in which Thames Water were actively being engaged on, it was not linked to the original incident.

In thanking Leslie Williams and Lewis Elmes for the update, the Chair welcomed questions from Committee members, with contributions summarised below:

- In response to a query on the progress of the marshland work, members were informed that no work had commenced since the last Committee meeting and local discussions needed to be held before progressing,

although it was planned to eventually have trees approximately 30 metres apart.

- Regarding pollution incidents in the Welsh Harp, the Committee were advised that there were ongoing issues with misconnected properties that Thames Water was aware of, businesses had been educated on pollution in response to incidents in Mutton Brook, there were a number of projects to address pollution and invest in the sewage network in Wealdstone Brook, and a more serious issue connected to Thames Water assets was being addressed further downstream. The work of Clean Up River Brent was also detailed, who had created a novel, cost-effective way of monitoring pollution. Members were informed to contact Lewis Elmes if they wanted to learn more about Clean Up River Brent's work or wanted to get involved in the work.
- Committee members highlighted that the public were accessing the water at Brent Reservoir as they were not aware of the restrictions in place. In response, Sian Palmer-Ferry (Canal & River Trust) explained that internal conversations were occurring within the Canal & River Trust to provide greater clarity concerning access to the waters. Thus, there were plans to improve the Terms of Reference on the Canal & River Trust website and increase signage at the reservoir.
- In reiterating the number of people using the water at Welsh Harp, members called for more communication regarding pollution incidents. In response, the Committee were informed that it was not practical to notify the public about every incident. However, the Environmental Agency was meeting Thames Water weekly to receive progress updates on existing incidents and mitigations. In addition, the Environmental Agency had asked for more frequent public communications from Thames Water.
- Consultative Committee members offered their assistance with the removal of trees on the marshland.
- Regarding the impact that draining the reservoir would have on the marshland, members were informed that most of the marshland consisted of perennial's which could cope with the change. Although recognising the minor impacts that the draining could have, it was explained that the seeds would remain in the soil and more rain was expected over the period of the draining.

With no further issues being raised, the Committee **AGREED** to note the update.

## 9. Update from the Canal & River Trust



Sian Palmer Ferry (Canal & River Trust) presented the update, which focussed on the Welsh Harp Joint Vision (the Vision) and the planned Winter works at Brent Reservoir. To begin, a one-page summary of the Vision was shared with members, which detailed its four key themes: environment, wellbeing, place and inclusion. Sian Palmer-Ferry explained that answers to frequently asked questions were being drafted to accompany the Vision, and welcomed emails from members if there were any further questions after the meeting.

The Committee were then informed about the planned Winter works which would ensure that essential maintenance of Brent Reservoir was completed. Included in the works was the draining of the Reservoir funded by the People's Postcode Lottery, which was said to take approximately four weeks, with members noting that refilling was anticipated to commence before the bird nesting season in March. The Committee heard that the next steps for the Canal & River Trust were to publish answers to frequently asked questions and start a crowdfunding campaign for £15,000 in order to fund the fish rescue and clean up, which was expected to start at the end of Summer.

Before finishing the update, Sian Palmer-Ferry explained that vacancies within the team at the Canal & River Trust had now been filled, with new additions in the roles of Community Roots Manager, Volunteer Leader and Area Operations Manager. It was hoped that these additions would increase both engagement with the community and the number of volunteering opportunities available.

Following the conclusion of their update, the Chair thanked Sian Palmer-Ferry for presenting the item and opened up the discussion to Committee members, with questions and responses summarised below:

- In response to a query on the impact that an unsuccessful crowdfunding attempt would have, members were advised that the fish rescue and clean-up had to occur. Thus, the Canal & River Trust would have to self-fund the operation which would impact other projects as the activities were not budgeted in the organisation's core delivery.
- In reiterating the importance that the public were aware of the maintenance works due to safety risks, officers from both Brent and Barnet councils offered support in publishing and distributing relevant information. Sian Palmer-Ferry welcomed support with the winter works and outlined that signage of the works would be widespread throughout water access points and engagement with schools, colleges and community groups was planned to ensure extensive knowledge of the planned works.
- Regarding crayfish in the Welsh Harp, members were advised that environmental scientists from the Canal & River would be informed of

the concerns, who could explore the possibility of sampling crayfish in the Welsh Harp area.

- Sian Palmer-Ferry noted the worries raised regarding terrapins in the north side of the Welsh Harp.
- In response to concerns about community groups being named in Canal & River Trust press releases without sufficient communication with the relevant organisations, members were given an apology as Sian Palmer-Ferry believed that community organisations had been contacted regarding volunteering. It was explained that the new Volunteer Lead at the Canal & River Trust would foster closer relationships with community groups going forward.

Having thanked Sian Palmer-Ferry for the update, and with no further queries, the Committee **AGREED** to note the update.

#### **11. Any Other Urgent Business**

On behalf of Silver Jubilee Park Residents Association, Diane Mitchell addressed the Committee concerning an ongoing issue regarding trees behind the bungalows in Kinloch Drive, which were the responsibility of Barnet Council but located near the border with Brent Council. It was explained that the trees were not being maintained in a proper manner and were impacting local residents. Despite contacting officers from Barnet Council there had been little progress on the matter and therefore an update was requested on the issue. In response, Cassie Bridger reassured Diane Mitchell that the issue would be investigated further and apologised for any delays in communications. As a next step, Cassie Bridger informed Diane Mitchell that contact would be made to clarify the full details of the issue, with the Chair stating that Barnet Council and Brent Council would work together to resolve the issue.

The meeting ended at 7:22pm.

## **1. WHY THIS REPORT IS NEEDED**

1.1 The Welsh Harp Joint Consultative Committee (WHJCC) is comprised of Canals and Rivers Trust, Brent Council, Welsh Harp Conservation Group, Welsh Harp Sailing Association and Barnet Council. The committee is a consultative committee and meets on a quarterly basis.

1.2 During July – Nov 2023 (Quarter 2 & 3), the Council progressed a series of activities in relation to the management and operation of West Hendon Playing Fields / Welsh Harp. The committee are requested to note the following.

### **1.3 Management and Operations**

1.3.1 There has been one reported illegal encampment during this period and is currently under investigation. The Councils Greenspaces and Leisure Team continue to work closely with the Barnet Community Safety Team, the Local Police, and other partners to identify and remove encampments when notified.

1.3.2 An area was reported and identified as being used to grow illegal substances. It was investigated by the Community Safety Team and Police and all illegal material was removed from site.

1.3.3 A new Volunteer Handbook with associated risk assessments has been released to the Barnet Green Spaces Network. We are actioning feedback to inform an updated version, but in the meantime following the processes outlined in that document should ensure volunteering work conducted on London Borough of Barnet land is safe and covered by the Councils insurance.

1.3.4 The councils Community Safety Team were commissioned to deliver weekend patrols in a number of parks and open spaces over the summer period. The patrols were intelligence led and sites were included within the patrol based on known issues and reporting, the Welsh Harp and West Hendon Playing Fields fell within the patrol sites list. We are currently reviewing the data collected from the patrols and this will be used to inform a decision around the possibility of future deployments.

1.3.5 Contractors Maydencroft are undertaking survey work to inform the proposed extension of the West Hendon Allotments into their disused tenanted land. The scope of the project includes ecological surveying before the production of a landscape concept plan then specification for works. The proposals will include new allotment space as well as conservation areas, a pond, orchard, apiary, and event space.

1.3.6 Following the contractor litter pick of July 2023 Barnet Council have arranged contractors to undertake a winter deep clean of the site in January 2024; focusing on the site's paths and areas of congregation. The Barnet Greenspaces Team are working with CRT to aid litter removal during the reservoir draw down and have contacted

Natural England to investigate options to mitigate bankside litter around the Silkstream trash screen.

1.3.7 As members of the Thames21 Brent Catchment Partnership Steering group, the council have approved the establishment of the following working groups: Data, Evidence and Monitoring, Invasive Non-native Species Control, and Eradication of Litter (reducing litter in Brent Rivers is a Catchment Partnership priority). The council will continue to attend regular meetings with other working group members such as Thames Water, Canal and River Trust, the Environment Agency and other London Boroughs, to discuss how best to deal with these issues across the Brent Catchment, all of which are relevant to the Welsh Harp.

1.3.8 We continue to work with Thames21 and the members of the Brent Catchment Partnership on catchment-wide projects such as the London Water Vole Recovery Program with ZSL and WRT. We are currently scoping survey locations at the Welsh Harp for American mink and water voles as part of this research, funded by the Mayor's Rewild London Fund.

#### 1.4 **Parks and Openspaces Strategy and Local Nature Recovery**

1.4.1 The Council continues to work towards developing a New Parks and Openspaces Strategy in partnership with Land Use Consultants. Following the last meeting of the Welsh Harp Joint Consultive Committee on 23 July 2023, the Committee are asked to note that a SINC review is underway in order to assess the baseline conditions of each SINC site that will lead to recommendations for changes in the level of designation, potential to extend the boundaries of the SINC sites to include adjacent habitats, and identification of opportunities to enhance the SINC network. Twelve SINC sites have been completed to date and it should be further noted that more sites shall be assessed in the spring of 2024. A desk-based review will soon commence so that the Council can collect and review baseline data this will include the field survey involving habitat mapping and assessment of SINC criteria in accordance with best practice methods and the GiGL data standards.

1.4.2 The Council plan to conduct a consultation exercise in the new year and will encourage, welcome, and appreciate the views of the Membership of the Welsh Harp Joint Consultive Committee.

#### 1.5 **West Hendon Playing Fields Master Plan**

1.5.1 Engagement Launch: Barnet Council, in collaboration with design partners Ove Arup & Partners, has initiated the first phase of public engagement for the West Hendon Playing Fields redevelopment.

1.5.2 Engagement Strategy & Plan Development: A comprehensive engagement strategy and plan were meticulously developed over several months. Input from key stakeholders and Members was solicited during the strategy development. Final approval for the engagement plan has been successfully obtained.

- 1.5.3 The first two formal community engagement activities took place in November 2023; These activities aim to actively involve the community in informing the design development for the playing fields.

- 1.5.4 Online Engagement Platforms: Engage Barnet and Commonplace have launched engagement platforms for the West Hendon Playing Fields project. Community members can actively participate and provide input through various tools, including: Survey, Interactive map and Memory map for sharing thoughts and experiences.

- 1.5.5 Statutory Consultations: Statutory consultation meetings which have been conducted with key entities so far: Metropolitan Police, Natural England, Sport England. Ongoing consultations are in place to ensure comprehensive engagement with relevant authorities.

## 1.6 **Welsh Harp and SSSI management**

- 1.6.1 Working with our in house and contract network we will be developing an updated litter management regime across the whole of the Welsh Harp and surrounding environs. We are finalising a revised weekly bin collection and litter picking schedule, augmented by a contractor deep clean in January 2024.

- 1.6.2 We are also investigating options to replace the public bird hide with a solution which makes the location less attractive for anti-social use.

- 1.6.3 The council has been consulting with the CRT to assist with the community volunteer days in November 2023 after the winter work and dewatering has commenced.

- 1.6.4 Damage to the SSSI caused by development on neighbouring properties was reported to the Council by members of the WHCG in April 2023. The Planning Enforcement Team are working with Natural England to resolve the issues and served enforcement notices to the address in May 2023. In August, a retrospective application for the construction work (23/2569/RCU) was refused by the London Borough of Barnet Planning Department. On the week commencing 13<sup>th</sup> November 2023, Barnet Planning Enforcement served a notice to the property owner requiring the demolition of the outbuilding and the removal of the constituent materials from the property within four months of the date of the notice. LBB will continue to monitor to ensure this is done and no further damage is done to the SSSI.

- 1.6.5 The council continues to work in partnership with Brent Council, Canals, and Rivers Trust, The GLA, The London Wildlife Trust and Thames 21 in delivering the overarching Vision for the Welsh Harp and updating the existing Management Plan.

The CRT are leading on two bids to the NHLF and are working closely with Barnet and Brent on the EOI submission. We are also looking at other sources of external funding to deliver the 'Vision,' for example the Mayor of London Rewild London Fund.

## **2. REASONS FOR RECOMMENDATIONS**

- 2.1 The terms of reference of the Welsh Harp Joint Consultative Committee include that it considers and co-ordinates all the interests of recreation, leisure, maintenance, and nature conservation with the object of protecting the Welsh Harp Reservoir and surrounding open land as a unique environment for both recreation and wildlife conservation.

The Local Authority has the power under Section 21 of the National Parks and Access to the Countryside Act 1949 to acquire, declare and manage nature reserves. However,

English Nature must be consulted by the Authority in the use of the powers given by section 21. The 1949 Act states that a Local Nature Reserve (LNR) must be managed in such a way to ensure that use of the site does not result in any damage to its natural features.

5.4.2 As set out in the Terms of Reference of the Joint Committee:

To consider and co-ordinate all the interests of recreation / leisure / maintenance / nature conservation and statutory requirements of the Canals and Rivers Trust (CRT) and the Environment Agency at the Welsh Harp; with the object of protecting the Welsh Harp Reservoir and surrounding open land as a unique environment for both recreation and wildlife conservation.”

Barnet’s Constitution – Article 8 – Joint Arrangements- states at paragraph 8.1 that the Council may establish joint arrangements with one or more Local Authorities. Such arrangements may involve the appointment of a Joint Committee with these Local Authorities.

## 1.0 Purpose of the Report

1.1 This report presents progress on the Brent Reservoir / Welsh Harp Management Plan since the last meeting of the Committee and during the 2023/24 year to date. The Management Plan is jointly managed by the three main land-holding organisations: Brent Council, the London Borough of Barnet, and the Canal & River Trust.

## 2.0 Recommendation(s)

2.1 Members are asked to note the Report.

## 3.0 Detail and Contribution to Borough Plan Priorities

3.1 Welsh Harp 'Vision':

The 'Welsh Harp Vision' was published in July 2023. The Vision has been prepared by the Canal & River Trust, Barnet Council, Brent Council, the London Wildlife Trust, Greater London Authority, Thames 21 and other partners.

### 3.2 Management Plan:

The current version of the Welsh Harp / Brent Reservoir Management Plan, (dated 2016 but a long-term management plan) is available from Brent Council. Refer to the Action Plan (3.3).

### 3.3 Action Plan:

The Welsh Harp / Brent Reservoir Management Plan includes an Action Plan that lists current year progress and actions that may require a longer time - frame and/or for the resources to be identified to undertake the action. For this committee the Action Plan is updated as Appendix A. The Action Plan provides notes and updates on issues and projects, rather than listing the details in this covering report. The 'Progress' column indicates current progress.

### 3.4 Grounds maintenance contractor:

A new grounds maintenance contract commenced on 1<sup>st</sup> August 2023 for the operational works in Brent Council's parks and open spaces. This includes the Welsh Harp Open Space, Neasden Recreation Ground and Silver Jubilee Park. The contractor is Continental Landscapes Ltd.

### 3.5 Marshland work:

A site meeting was held with officers of the Canal & River Trust in early October 2023 as to options to re-start work to manage the growth of scrub on the marshland of the shores alongside Neasden Recreation Ground. Previous work to manage the marshland on the shore of the Welsh Harp Open Space provided for a range of conservation, landscape and recreational (water wind sports) needs, while retaining also a variety of trees within the marshland. However, shade is continuing to reduce the marshland vegetation on the south-western shore of the reservoir alongside Neasden Recreation Ground.

### 3.6 Welsh Harp Environmental Education Centre:

Officers of Brent Council are working to consider the potential details for a Welsh Harp Centre to replace the current portacabin building. This follows a decision by Brent Council's Cabinet in May 2023 to approve proposals, as in the report for that Agenda, for the future of the Welsh Harp Centre as a post-16 skills resource centre for young people and young adults with special educational needs; and to enable horticulture, work experience and volunteering opportunities. There is the potential for use at other times by third sector and community organisations. Currently, Thames 21 are continuing to provide some limited services at the existing Centre.

### 3.7 Healthy Walks programme:

The walking programme continues. The Welsh Harp walks are on Thursdays from 10am to 11am, meeting at the Welsh Harp Open Space end of Birchen Grove, Kingsbury NW9. For details please email [healthyliving@brent.gov.uk](mailto:healthyliving@brent.gov.uk)

### 3.8 Brent Reservoir de-watering:

The Canal & River Trust will probably elaborate during their report, but they ask us to emphasise the need to keep out of the reservoir, during the de-watering from mid-November 2023 until the end of February 2024. The reservoir water-level is being reduced to enable works on the dam wall and associated mechanisms, while the low water level will enable works on some marginal areas particularly in the eastern marsh. The reservoir contains varying depths of alluvium ('mud') which can be dangerous to attempt to walk upon. The Canal & River Trust are providing signage around the reservoir. For those who may wish to be involved in the clean-up of the reservoir, the Canal & River Trust are providing information about organised projects on their website and contact information regarding the reservoir.

### 3.9 Pollution incidents:

Refer to the Environment Agency. A fly-tip on the southern side of the Welsh Harp is being investigated by the Canal & River Trust.

### 3.10 Priestley Way Trash Screen:

The Environment Agency attend the Priestley Way screen on a fortnightly basis to use a grab lorry to clear the screen. The Environment Agency have requested a reminder that other than of their trained teams, there should be no accessing of the trash screen beyond the fence and gate into the trash screen area. Signage is provided on the screen's exterior fence.

## 4.0 Financial Considerations

4.1 The Brent Reservoir / Welsh Harp Management Plan is primarily a land-use document to guide land managers and others in the maintenance, management and legislative issues affecting the land management of the Brent Reservoir and associated land. The Brent Reservoir / Welsh Harp Management Plan also has a forward planning role, particularly in identifying the needs of land management over timeframes into the future.

4.2 The actions in the accompanying Action Plan (Appendix A) are achievable over varying timeframes, though many are not affordable within existing budgets in the short term. The actions will be closely monitored, prioritised and re-profiled to ensure there are existing resources available to mitigate against any possible overspends. More details of works are included in Appendix A. Where those works are not currently achievable, the Action Plan highlights key issues. Works are only undertaken when approved by the service responsible for delivering the works within existing approved budgets.

4.3 As is being reported to the Committee, the main land-holding organisations at the Welsh Harp and some other organisations are currently working on a 'vision' exercise, which will include a review of possible sources of funding and income for those works currently not affordable.

## **5.0 Legal Considerations**

- 5.1 Brent Reservoir / Welsh Harp is a designated 'Site of Special Scientific Interest' ('SSSI'). Section 28E of the Wildlife and Countryside Act 1981 as amended by the Countryside and Rights of Way Act 2000 ('CROW') and the Natural Environment and Rural Communities Act 2006 (NERC) sets out the duties in relation to SSSIs. Land owners or occupiers, and also public bodies, are required to give notice to and consult with Natural England where they wish to carry out, or cause or permit to be carried out any operation in an area of land that is of special interest by reason of any of its flora, fauna, or geological or physiographical features (this requirement applies to operations within a SSSI, and to operations outside the SSSI that may affect the features of interest). Natural England will issue consent, which may have conditions or refuse consent. It is a criminal offence to carry out a listed operation without Natural England's consent or to ignore any conditions of a consent which may result in an unlimited fine and a restoration order. CROW (and section 28G of the Wildlife and Countryside Act 1981) places a duty on all public bodies to take reasonable steps, consistent with the proper exercise of the authority's functions, to further the conservation and enhancement of a SSSI. When advice is obtained from Natural England prior to carrying out the works, an explanation of how the Council has taken into account any advice Natural England has given should be provided –

The Council must be able to show that it considered alternatives that could reduce the impact on the SSSI and the methods being used are those that cause as little damage as practicable to the land:

The Council should demonstrate how it has assessed differing interests (including the special interests of the SSSI) before deciding to go ahead with the works.

- 5.2 It is good practice for landowners or occupiers to produce Management Plans for the SSSI, which when approved by Natural England, enable the carrying out of the works specified in the Management Plan. This can reduce the administrative work inherent in obtaining consent for individual items of management work.
- 5.3 The Natural Environment and Rural Communities Act 2006 requires that all public authorities in England and Wales, when exercising their statutory functions, must have regard to the conservation of biodiversity, so far as is consistent with the proper exercise of their functions.
- 5.4 Section 28Q of the Wildlife and Countryside Act 1981 requires the owner of land included in a SSSI to inform Natural England within 28 days of any changes in ownership or occupation of the site, including leases, easements and rights.

## **6.0 Equality, Diversity and Inclusion (EDI) Considerations**

- 6.1 Decision makers must have due regard to the public sector equality duty in making their decisions. The public sector equality duty is set out at section 149 of the Equality Act 2010 and is as follows:

A public authority must, in the exercise of its functions, have due regard to the need to:

- (a) eliminate discrimination, harassment, victimisation and any other conduct that is prohibited by or under this Act;
- (b) advance equality of opportunity between persons who share a relevant protected characteristic and persons who do not share it;
- (c) foster good relations between persons who share a relevant protected characteristic and persons who do not share it.

In terms of advancing equality of opportunity, this means to:

- (i) remove or minimise disadvantages suffered by persons who share a relevant protected characteristic that are connected to that characteristic;
- (ii) take steps to meet the needs of persons who share a relevant protected characteristic that are different from the needs of persons who do not share it;
- (iii) encourage persons who share a relevant protected characteristic to participate in public life or in any other activity in which participation by such persons is disproportionately low.

In terms of:

- (a) Tackling prejudice, and
- (b) Promoting understanding,

The relevant protected characteristics are:

- Age
- Disability
- Gender reassignment
- Pregnancy and maternity
- Race,
- Religion or belief
- Sex
- Sexual orientation
- Marriage and Civil partnership

6.2 At this stage, no potential adverse impact arising from the recommendations in this report has been identified.
