 - a) 2 appointed by the London Diocesan Board for Schools
 - b) 2 appointed by Central Barnet Deanery Synod
 - c) 2 appointed by the Parochial Church Council of Christ Church Barnet
7. The holder of the following office shall be a foundation governor ex-officio:
 - a) The Vicar of Christ Church Barnet
 - b) The Archdeacon of Hampstead shall be entitled to appoint a foundation governor to act in the place of the ex-officio governor whose governorship derives from the office named in (a) above, in the event that that ex-officio governor is unable or unwilling to act as a foundation governor, or has been removed from office under regulations 23(2) of the Regulations.
8. The Archdeacon of Hampstead shall be entitled to request the governing body to remove the ex-officio foundation governor referred to in 7 above and to appoint any substitute governor
9. **Ethos statement:**
Recognising its historic foundation, the school will preserve and develop its Christian character in accordance with the principles of the Church of England and in partnership with the Church at parish and diocesan level.

The school aims to serve its community by providing an education of the highest quality within the context of Christian beliefs and practice. It encourages an understanding of the meaning and significance of faith, and promotes Christian values through the experience it offers to its pupils.

10. With the exception of the Head Teacher and the vicar Of Christ Church, Barnet (whose membership is co-terminous with their appointments), the term of office of all Governors is four years.
11. The instrument of Government comes into effect on **1 September 2015**.
12. This instrument of Government was made by order of the **London Borough of Barnet Local Education Authority on 30 June 2015**
13. A copy of the instrument must be supplied to every member of the governing body (and the head teacher if not a governor), and to the London Diocesan Board for Schools.
