Summary

At their meeting on 6 July 2015, the Committee received a Member's Item in the name of Councillor Mittra. After considering the Member's Item, the Committee resolved to receive a report from NHS England at their October meeting addressing the issue of dentistry in Barnet as well as the recommendations made in the recent Healthwatch Barnet report as referred to in the Member's Item.

There was no representation from NHS England at the October meeting and so the Committee have requested that the item is received again. NHS England has provided an updated version of the report that they submitted in October 2015. In addition, the two reports supplied by Healthwatch Barnet have been re-attached (at Appendix B and C) At the meeting in October 2015, Healthwatch Barnet informed the Committee that would be undertaking a mystery shopping exercise. As per the Committee's request, this report is attached at Appendix D. A response from NHS England on the mystery shopping exercise

is set out at Appendix E. Representatives from both NHS England Healthwatch Barnet have been invited to attend the meeting.
