#### Issue

London Borough of Barnet (LBB) faces a significant challenge in the provision of Adult Services, with a need to make budget savings while coping with growing demand. In order to reduce the projected increase in demand for Adult Services, LBB is developing a new operating model, which radically redesigns the way Adult Services are delivered by changing the way residents interact with LBB to manage their health, wellbeing and care needs.

The scope of the new operating model covers all adult social care (ASC) services provided by LBB, including preventative services, first point of contact services, assessments and reviews, short and long term support provision, information and advice, and includes all service user groups: adults with learning disabilities, mental health needs, physical disabilities or sensory impairment, older people and carers.

The Council Medium Term Financial Strategy (MTFS) has identified savings of £2m from Adults Services from 2017/18 to 2019/20 for the identification of alternative delivery models, and £0.8m in 2019/20 for Family Services looking at emerging best practice across the country to ensure the highest quality of purposeful social work and wider children's service.

#### Requirement

PA Consulting role and deliverables in the development of the Business Cases is defined as:

- Options Modelling: Add further detail in terms of the following:
  - 1. Methodology as to the costing of each benefit type
  - 2. Economic appraisal of each option (Net Present Value, and detailed costing)

- 3. Analysis of cost of risk, as appropriate
- 4. Sensitivity Analysis
- 5. Output will be a detailed Microsoft Excel Financial Model
- Analysis of Affordability: Analysis of the impact on affordability i.e. degree to which the MTFS is met. The output of this activity would be incorporated in the financial model referenced above.
- **Drafting Notes for the Business Case:** Drafting of quantitative assumptions and notes in support of the above analysis.
- Demand Modelling: Wider support modelling for the Adults Transformation programme, around demand modelling for care provision across all user groups.

#### Cost

The total cost is £69,820 excluding VAT

#### **Budget**

The costs will be met from existing project budgets

## Single tender justification

The Procurement Forward Plan agreed at Policy & Resources Committee on the 16<sup>th</sup> December 2015, includes Ref 54/55 Adults Future Operating Models to a combined total of £75k.

PA Consulting is the market leading government business case experts, from which the Council have previously benefited from this expertise.
