Acceptance of quotation for proposed building at Oak Hill Satellite Depot	05/05/2017	Commissioning Director - Environment	This report seeks approval to appoint Cleveland SiteSafe Ltd to undertake supply and installation of a replacement park depot building at Oak Hill Park, following demolition of the existing building/ enabling works by others. The existing building is unsafe and requires replacement urgently.  Discussions have involved the Leader of the Council with regard to timing of provision and appearance of the replacement building. The proposal forms part of the Council's programme to relocate Depot facilities from Mill Hill. The Mill Hill Depot ("the Depot") is currently the base for the Street Scene and other London Borough of Barnet operations.  In 2011 the Council entered into a landowners' joint venture agreement with private partners to facilitate the comprehensive redevelopment of the Mill Hill East area in line with the Mill Hill East Area Action Plan (MHEAAP). This agreement delivers a £40m benefit to Barnet tax payers.  The Council is required under the terms of the contract to give up vacant possession of the Mill Hill Depot to the joint venture consortium.  The building in Oak Hill Park is part of the programme of works that will facilitate vacation of the Depot, so the replacement building

			needs to be in situ as soon as possible to enable the use of Oakhill Park as a satellite depot. Procurement for works under the Depot Relocation Project has been authorised via inclusion in the Annual Procurement Forward Plan.  Competitive quotations for the works were sought through the E-Portal and on Contracts Finder in line with the Council's Contract Procedure Rules, with award criteria based on quality and cost. Thirteen suppliers expressed an interest in the contract but twelve subsequently did not submit a quotation. Cleveland SiteSafe Ltd submitted the only compliant
