Increased hours of working and days of the week (8-8, 7 days per week) – higher numbers of ASC staff now working</p>	<p>Covid-19 Hospital Discharge Service Requirements guidance, published 19<sup>th</sup> March 2020 by HM Government and NHS England. The guidance states that the NHS will fully fund the cost of new or extended out of hospital care and support packages. The financial impact of new service will be recovered from NHS England via the CCG.
