# **Summary**

The report seeks approval for the award of contracts to the providers set out in Appendix D for the provision of hired transport services for children and adults and authorisation for Barnet Education and Learning Service Ltd to manage these contracts and the extended contracts with providers listed in Appendices A to D.

# **Decisions**

- 1. To approve the award of contracts to the transport providers set out in Appendix D for the provision of hired transport services for children and adults following the Dynamic Purchasing System (DPS) procurement process, as set out in the Policy and Resources Committee report dated 21 March 2017.
- 2. To approve the proposal to extend the existing DPS for a further four years.
- 3. To authorise Barnet Education and Learning Service to continue to manage contracts with individual providers on the Council's behalf including contracts with those providers listed in Appendices A, B, C and D and any further contracts let through the DPS procurement process.

#### 1. WHY THIS REPORT IS NEEDED

- 1.1 The report is needed so that approval can be given to the award of contracts to the providers set out in Appendix D for the provision of hired transport services for children and adults following the Dynamic Purchasing System (DPS) procurement process, as set out in the Policy and Resources Committee report dated 21 March 2017.
- 1.2 Barnet Educational Learning Service is contracted to provide the brokering of transport for pupils with SEN, Family Services and Adult Services and the commissioning and contract management in relation to operational delivery on an agency basis on behalf of the Council. The contracts with the providers will be with the Council but Barnet Educational Learning Service will manage the contracts as the Council's agent.
- 1.3 During the school year, additional individual transport routes are required at short notice. This report records a decision to authorise Barnet Education and Learning Service to manage any further contracts let through the DPS procurement process in order to meet demand that arises during the remainder of the school year 2020/21.

## 2. REASONS FOR RECOMMENDATIONS

- 2.1 On 21 March 2017, the Policy and Resources Committee authorised commencement of the DPS (Dynamic Purchasing System) procurement process and commissioning of Cambridge Education to procure hired transport services for children and adults on the Council's behalf, in accordance with the strategic partnership contract between the Council and Cambridge Education.
- 2.2 The contract between the council and Cambridge Education came to an end on 31 August 2020 and was novated from Cambridge Education to Barnet Education and Learning Service Ltd on 1 September 2020.
- 2.3 On 18 August 2017, an officer DPR was approved (see background papers), which agreed, following the DPS procurement process, to the award of contracts to the transport providers set out in the Appendix to the report for the provision of hired transport services for children and adults and to authorise Cambridge Education to manage contracts with individual providers on the Council's behalf, including contracts with those providers listed in Appendix A (attached to this report) and any further contracts let through the DPS procurement process.
- 2.4 On 14th June 2019 an officer DPR was approved for the school year 2018-19 which agreed a further 45 routes that were let through the DPS procurement process, which are listed in Appendix B.

- 2.5 For the school year 2019-20 a further 30 routes were let through the DPS procurement process, which are listed in Appendix C.
- 2.6 In order to ensure that all contracts let through the DPS are formally recorded and approved, an annual DPR is published listing all additional contracts awarded since the last DPR was published. For the school year 2020-21 a further 36 routes have been let through the DPS procurement process, which are listed in Appendix D. This DPR is seeking approval for these contracts.
- 2.7 These individual contracts are let under a DPS that forms the main contract between the council and those providers who apply for and meet the qualification requirements for contracts let under the BELS Dynamic Purchasing System. The initial DPS was for four years, from 2017 to 2021. Following legal advice, it has been confirmed that the DPS may be extended, as this offers better value for money than a full re-tendering exercise would. It is therefore proposed to extend the DPS for another 4 years.
- 2.8 New providers may apply to join the DPS at any time and are admitted if they meet the qualification criteria. All providers may then bid for individual routes through the BELS Dynamic Purchasing System.
- 2.9 A further Delegated Powers Report will be submitted in due course in respect of routes let under the DPS for the school year 2021-22.

#### 4. POST DECISION IMPLEMENTATION

4.1 Contracts are awarded through the DPS. This DPR confirms approval for those contracts and ensures the contracts and decisions are published.

#### 5. IMPLICATIONS OF DECISION

## 5.1 Corporate Priorities and Performance

- 5.1.1 The quality of the education offer is at the heart of Barnet's continuing success as a place where people want to live, work and study. Excellent educational outcomes are key to deliver the Council's vision set out in its Corporate Plan 2015-20 for Barnet's children and young people to receive a great start in life'.
- 5.2 Resources (Finance & Value for Money, Procurement, Staffing, IT, Property, Sustainability)
- 5.2.1 The total value of transport services subject to the DPS was approximately £1.6 million in 2018-19 and remained at approximately £1.6 million in 2020-21.The

- contract extension value will continue to remain at £1.6 million per annum totalling £6.4 million for the next four years.
- 5.2.2 The budget for these contracts is held by BELS Ltd and is funded through the service fee paid to BELS under the contract between the council and BELS. There are therefore no financial implications for the council.

## 5.4 Legal and Constitutional References

- 5.4.1 The Council's Contract Procedure Rules Appendix 1 Table A states that acceptance of procurements valued at £181,302, if within budget and agreed savings target on forward plan, must be by a full officer DPR (Chief Officer in consultation with the Chairman of the relevant committee).
- 5.4.2 As per 5.2.2 above the extensions are within the budget held by BELS and the authorisation in the form of a DPR complies with the authorisation requirements found in Table B of Article 10 of the Constitution.
- 5.4.3 The extension of the Dynamic Purchasing System itself must comply with regulation 34 (28) (b) of the Public Contract Regulations and a form of notice should be used as notification that the period of validity has changed. The form of notice should be the same as that used for the initial call for competition.
- 5.4.4 Although it is not clear under the PCR 2015 whether regulation 72 would absolutely apply to extensions of a DPS it is considered that if it does apply, then either regulation 72 (1) (c) or regulation 72 (1) (e) can be used to undertake the modification lawfully. The DPS is open to any economic operator throughout its period of validity.

# 5.5 Risk Management

5.5.1 If the Council does not enter into contracts for the provision of hired transport services for children and adults effectively and efficiently it could lead to a detrimental impact on value for money and the likelihood of delivering procurement savings.

## 5.6 Equalities and Diversity

5.6.1 The 2010 Equality Act outlines the provisions of the Public-Sector Equalities Duty which requires Public Bodies to have due regard to the need to: eliminate unlawful discrimination, harassment and victimisation and other conduct prohibited by the Equality Act 2010; advance equality of opportunity between people from different groups; foster good relations between people from different groups. 5.6.2 The broad purpose of this duty is to integrate considerations of equality into day to day business and to keep them under review in decision making, the design of policies and the delivery of services.
