Summary

This report informs the Area Committee that the applications listed under section 1 for Neighbourhood CIL funding have been submitted. The Committee are requested to consider the information highlighted within this report and decide on its desired course of action in accordance with its powers.

Officers Recommendations

1. WHY THIS REPORT IS NEEDED

1.1 Applications for funding from the Committee's allocated NCIL budget have been raised. The applications are as follows:

Member Request	<p>The Hope Community Centre plays an essential role in bringing the Dollis Valley and Underhill together as one community. It provides a wide range of facilities and community services to the local community. Of course, like every other community provider it has been hit by the Covid crisis and it has seen reduced income due to the lockdowns, prolonged closures and lack of use by local residents. Lettings and café incomes were badly hit and six members of staff placed on furlough.</p> <p>Two projects that have been particularly adversely affected are the Lunch Delivery Service and the Homework Club + Catch-up Maths.</p> <p>The Lunch Delivery Service continued until the Covid lockdown restrictions were lifted in May 2021. Many now attend the weekly lunch club at the Centre, however, some 10-12 local residents were</p>

still in need of delivered lunches due to fear of venturing out or lack of mobility contracted through not going out during the Covid period. The Centre wishes to run this meal delivery service through to March 2022 when it will review the situation. The costs are for food/packaging (£3,000) and employment of a cook (£1,150) giving a total of £4,150 to run this service through to next March. All the recipients of this service live in Underhill Ward and the service is greatly appreciated by all recipients.

The second project is the Homework Club + Catch-up Maths. This service takes place three afternoons per week after school during term time. Due to the impact of Covid on schooling there has been extra demand for maths tuition as many children found this a difficult subject on virtual learning and have fallen behind on this vital subject. For a full year the costs are Tutor (for 40 weeks @ 7 hours p/w) £5,684, computer licences/student resources £1,400, administration £300, publicity £300, contingency £200, giving a total of £7,884. This highly successful club provides a much sought after educational boost to pupils of Underhill School, St Catherine's Primary School, Totteridge Academy, QE Girls School all local to Underhill.

Combined these two services need a total of £12,034. In Underhill 15.6% of children are in relatively low income families compared to 13.6% for Barnet as a whole. Pupil attainment at key stage 4 is lower in Underhill than the Barnet or London averages.

Hope Centre Manager Sue Day said: "We did not expect to have to run the lunch deliveries for so long, but isolated and homebound local residents have really appreciated this service. The Homework Club has been adjusted to allow children to catch up on subjects they have fallen behind during Covid, so it is really appreciated and other subjects are now being offered along with the use of laptops and printing."

It is made up of youth practioners and young community champions who want to make a difference through proactive social action using a community café & restaurant to empower, engage and educate young people through promoting their enterprise. https://youtu.be/tnRZMSZVaWw provides more information.</p> <p>The request is to provide money to fitting out a [already purchased] black cab as a mobile kitchen and the necessary training for young people to run their own business. Training will include food hygiene, keeping accounts, engaging with supply chains, etc. The capital work on the cab is £1400 plus VAT = £1680 with £320 towards training costs. If successful any surplus goes towards expanding the project with a second vehicle. The community benefit is to help provide work for local young people whilst giving them the entrepreneurial skills and experience to improve their life chances, many of whom have few other opportunities that this unique project provides. The intention is to use it at festivals, outside tube stations and at Saracens [who they have already talked to].</p>

Halliwick recreation ground is a well-used amenity located close to the border with Haringey and Coppetts Wood primary school.

Local residents have taken it upon themselves to do a survey asking what improvement people would like to see. This was sent to green spaces who have looked at the survey and given a view as to what is possible or feasible. This will be carried forward in the new year by drawing up a plan for this area and seeing what other funding / grant streams can be accessed.

This application is for one item on the residents wish list this being refurbishment of the tennis courts and the surrounding fencing. At the moment they can only be described as not fit for use as the ground surface is broken up in places. The friends group are having regular meetings and this has been flagged up as the one item they would have difficulty finding enough grant or fundraising funds for.

Currently any usage of the courts is free, but due to the condition they are underutilised, with only 4% of the available court time being booked and has the third lowest number of court hours booked out of all 20 locations. (data provided and confirmed by Matt Gunyon at Green spaces)

The area profile data for Coppetts ward shows that under 'family friendly information', the level of children in relative low income is slightly higher than the Barnet average. What we know as local councillors from our casework is that the N10 side of our ward on the south side of the north circular where Halliwick rec ground is located has more deprivation than the north N11 side. Yet the number of physically active adults

physically active two times a month is 69% slightly higher than the London level at 66% and the Barnet level of 67%. This suggests that there would be a demand for use if the courts were to be refurbished. Backed up by the surveys that the Friends group has carried out and with both adults and children requesting this refurbishment. This proposal aligns with the committee's annual priority to support the provision of infrastructure within parks and open spaces.

For anyone not knowing the area it is next to Coppetts Wood primary school where one of the exits leads directly into the recreation ground, a route used daily by parents and children who long to see improvements to a rather barren area. The success of Emma Radacanu is firing their desire to have usable and safe courts on which to play and practice.

This will be a large project which, if the committee supports, could be spread over two years. Council could then decide if there should be a nominal charge for usage.

In consultation with (e.g. named Officer):	<p>Officer: Iliana Koutsou, Programme Manager Special Projects, Estates</p> <p>This report requests match funding for the restoration of the Grade II listed Peace Statue, Friary Park, Friern Barnet.</p> <p>The Council is aiming to restore the Peace Statue in early 2022. The contractor quote to restore the statue is estimated at £37,000, not including the cost of replacing the statue's spear with an historically accurate sceptre and dove estimated at £4,122, bringing the total cost to £41,122.</p> <p>The Council's Estates Department, which has a limited heritage budget and responsibility for maintaining over 20 listed monuments, has committed to meeting at least half the restoration costs. The match funding being sought therefore totals £20,526 including</p>

The Peace statue, owned by the Council, is in urgent need of restoration having undergone no known repair or maintenance since its unveiling in Friary Park in 1911. Most alarmingly in recent years the casting has started to crack. Due to the monument's historic significance and Grade II listed status it can only be restored by a team of specialist contactors.

Please see additional background historical information below.

The breakdown of the projected restoration costs can be provided if considered necessary by the Committee Chairman or lead officer.

This request falls within the Open Space CIL Funding Priority.

This project has been initiated by the Council's Heritage Champion, Councillor Stephen Sowerby, in consultation with the Friends of Friary Park, The Finchley Society, Friern Barnet and Whetstone Residents Association and Friern Barnet & District Local History Society.

Background

The Peace Statue was sculptured in the early 1860s and presented to Friary Park in 1911 by Sydney Simmons, who also gave his land for the creation of the park. The monument remains the central feature within the park landscape dramatically overlooking the park on its rocky promontory.

The statue was sculptured by Joseph Durham and is a portrait of the young Queen Victoria dressed as an allegory of Peace and Plenty, Mother of the

Nation. The monument was sculptured using the new Victorian electrotype method of casting.

The statue was originally conceived as the surmounting sculpture of a memorial commemorating the Great Exhibition of 1851. However, on the death of Prince Albert, who had initiated the Great Exhibition, the Queen considered a monument immortalising the Prince Consort, rather than herself, would be more appropriate and so the Peace statue was never used as intended.


The statue was nationally listed as a Grade II historic monument in 1983 and in terms of its rich history and fine craftsmanship is arguably the London Borough of Barnet's most significant public monument.

Dove & Sceptre

The spear as seen on the current sculpture is not original to Joseph Durham's design creation. The sculpture of the Queen when made and exhibited in the gardens of the Royal Horticultural Society until 1888 held in her left hand an elongated version of the rod (sceptre) of equity, bearing at its top a dove mounted on a globe - not the spear.

To further exemplify the contemporary interest in new materials and techniques, the dove was specified to be cast in aluminium, which at the time was a rare and very costly material, with the globe being either glass or enamelled.

This replacement with a spear is therefore allegorically inaccurate, this being an incorrect attribute for an allegory of peace and plenty. As no record has been found describing where the statue was placed between

Title	Hadley Green Litter Bins

Member Request:	<p>Hadley Residents Association have written to me on the following, regarding the provision of 20 modern covered litter bins.</p> <p>They write: There are currently 25 bins on Hadley Green 9 of which are in good condition, 16 of which are broken or in poor condition. Very few are of a design that prevents birds and animals foraging in them which increases litter and could be hazardous and most of them do not provide the capacity that is required to stop them overflowing prior to collection.</p> <p>There are a variety of different styles of bin that have accumulated over the years, selecting a single, suitably robust design of bin would improve the appearance of the Green and encourage people to use the bins more. Some of the bins have not been well placed; for example, to place bins next to benches and parking places to encourage use and to de-clutter the area around Brewery Pond where there are 6 bins but there are no bins on Old Fold pond.</p> <p>The HRA conducted a 'Bin and Bench' survey in 2019 plotting where all the assets were, describing their condition and recommending locations for future placement. This was made available to Barnet Council's Parks and Open Spaces team and they have used the survey to inform their decisions on bench</p>

	<p>replacement and placement. I can provide this information and images of the current path / trail if you feel it may help.</p> <p>We are aware that the Community Infrastructure Levy fund, (CIL), is available to pay for infrastructure projects of this nature and has been used to good effect to pay for the purchase and installation of a number of playgrounds and other enhancements to the Boroughs' parks.</p>
<p>Funding Requested (£):</p>	<p>£10k</p> <p>Mat Gunyon and Rob Wiltshire have provided an estimate for the replacement of litter bins.</p> <p>They have also confirmed that there are currently no plans or monies allocated for the replacement of these bins within their plans.</p> <p>Chipping Barnet Area Committee has set a priority for this year to support infrastructure in parks and green spaces so I see this aligning with that priority.</p>

<p>Member Request:</p>	<p>During the planning for and delivery of New Barnet Leisure Centre, a high-level master plan for the wider surrounding green space in Victoria Recreation Ground was prepared. The draft master plan proposed significant transformative designs in the park, including new community spaces, landscaping, and outdoor games and activity equipment. To the disappointment of residents, the draft master plan remains unfunded, and has been shelved indefinitely.</p> <p>Victoria Recreation Ground should not miss out entirely on new investment simply because we are not in a position to fund the full extent of the Council's vision. I am requesting CIL funding to enable design and implementation of an outdoor gym in Victoria Recreation Ground – to expand the immediate demographic appeal of the park, and as</p>

the first step in realising the best, most effective suggestions from the masterplan.

The recent period of pandemic lockdowns, which included prolonged closure of facilities at New Barnet Leisure Centre, drew community attention to the absence of outdoor exercise equipment in Victoria Recreation Ground. There is no other outdoor gym equipment nearby, and demand for use of the outdoor gym on the other side of the ward, in Oak Hill Park, has frequently exceeded availability throughout the pandemic period.

The ongoing planning permissions and new planning applications for significant development in and around the Victoria Quarter site, with hundreds of new households set to move into close vicinity of Victoria Recreation Ground in the next few years, makes it particularly urgent that we invest in facilities in Victoria Recreation Ground that can enable residents in this part of Chipping Barnet – on the border of three wards – to live fit and active lives.

The outdoor gym would comprise:

- Flex wheel and leg lift
- Steps
- Assisted step
- Power bike
- Cross-trainer
- Hand bike
- Four-piece combination
- Signage

Details and illustrations are set out in the attachment.

	<p>Following discussion on-site, the current proposal is to locate the outdoor gym equipment in the vicinity of the children's and junior play areas. This is subject to change, but the gym will in any event be located within the boundaries of Victoria Recreation Ground.</p>

REASONS FOR RECOMMENDATIONS

- 1.2 The Committee is requested to decide in respect of each application submitted by Ward Members for Neighbourhood CIL Funding, in line with its terms of reference set out in Article 7 of the Council's Constitution.
- 1.3 The Policy & Resources Committee were requested by the Finchley & Golders Green Area Committee in February and October 2020 to review and clarify the current CIL Funding Policy and Eligibility Guidelines.
- 1.4 On 8th February 2021, the Policy & Resources Committee discussed a report concerning the CIL funding process. It was agreed that each Area Committee should consider, develop and approve their own CIL funding priorities for each financial year starting in 2021/22. In addition, it was recommended that comprehensive guidance be developed for CIL Area Committee Budget and the Road Safety & Parking Fund to ensure that Members can make informed decisions when receiving applications for funding.
- 1.5 At its meeting on 24th May 2021, the Policy and Resources Committee agreed in respect of Area Committees:
 - that each Area Committee be allocated £400,000 of Community Infrastructure Levy (CIL) funding per financial year
 - to remove the funding limit for each individual Area Committee CIL funded project (which will operate within the approved annual budget)
 - the new CIL Funding Application Guidelines and Funding Application Form
- 1.6 The Area Committees have considered and agreed their priorities for CIL funding for 2021- 22 and these can be accessed via the links provided in section 6 under Background papers.
- 1.7 The priorities do not restrict the Area Committees from approving funding requests that are not agreed priorities. The Area Committee could choose to approve something that is not an identified priority providing it meets the legal definition of infrastructure.
- 1.8 The purpose of the priorities is to enable Area Committees to make informed decisions about the requests before them. This will allow each Area Committee to make appropriate decisions on how funding is allocated in line with the specific infrastructure needs of the area.
- 1.9 Community Infrastructure Levy (CIL) is a planning charge that was introduced by the Planning Act 2008 Part II to help deliver infrastructure to support the development in an area. CIL is a standard charge collected from developers on a rate per square metre basis and the funds raised are spent on infrastructure

to support the development of an area. Part of CIL funding is allocated to the Neighbourhood Portion and managed by the three Area Committees for Finchley & Golders Green, Hendon and Chipping Barnet.

- 1.10 For schemes approved by Area Committee for funding above £50,000 these are recognised as more complex to deliver. The relevant Executive Director will ensure the appointment of a senior Council Officer to sponsor the scheme and the coordination of Council services, ensure the appropriate project methodology is adhered to, with the scheme set up for a successful delivery. It is recognised that these schemes may deliver outside of the financial year in which they are approved.

2. ALTERNATIVE OPTIONS CONSIDERED AND NOT RECOMMENDED

- 2.1 Not applicable; Members of the Council are able to submit applications for Neighbourhood CIL funding to the Area Committee via Members' Items. As a result, the Committee are requested to consider and determine the applications submitted by Ward Members. Therefore, no other recommendation is provided from Officers.

3. POST DECISION IMPLEMENTATION

- 3.1 Post decision implementation depends on the decision taken by the Committee, and the assessing officer's recommendation.

4. IMPLICATIONS OF DECISION

4.1 Corporate Priorities and Performance

- 4.1.1 The Community Infrastructure Levy funding supports the delivery of the Corporate Plan objectives: A pleasant, well maintained borough that we protect and invest in Getting the best out of our parks and improving air quality by looking after and investing in our greenspaces Investing in community facilities to support a growing population, such as schools and leisure centres.

4.2 Resources (Finance & Value for Money, Procurement, Staffing, IT, Property, Sustainability)

- 4.2.1 Starting in 2021/22, the Area Committee has an allocated budget for Community Infrastructure Levy (CIL) of £400,00 per financial year. This enables the Area Committees to consider funding a larger number of projects with the opportunity to unlock greater community benefits.
- 4.2.2 The Policy & Resources Committee on 24th May 2021 agreed to remove the funding limit per scheme and that Area Committees operate within their annual budget. This enables Area Committees to consider using the increased CIL

allocation to fund larger projects with the opportunity to unlock significant community benefits.

4.3 Social Value

4.3.1 Requests for Area Committee budget funding provides an avenue for Members to give consideration to funding requests which may have added social value.

4.4 Legal and Constitutional References

4.4.1 Council Constitution, Article 7, Section 7.5 Responsibility for Functions details that the Area Committee is responsible for determining the allocation of Community Infrastructure Levy funding within the constituency subject to sufficient of the budget being allocated to the Committee being unspent.

4.4.2 Council Constitution, Article 2 Members of the Council, Section 2.3 states that a Ward Member will be permitted to have one matter only (with no subitems) on the agenda for an Area Committee where the Member is submitting a request for CIL funding to an Area Committee Budget relating to their Ward. Members' Items for CIL funding Budget must be submitted 10 clear working days before the meeting. Items received after that time will only be dealt with at the meeting if the Chairman agrees they are urgent.

4.5 Risk Management

Applications where limited or no consultation has taken place are likely to be deferred or rejected by committees. This information will enable committees to make informed decisions. There is no prescribed format for supporting information,

but it is recommended that it is sufficient for the committee to make an informed decision.

5 Insight

- 5.1 The Committee may wish to utilise the CIL funding priorities agreed by the Area Committee as a guide towards determining an application. Officers will work on collating key information to assist Members in reviewing priorities including infrastructure needs by constituency area and insight data.
