**Appropriation of land at Brent Cross, Cricklewood (BXC), London**

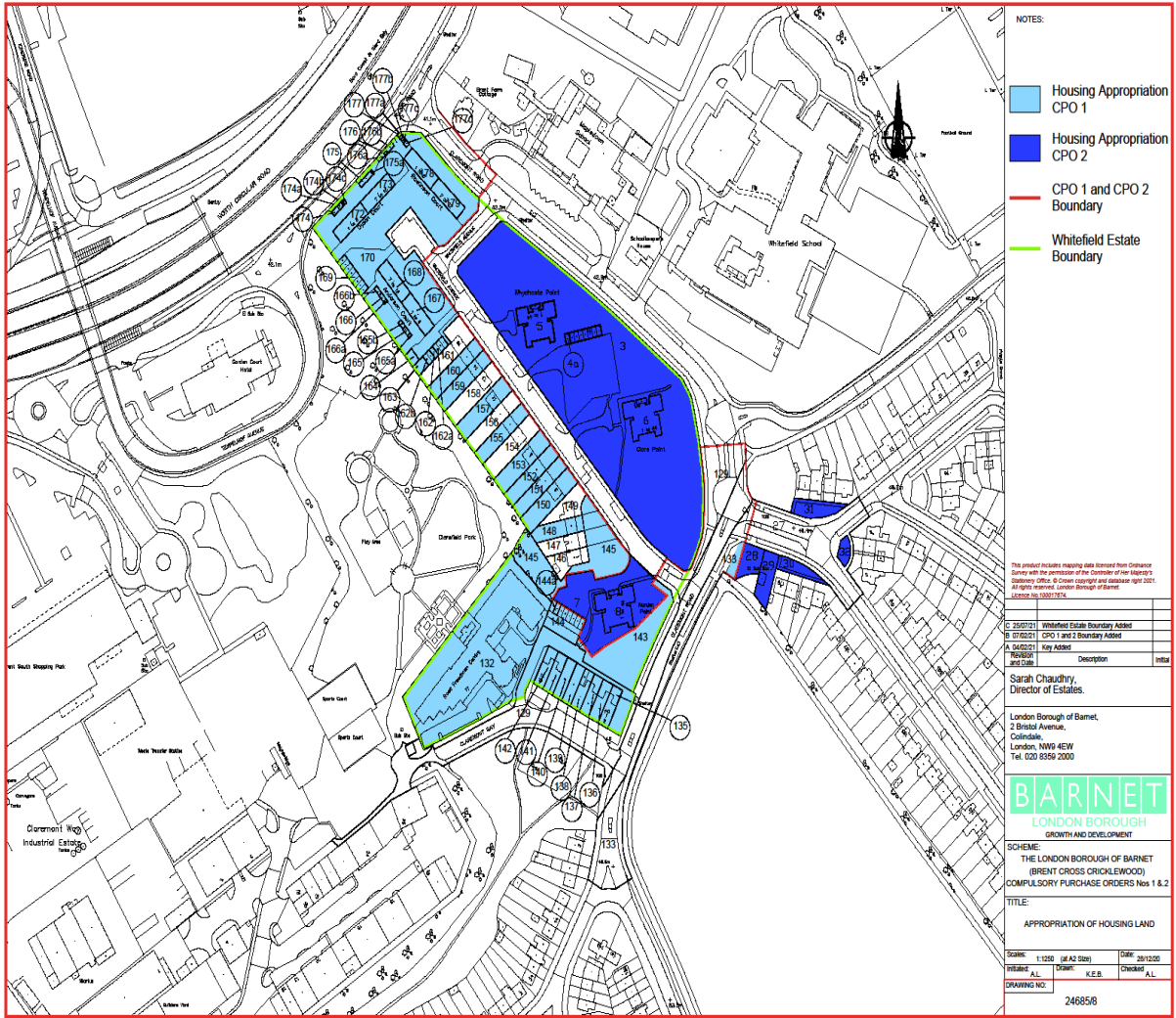
1. Thank for your application of 23rd September 2021 and attached documents for the above consent.
