1	<p>Petition: Response to Engagement on Parking, Finchley Church End Lead Petitioner: Ms Deborah Weinberg Number of Signatures: 128</p> <p>Petitions have been submitted to the Finchley and Golders Green Residents Forum in response to the recent "Engagement on Parking" in Finchley Church End, which ran from early December to end January 2022.</p> <p>In addition to whatever responses were made to the consultation, many residents of Windermere Avenue, Beechwood Avenue, Holly Park, Holly Park Gardens and Orchard Avenue wish to make extremely clear the strength of their opposition to any proposed CPZ.</p> <p>The number of signatures gathered over a very limited time were:</p> <p>44 –Windermere (south of barrier) 25 – Beechwood Avenue 26 - Holly Park 22 - Holly Park Gardens 11 - Orchard Avenue</p> <p>The overwhelming majority of residents believe a CPZ to be totally unwarranted in this area; there is not a perceived problem with parking in any of these streets for which CPZ could</p>	<p>To be dealt with in line with the Council's constitution:</p> <p>The Lead Petitioner will be given three minutes to present the petition to the Forum. Following this the Residents' Forum Chairman will decide to:</p> <ul style="list-style-type: none"> • Take no action; or • Refer the matter to a chief officer to respond to within 20 working days; or • Refer the matter to the relevant Area Committee (if funding is required).
