Summary

This report asks the Sub-Committee to consider an application for a New Premises Licence, under section 17 of the Licensing Act 2003

Officers Recommendations

1. This report asks the Sub-Committee to consider an application for a New Premises Licence, under section 17 of the Licensing Act 2003 for Shell Little Waitrose Mill Hill Apex Corner Northway Circus Mill Hill London NW7 3ET

1. WHY THIS REPORT IS NEEDED

- 1.1 The licensing authority having received a valid representation against the application for a premises licence is expected to hold a hearing to consider those representations. The application can be determined by the licensing authority without a hearing in certain circumstances.

2. REASONS FOR RECOMMENDATIONS

- 2.1 Where a representation is submitted under Section 18 (3) of the Licencing Act 2003 the authority must hold a hearing to consider such representations, unless the representation is withdrawn, the applicant or any party or responsible authority who has made a valid representation agrees or where the authority considers that the representations are frivolous or vexatious.

3. ALTERNATIVE OPTIONS CONSIDERED AND NOT RECOMMENDED

- 3.1 The Licensing Sub-Committee is required to give appropriate weight to the representations (including supporting information) presented by all the parties, the Guidance issued pursuant to section 182 of the Licensing Act 2003, the Council's statement of licensing policy and the steps that are appropriate to promote the four licensing objectives.

Having considered those relevant matters, the Licensing Sub-Committee is required to take such of the following steps (if any) as it considers appropriate for the promotion of the licensing objectives.

The steps are—

(a) To grant the licence subject to—

- (i) conditions that are consistent with the operating schedule accompanying the application modified to such extent as the authority considers appropriate for the promotion of the licensing objectives, and

(ii) any condition which must under section 19, 20 or 21 of the Licensing Act 2003 be included in the licence;

- (b) to exclude from the scope of the licence any of the licensable activities to which the application relates;
- (c) to refuse to specify a person in the licence as the premises supervisor;
- (d) to reject the application

For the purposes of 3.1(a) (i) above, the conditions of the licence are modified if any of them are altered or omitted or any new conditions added.

3. Representations

The Licensing Team received one representation from a local resident. The representation relates to the Licensing objectives of prevention of crime and disorder and prevention of public nuisance.

The Licensing Team did not receive any representations from Responsible Authorities.

4. Attaching conditions

The operating schedule, which is part of the application, includes certain additional steps that the applicant will take to protect the licensing objectives. These will become enforceable conditions, should the licence be granted. Additional conditions may be attached to the licence if the committee thinks it appropriate.

The Committee must have regard to all of the representations made and the evidence it hears, and is asked to note that it may not attach conditions or reject the whole or part of the application merely because it considers it desirable to do so. It must actually be appropriate in order to promote the licensing objectives.

In relation to conditions, the statutory guidance at chapter 10.8 states that, "The licensing authority may not impose any conditions unless its discretion has been engaged following receipt of relevant representations and it is satisfied as a result of a hearing (unless all parties agree a hearing is not necessary) that it is appropriate to impose conditions to promote one or more of the four licensing objectives. In order to promote the crime prevention licensing objective conditions may be included that are aimed at preventing illegal working in licensed premises. This provision also applies to minor variations."

Full Copies of the Councils Statement of Licensing Policy, the Statutory Guidance to the Act and the Council's Guide to Good Practice at Licensed Premises will be available at the Licensing Sub Committee hearing or in advance if required.

This is a well-established convenience store located on a petrol forecourt. The site trades under Shell UK Oil Products Limited and is operated by Subramaniam Luxmanan (the Retailer). The site was previously licensed for alcohol sales 24 hours each day and Late-Night Refreshment 23:00 to 05:00 but the existing store has been knocked down and is in the course of being rebuilt. A new premises licence is therefore being applied for. The new convenience store will trade under the Waitrose format and will have a retail area of approximately 1,291 sq ft. The store serves both the local community along with passing trade. The convenience store operates 24 hours per day Monday to Sunday and deliveries are also offered via a third-party delivery company. The store will stock and extended range of fresh foods and dairy produce, groceries and other domestic products and will also offer 'express' lunch facilities. In addition, dry fuel products such as BBQ charcoal/kindling/logs will be available. Off sales are a standard and expected feature of the convenience store service. The internal and external digital CCTV system will benefit from a recorder with 31-day image retention and recordings can be made available to Police and other enforcement agencies as needed. The convenience store is operated by the Manager assisted by a team of full and part time staff. The Designated Premises Supervisor, is trained and certified through an accredited scheme and is responsible for training all staff- utilising the Lockett & Co Due Diligence package- and keeping complete training records. The Challenge 25 trading initiative will be used supported by the refusals system with records kept in the Refusals Log.

The Premises Licence holder shall be permitted to display bulk stacks, wine towers and chilled promotional offerings throughout the store that may not necessarily be shown on the plan. The locations may be subject to change but will be contained within the red lined licensable area shown on the plan attached to the Premises Licence. The display of bulk stacks will not be located where they may impact on the ability of customers to use exits or escape routes without impediment.

The premises licence holder will require any third party delivery partner delivering on behalf of the premises licence holder to comply with all legal requirements pertaining to the retail sale of alcohol, and in particular to operate a Challenge 25 age verification policy.

The premises licence holder will require all third party delivery partners not to deliver alcohol to schools, parks or playgrounds.

There will be two members of staff on duty between the hours of 23.00 and 05.00 each day. In the event that there is not, the door to the shop will be closed and all service will take place through the night hatch.

b) The prevention of crime and disorder

A suitable and sufficient CCTV system with recording facilities will be in place at site and will operate at all times the premise is open for licensable activities. Images will be retained for a period of no less than 31 days. Access to the equipment and recordings will be provided to the Police or other relevant officers of a responsible authority within 24 hours of the request being made.

Staff will be trained with regard to their responsibilities in the retail sale of alcohol and regular refresher training will also be undertaken (minimum of every 6 months). Written training records can be made available for inspection upon reasonable request by the Police or other relevant officers of a responsible authority.

Spirits (with the exception of spirit mixers and premixed spirit drinks) will be located behind the counter.

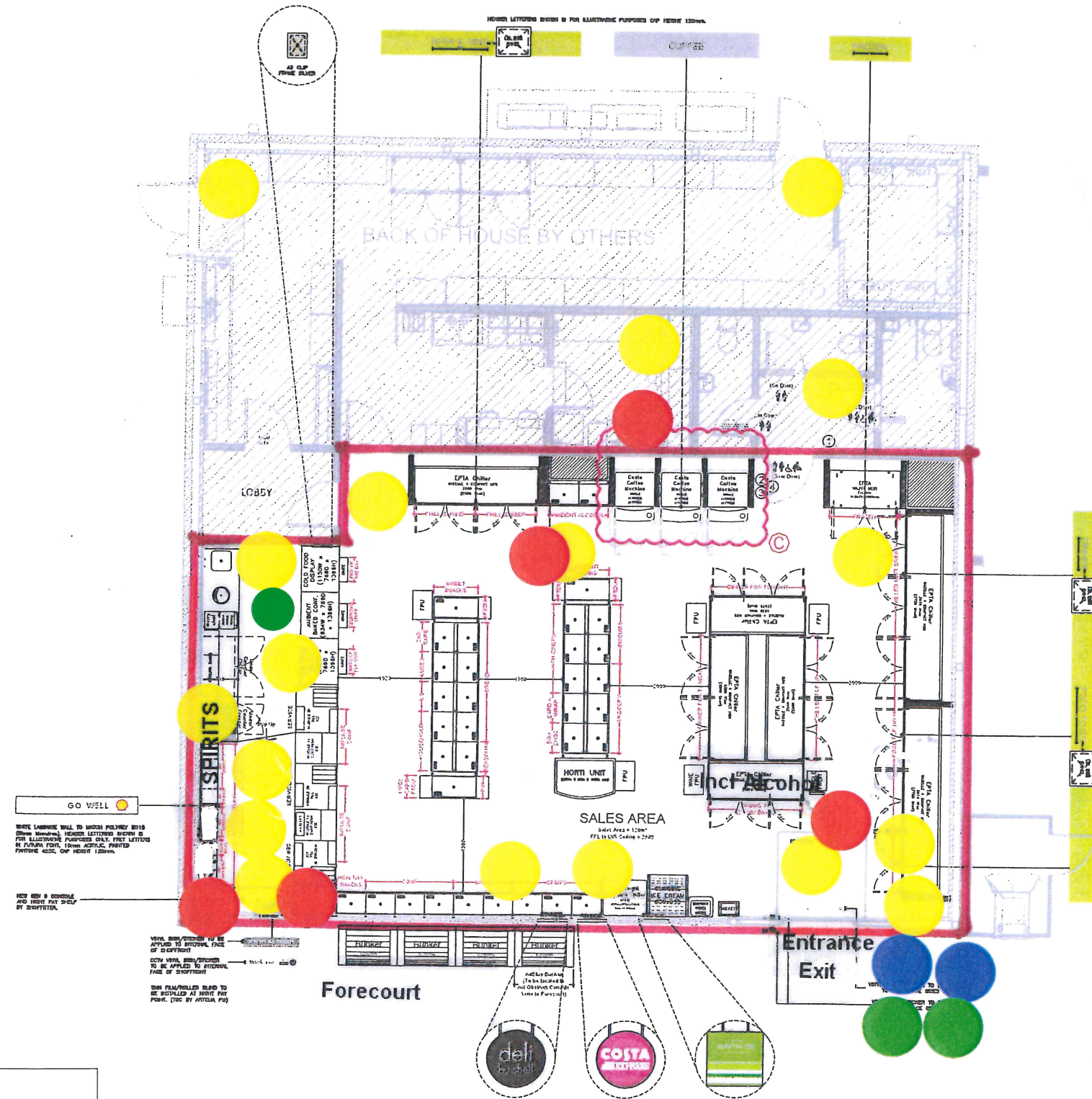

It has been brought to my attention the above application for a premises licence to sell alcohol at Shell Little Waitrose, Apex Corner , 24 hours per day, seven days per week.

I am a resident of Ellesmere Avenue and I am writing to raise my concerns should this application be approved by Barnet Council.

My key concerns are:

1. Anti-social behaviour – we have already witness increased drug dealing and anti-social behaviour on Ellesmere Avenue just behind the location of Shell Petrol Station as well as in the Apex Corner underpass – sale of alcohol will most certainly add to these issues
2. Drunken & disorderly behaviour - 24 hour sales of alcohol will no doubt increase alcohol related nuisance in and around the area
3. Increased litter around the area from shoppers, which is already affected by rat infestations from the nearby KFC restaurant
4. Increase traffic and therefore noise and pollution from passing trade, in an already very busy residential road. This will lead to potentially more road accidents

6. All the above will have an adverse effect on property values in the area
