We did put in a petition years ago, but because it was badly thought out in the Councils part, we had to reject it. It would have made the area worse off due to the parking restrictions in Orange Hill Road.
WATLING AVENUE	My neighbours all have 2 cars or more per household and all get home before me in the evening. Having a resident parking permit will not guarantee me a parking space. I see myself paying for the parking permit and still having the same problems with parking my car as I do now.
GOLDBEATERS GROVE	Goldbeaters Grove needs a parking permit scheme, it is ridiculous how many times me and my disabled neighbours or family members have had to walk several minutes as a result of commuters parking outside my house just to get home

HORSECROFT ROAD	On HA8 0PA, sometimes is very difficult to get out of property because other cars are being parked on wrong spots. Also, on Horsecroft Road we should limit the speed of cars, e.g., by road bumps, as there are some irresponsible motorists who speed up making an incredible noise. This happens 7 days a week, and we residents need to support all this noise, not to speak about pets and hedgehogs being killed on the street. We desperately need this issue to be sorted out.

A lot of travellers who travel abroad on holiday, come, and park their car for the holiday period and on return take their cars. We also have issues with mini cab drivers who leave their cars for months which are not being used. Out of about 14 car parking spots outside our houses, the residents only have 6 spots. Once we move our car in the morning, it would be about 10:30pm before we get a spot to park. We have been trying for the past 10 years to get some restrictions imposed. Our elderly neighbours cannot get their shopping in after shopping, as they have to park their car far away and have to park their car far away and get their shopping in, late at night, or go shopping late at night. It is ridiculous that something has not been done before about this.

TRUEMAN CLOSE	I have lived in Trueman Close, Pavilion Way since year 1990, before the building of Watling Park School in 2015, which is causing us Pavilion Way residents, massive traffic problems, in terms of dangerous and inconsiderate parking by school run parents, its attendant noise and pollution, during school drop off and pick times, between 7.30 am to 9 am, and 2.30 pm to 4 pm, daily Mondays to Fridays. The implementation of yellow lines, along Pavilion Way plus within its side streets here, with time restrictions, and signs denoting "NO PARKING ON PAVEMENTS" will make life much more pleasant for residents living here. People living in the various "Closes" of Pavilion Way, are designated their own PRIVATE parking spaces, which are written into their property deeds, and, as such cannot fall under any proposed CPZ parking controls of Barnet Council - it being nonsense to have to pay to park in your own private parking space! However, the main access road that is Pavilion Way - views should be solicited from residents living in houses/flats sited here, to ascertain their particular parking needs on CPZ, etc. These premises also have their own private parking spaces, usually located behind their properties. Parking Attendants of Barnet Council cannot be expected to come in regularly into Pavilion Way - what is needed is a CCTV camera to record traffic offences and give out fines.

BLESSBURY ROAD	Residents and visitors are most times unable to park. We have to park far away and wait for long. Parking control is needed so much. + we need parking boxes allocated to houses - as we have park in front of houses = no driveways. Thank You!
HORSECROFT ROAD	Watling Avenue school (we lived on Pavilion Way until Feb 2020) was meant to have a full parking and drop off system. The school was built despite strong opposition due to the traffic and dubious claim to the land. The fact that school seems to have not really implemented this system is very poor.
GRANGE ROAD	I support residential parking, but I think it needs to be for a longer time possibly 5.00 to 7.00pm as well as the problem with parking are not just due to commuters but because of business vehicles as well. While I do not always expect to be able to park outside my house, most evenings when returning from work I can't even get parked in the same street.
ABBOTS ROAD	If restrictions are introduced, they should not be all day only peak times.
BURNT OAK FIELDS	The pricing of the permits needs to be considered. The current proposed costs are too high. The revenue needs to be enough to fund the scheme, but no more. £71/96 is too high. There are many low-income households who will be against the CPZ based purely on financial grounds, even though they would otherwise support.

BARNFIELD ROAD	There appears to be increasing demand for both takeaway food and supermarket shopping home delivery ordering via the internet. Could we suggest that each residential road has a dedicated delivery parking spot with, say, a maximum 20-minute turn around to accommodate this ongoing and increasing commercial activity. This would obviate the inevitable flash parking that currently occurs. Maybe Barnet could be the first borough to develop this idea. Regarding loading and unloading to the shops between 116 and 156 Burnt Oak Broadway, vehicles block our local road, partly because the loading kerb markings are now virtually non-existent although the plates are still in situ and the double yellow lines have been recently renewed. More use could be made of double yellow lines (with cameras to monitor offenders) specifically on approaches to Burnt Oak Broadway. The northern stretch of Barnfield Road has double yellow lines at each end, but although Parking Enforcement do a really good job, both ends of the road are regularly abused by shoppers/Costa coffee pick-ups, obstructing drivers and trapping residents.

HORSECROFT ROAD	I have a front garden and I would like the prices for dropping the kerb reduced as I would like to park at my front garden, as I never get to park on my front house as my neighbour have multiple cars and one junk car parked on the road, so issues with bin put out is also an issue.
COLCHESTER ROAD	Control parking necessary all day and every day.
CRESSINGHAM ROAD	I strongly oppose this proposed method to deal with the issues identified. More than half of these are not solved by CPZ, rather they are issues concerning lack of policing, appropriate road sign displays and education. I would rather park a few houses down than pay out £71.25 per year. it is infuriating to think that residents and visitors are being squeezed of more of their hard-earned money from another direction. the elderly is already struggling having to pay £159 for tv licence, it's been reported. The temporary £20 uplift is gone. energy prices are going up and fuel prices are up to point out a few. I suggest the appropriate team come up with something more creative and less financially impactful for residents.
ABBOTS ROAD	I live 25 m from Menorah School on Abbots Road. I have complained about school traffic there and would support a time-related prohibition on parking on one side (not both) of that and nearby roads, to prevent school-related problems. But one of the attractive features of Abbots Road is that there simply is not otherwise, a parking problem. Even as it stands, family and friends have never failed to find roadside parking, day or night, evening or weekend, school, or term, in over 6 years here. Please, we would like not to lose that facility. I've lived elsewhere with CPZ's and it *does* impact on living there, sadly not always in a good way. The situation isn't bad enough for it, and there isn't likely to be a huge increase in population capacity or attractions, given the conservation areas status. But if there must be one, then please, afternoon rather than morning, and weekdays only.

BLESSBURY ROAD	I do not agree to have parking restrictions which residents and their visitors to pay a permit for. I am happy with calling enforcement as and when needed
LITTLEFIELD ROAD	If CPZ's are introduced we will have problems with speeding vehicles (Less parked vehicles) as our road is used as cut through, also visitors' residents who don't have permits will get caught out with extortionate parking fines for leaving their car on the road to unload shopping etc. I also notice that the cost of permits goes up for a second permit so I assume if you needed more it costs more, also the cost is based on average emissions vehicles so does not show costs if you are unfortunate not to be able to purchase a newer vehicle, so you will probably be hit with bigger and bigger bills as the council look to recoup funding lost etc, This goes for all vehicle users as well as inflation races away.
LITTLEFIELD ROAD	I would very much like to see CPZs on my street, but also reduced parking near junctions and greater monitoring as the situation on Littlefield is very difficult to deal with. In terms of CPZs, the problem where I with the schools and hospital nearby and lots of trades people and commuters mean that CPZ should be earlier than the school drop off ideally. The schools have also asked carers not to use Orange Hill or Pavilion, which has increased it on Littlefield. Also, the area has lots of HMOs and parties which make the weekends very difficult - and leads to not only cars blocking, but litter, including broken glass which many residents are forced to clear up ourselves.
