This report is to give the Overview and Scrutiny committee an overview of the work of the Safer Communities partnership (SCP) for the period 2022-2023 (inclusive of March 2023). The SCP brings together agencies and organisations involved in crime prevention and community safety within the borough of Barnet.

Summary

The work has involved the councils Community Safety Team and Family Services taking a lead on tackling the five priorities that were laid out within the Barnet Community Safety Strategy 2022-27.
