
This scheme is to turn the Cloister Road roundabout into a productive and attractive community-driven garden. The project will be led by The Roundabout Garden NW2 community group, a group of local residents living adjacent to the roundabout, who will plant and maintain the garden.

The roundabout lies at the end of Cloister Rd, a noticeably quiet road adjacent to the Granville Road Estate:



The proposal is to install 6 durable troughs on the roundabout, as per the diagram below. The garden will be designed to incorporate a variety of flowers, vegetables, fruit and herbs, creating a vibrant and diverse green space for the community to enjoy.

Professional consultation (as support in kind) from horticulturists, landscape architects and designers will be sought to ensure the garden's design aligns with the group's vision. A volunteer rota will be established for watering and garden maintenance, involving residents in the ongoing care of the space.

CIL Eligibility

Ms Fishman created The Roundabout Garden NW2 group which comprises of local residents and volunteers, who are keen to set up this community garden, using their wealth of expertise. Ms Fishman has gathered further support from local residents and has been invited to talk about this initiative at the next GERA (Granville Estate Residents Association) meeting, in the hope that the GERA group will be inspired to participate and/or create their own community garden across the road. The Granville Road Estate has suffered a huge loss of green space over the last few years due to the ongoing development. Greening the Cloister

Road roundabout is a small step toward making this area greener and more biodiverse.

Councillors Giulia Innocenti and Nigel Young and officers Graham Perrior and Lisa Bannister-Wood have met with Ms Fishman on site to discuss the proposal. Mr Perrior outlined the various constraints that the group would have to work within to meet Highways standards.

The transformation of the Cloister Road roundabout into a community garden will provide a range of benefits to the community, including increased access to fresh, locally grown produce, enhanced urban aesthetics, improved environmental sustainability, and opportunities for community engagement.

Community Engagement: This transformation of the roundabout seeks to foster a sense of community by encouraging active participation from residents. Community members will be invited to contribute ideas, volunteer their time for garden maintenance, and share in the harvest. We hope this will bring the road and local area together and foster new friendships. By engaging residents in the planning and maintenance of the garden the group hope to promote a sense of ownership and community cohesion. This community-driven initiative will not only beautify the neighbourhood but also fosters a sense of pride and connection among residents.

Sustainability: The garden will be designed to incorporate a variety of flowers, vegetables, fruit, and herbs, creating a vibrant and diverse green space for the community to enjoy. It can also serve as an educational space, providing learning opportunities for residents interested in gardening and inspire residents in other areas to take over unused land to create growing spaces. Emphasis will be placed on environmental sustainability by incorporating low-maintenance perennial edible plants.

Public Health: The transformed roundabout will serve as a visually appealing and welcoming space for both residents and passers-by. It aims to enhance the overall beauty of the neighbourhood and provide a place for appreciation of nature and biodiversity. This will no doubt have a positive impact on people's wellbeing and mental health. Access to fresh edible produce will also benefit local residents.

Who will deliver the scheme

The Roundabout Garden NW2 community group will be delivering and maintaining this scheme, led by Poppy Fishman. Ms Fishman is Environmental Project Coordinator at Stonegrove and has a lot of experience as a community gardener, specialising in food growing education, horticultural therapy and community engagement.

Dependencies/Risks	Financial: I deem this to be a fairly low risk scheme, hence a relatively low contingency at 5%. Once the initial infrastructure costs are invested and the garden is set up there will be no large ongoing costs with this project. If further funds are needed in future the group will apply for small grant funds or fundraise within the community.
	Road Safety: We have had initial meetings and conversations with the Highways team to discuss road safety and the location of the planters to the road. The group have agreed to keep 1m around the path and 1m around the lamp for access to utilities.
	 High vis jackets will be worn when the group is working on the roundabout and there will be a minimum of 3 signs placed on the various approaches to the roundabout to inform traffic that there are people working there. Visibility – the group will make sure that planting will not be too high, so that visibility for drivers will not be affected. Watering will be done by hand. Volunteers – only adult volunteers will be working on the roundabout in this first stage of installation and planting.
	The group will be guided by officers with regards to any further health & safety considerations.
	Public consultation: residents in the immediate vicinity have been informed of this project by Ms Fishman, some of them have come on board as volunteers.

VALUE FOR MONEY

- This scheme will not impose any additional costs on the Council the planters will be maintained by a group of local residents and volunteers, led by Poppy Fishman. They are all keen gardeners and between them have a vast knowledge of growing and maintaining plants, so they will not need to spend money on a supplier to design or plant the troughs. They also have a volunteer landscape designer on board to further ensure that the planters are positioned and planted to a high standard.
- Ms Fishman lives next to the roundabout and she will be able to water the garden from her own house.
- If further funds are needed for extra planting or maintenance, the group will fundraise to cover these costs, either through small grants or through the local community.
- The group are keen to engage local residents in this project and to create a network of volunteers who will contribute to the planting, maintenance and harvesting of the roundabout garden. Creating a larger support network will ensure the scheme's longevity.

No ongoing revenue costs

There will be no ongoing additional revenue costs associated with the scheme.

COMMUNITY BENEFITS

This resident-led community garden holds the potential for a wide range of community benefits. Beyond the immediate participants, the garden becomes a shared space that positively impacts the entire neighbourhood.

Community cohesion and wellbeing: During the gardening sessions it provides a gathering point for residents, fostering social interactions, community bonding, and a sense of belonging. The cultivation and sharing of fresh produce contribute to improved local food access, promoting healthier lifestyles and well-being for residents.

Environment: The transformation of this grey, tarmac roundabout into an attractive area full of plant and insects will be a focal point, attracting attention and positively shaping the overall perception of the area. Residents take pride in contributing to the development of a more attractive and vibrant community space, fostering a sense of ownership and commitment to the neighbourhood's improvement.

Biodiversity: By greening this roundabout with a variety of different perennials, there will be an increase in biodiversity which will benefit the ecology of the area, creating another green pocket which can connect to the Childs Hill allotments and neighbouring parks and green spaces.

Children/ Education: The roundabout is on a busy walking route for school children, every morning and afternoon there are families walking past from the Granville Estate to the local primary schools (St Agnes and Childs Hill primary). In addition, with the new development on Granville Road, there will be many more people in the area and we hope this growing space will welcome people to come have a look, get stuck in and be inspired by what can be grown in a small urban space.

SCHEME SUMMARY		

This scheme will help to transform the verge and green spaces alongside the busy Claremont Road. It will complement work that the Greenspaces team have already planned for Brent Terrace, and work that has already been completed to plant bulbs in other sections of Claremont Road and The Vale.

Residents have long complained about the untidiness of Claremont Road verges and small green spaces. Cllrs Clarke and Schneiderman have visited this site with officers from Highways, Greenspaces and the Brent Cross Team as some of the land is adjacent to the regeneration. It is in very poor condition. The scheme seeks to plant over areas of high weed density where litter and flytipping collects. The weeds become overgrown and narrow the footpath annually, it is simply an unattractive stretch of road and this application seeks to improve it.

We have met with residents groups and the Millennium Green Trust who all agree it needs improvement.

CIL Eligibility	The entire length of Claremont Road has been impacted by development, regeneration and lots of building. Heavy vehicles from the local waste site along with the neighbouring regeneration mean the area is often very messy. The verges fill with weeds and litter. The
	area has long been neglected and this will directly improve the look and feel of the area, along with improving biodiversity.


